### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Salpointe Catholic High School Cash or Deferred Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Salpointe Catholic High School Cash or Deferred Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

**Note 1 – Description of Plan**

The following description of the Salpointe Catholic High School Cash or Deferred Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions.

The Plan is a defined contribution plan which was formed on January 1, 1985 and amended and restated effective October 27, 1994 to encourage and assist employees of Salpointe Catholic High School (the “School”) in regularly saving for their retirement through payroll deductions and discretionary contributions made by the School. In 2002, the Plan was further amended to comply with the requirements of the Economic Growth and Tax Relief Reconciliation Act. The Plan has been further amended in 2005, 2006, and in 2008 for changes effective January 1, 2009 related to the use of forfeitures and earlier participant eligibility. In 2016, the Plan was further amended for qualification requirement changes issued by the Internal Revenue Service effective January 1, 2016. In 2021, the Plan was further amended for Roth contributions and Roth rollover contributions, effective January 1, 2022. The Board of Trustees determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

**A. Eligibility**

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees of the School who have attained the age 21 and who have completed at least 550 hours of service within the first five consecutive months of employment are eligible to participate for purposes of salary deferrals. Employees of the School who have attained the age of 21 and who have completed one year of service, defined as a minimum of 1,000 hours service, are eligible to participate for purposes of employer profit sharing contributions. Employees can become a member as of the first entry date (January 1 or July 1) following completion of the eligibility requirements. Union employees and non-resident aliens are not eligible to participate in the Plan.

**B. Contributions**

Participants may contribute through payroll deductions a percentage or flat amount, up to 90 percent of their annual wages to the Plan, which are contributed on a pre-income tax basis subject to annual limitations established by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The School, at its discretion, may make profit-sharing contributions to the employee accounts. During the current year, the School made a discretionary profit-sharing contribution of seven percent of gross wages.

**C. Investment Options**

The Plan provides for participant-directed investment elections among different types of common collective trusts and mutual funds, and allows participants to change their investment elections on any business day as often as desired.

**D. Participant Accounts**

Each participant's account is credited with the participant contribution, an allocation of Plan earnings, and any applicable discretionary profit-sharing contribution made by the School. Allocations are based on account balances as defined. The benefits to which an employee is entitled are the benefits that can be provided from the participant's vested account balance.

**E. Vesting**

Employees are immediately vested in their voluntary contributions plus their contributions' earnings. Vesting in the remainder of the account is based on years of service. An employee is vested in employer discretionary profit-sharing contributions at the rate of 20 percent after two years, 40 percent after three years, 60 percent after four years, 80 percent after five years and is fully vested after six years of service. Upon retirement, disability or death, an employee is 100 percent vested for the entire account balance.

**F. Payment of Benefits**

Upon termination of service, an employee may elect to receive a roll-over distribution or lump-sum amount equal to the value of the participant's account. If the account is valued at less than \$5,000, the participant will automatically receive a lump-sum payment. The Plan also provides for hardship withdrawal during employment. A hardship withdrawal may only come from an employee's voluntary contributions and may not be for an amount greater than which is necessary to satisfy the immediate financial need, and an employee may not make contributions to the Plan for six months following the date of the withdrawal.

**G. Notes Receivable from Participants**

The Plan is permitted to make loans to employees to satisfy certain financial needs as defined. Each loan may not exceed the lesser of \$50,000 or 50 percent of the employee's vested account balance at the date the loan is granted. Loans have a maturity of not more than five years, unless the loan was made for the purpose of acquiring a principal residence, and includes a reasonable rate of interest, comparable to similar commercial loans, conducted at an arms-length. Principal and interest is paid ratably through pay period payroll deductions.

**H. Administrative Expenses**

Certain administrative expenses of the Plan are paid to the Plan Administrator and Plan Custodian from Plan assets. Certain other administrative services for the Plan are provided by the School at no charge.

**I. Plan Termination**

Although it has not expressed an intention to do so, the School has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, employees become 100 percent vested in their accounts.

**Note 2 – Summary of Significant Accounting Policies**

The significant accounting policies followed by the Plan are as follows.

**A. Basis of Accounting**

The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. Accordingly, additions are recognized when earned and deductions are recorded when incurred. Further, contributions are considered earned in the period withheld.

**B. Use of Estimates**

Management uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported additions and deductions. Actual results could differ from those estimates.

**C. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

**D. Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are recorded at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**E. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are recorded as distribution based upon the terms of the plan document.

Subsequent to year end, several employees received participant loans from their respective accounts, which totaled \$82,003.

**F. Payment of Benefits**

Benefit payments are recorded when paid.

**G. Forfeitures**

Forfeitures are the non-vested portion of participant account balances for terminated participants. These funds, which have been retained in the Plan, are available to pay Plan expenses and to reduce the discretionary profit sharing contribution of the School. The balances of the forfeited account were \$22,449 and \$33,950 as of December 31, 2024 and 2023, respectively.

**H. Income Tax Status**

The Plan obtained its latest determination letter on May 11, 2009, in which the Internal Revenue Service determined that the Plan and related Trust, as then designed, was in accordance with the applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan's administrator and the Plan's tax counsel believe that the Plan is currently designed and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

**Note 2 – Summary of Significant Accounting Policies**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions by the plan and recognize a tax liability if the plan has taken an uncertain position that more than likely would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress.

**I. Date of Management’s Review**

Subsequent events have been evaluated through October 6, 2025 which is the date the financial statements were available to be issued.

**Note 3 – Fair Value Measurements**

ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

**Note 3 – Fair Value Measurements**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level or any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Fair values of assets for mutual funds measured on a recurring basis at December 31, 2024 and 2023 were \$16,847,900 and \$15,310,395, respectively. The mutual funds were measured at Level 1 of the fair value hierarchy.

**Note 4 – Group Annuity Contracts**

The Plan has entered into traditional fully benefit-responsive guaranteed investment contracts reported as group annuity contracts on the financial statements. Total group annuity contracts account balances at December 31, 2024 and 2023 were \$754,892 and \$1,167,376, respectively. The Reliance Trust Company Stable Value Fund Collective Investment Trust was formed for employee benefit plans to invest in group annuity contracts issued by Metropolitan Life Insurance Company (MetLife). The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 4 – Group Annuity Contracts**

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by MetLife, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

**Note 5 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 6 – Unaudited Information Prepared and Certified by the Custodian**

**Note 7 – Market Risk**

The Plan investments included mutual funds, which invest in various investment securities and in various companies within various markets. The mutual funds investments are recorded at fair value in accordance with the reporting requirements governing the Plan. Net changes in asset value is reflected as net appreciation (depreciation) in fair value of investments which includes realized income or loss as well. All such investments are subject to various market and economic risk factors as well as the national and global economies. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8 – Party-In-Interest Transactions**

Plan investments are managed by Reliance Trust Company, the trustee/custodian of the Plan. Investment advisor services are provided by Wellspring Financial Partners. Certain administrative functions are performed by employees of Salpointe Catholic High School. Other recordkeeping and administrative functions are also performed by Reliance Trust Company and ADP Retirement Services. Reliance Trust Company, Wellspring Financial Partners, ADP Retirement Services, and Salpointe Catholic High School are considered parties-in-interest for which statutory exemptions exist. No administrator, officer or employee of Salpointe Catholic High School receives compensation from the Plan. Fees incurred by the Plan for the investment management services provided by Reliance Trust Company are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Such indirect payments amounted to \$3,790.
