INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the CAL-AM Properties, Inc. 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the CAL-AM Properties, Inc. 401(k) Profit Sharing Plan & Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the CAL-AM Properties, Inc. 401(k) Profit Sharing Plan & Trust, and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the CAL-AM Properties, Inc. 401(k) Profit Sharing Plan & Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

1. DESCRIPTION OF PLAN

CAL-AM Properties, Inc. 401(k) Profit Sharing Plan & Trust (the Plan) is a defined contribution plan to which CAL-AM Properties, Inc. (the Company) contributes such amounts annually as determined by the Board of Directors. The Plan also provides for voluntary contributions by employees. The Plan was amended effective March 1, 2023. The amendment added an auto-contribution for new employees that did not opt out of the Plan. Participants should refer to the Plan agreement for more complete information.

Major provisions of the Plan are as follows:

Eligibility and Participation

All employees age 21 and over are eligible to participate in the Plan. The entry date is the first day of the month following the date eligibility requirements are satisfied.

Exclusions include:

- Union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining, unless the collective bargaining agreement requires the employee to be included within the Plan.
- Certain nonresident aliens who have no earned income from sources within the United States.
- Temporary and Seasonal Employees. A temporary or seasonal employee is an employee whose regularly scheduled service is less than 1,000 hours of service in the relevant eligibility computation period.

Contributions

The Plan allows for pre-tax elective deferrals and 401(k) Roth elective deferrals. Employee salary deferrals cannot exceed a maximum dollar amount determined by the federal government each year.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of Plan earnings or losses. Earnings or losses are allocated on the basis of the ratio each account balance bears to the total account balances of all participants in the same investment. The benefit, to which a participant is entitled, is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon.

1. DESCRIPTION OF PLAN (Continued)

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions to any of the investment options through Reliance Trust Company, the trustee of the Plan.

If participants choose not to select an investment option, the administrator will select investment options through the trustee of the Plan.

Participant Loan

Per current Plan provisions, new participant loans are not permitted. Prior to this adoption, the Plan had a provision and loan policy in effect permitting participants to borrow funds from their vested accounts. Per generally accepted accounting principles, for any default loan treated as a distribution, the Plan will continue to hold and treat the deemed distributed loan as a participant loan receivable until the participant takes a distribution from the Plan at which time the loan receivable will be offset against the distribution. The note receivable is measured at its unpaid principal balance, plus any accrued interest.

Payment of Benefits

Participants may withdraw all or a portion of the vested interest in their account upon retirement, termination of employment, or financial hardship.

Administrative Costs

Administrative costs of the Plan are generally paid from participant accounts, unless the employer elects to pay.

Forfeitures

Forfeitures will be used to reduce future employer contributions.

Forfeitures which were directly attributable to employer contributions will be used to first pay administrative expenses and then to reduce future employer contributions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are valued at quoted market prices which represent the fair value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, which was the date the financial statements were available to be issued. Management determined no other material events have occurred subsequent to December 31, 2024 that would require disclosure or recognition in the accompanying financial statements.

3. TAX STATUS

The Internal Revenue Service has determined and informed the Plan by a letter dated October 6, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and continues to operate in compliance with the applicable requirements of the IRC.

5. FAIR VALUE ACCOUNTING

With respect to its financial and non-financial assets and liabilities, the Plan adopted a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 quoted prices in markets that are not active, or inputs that are observable, either directly or indirectly for substantially the full-term of the asset or liability;
- Level 3 prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable (supported by little or no market activity).
