## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Wellness Pet Company Employee 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **1. Description of the Plan**

The following description of The Wellness Pet Company Employee 401(k) Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a participant-directed defined contribution 401(k) plan covering substantially all employees of Wellness Pet Company (the Employer or Company) who are at least 21 years of age and, effective January 1, 2024, have completed one month of service. Employees can enter the Plan upon satisfaction of the eligibility requirements. Prior to January 1, 2024, eligible employees were able to enter the Plan on the first day of the month following reaching 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective June 26, 2024, the Company sold its Mishawaka, Indiana plant, which resulted in a reduced workforce. As a result, the Plan experienced a partial Plan termination for the 2024 Plan year, as defined by the Internal Revenue Code (IRC) (Note 9).

The Employer is also the administrator of the Plan (Plan Administrator). As Plan Administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Fidelity Management Trust Company (Fidelity) is the appointed trustee of the Plan and acts at the direction of the Plan Administrator.

***Contributions***

Participants may elect to contribute any percentage of their eligible compensation, not to exceed annual limitations as provided by the IRC. Participants may also elect to make Roth contributions. The Plan provides for automatic enrollment, whereby eligible employees are automatically enrolled to defer 6% (increased from 5% effective January 1, 2024) of eligible earnings in the Plan, unless the employee opts out of this arrangement. Participants who have attained age 50 before the end of the Plan year and who are making deferral contributions may also make a catch-up contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (participant rollovers).

Effective January 1, 2024, the Plan was amended and restated to a Qualified Automatic Enrollment Arrangement (QACA) with 401(k) Safe Harbor Matching Contributions Plan. The Employer makes QACA safe harbor matching contributions which consist of 100% of the first 1% of eligible participant contributions and 50% of the next 5% of eligible participant contributions.

Prior to January 1, 2024, the Employer had the option under the terms of the Plan of making discretionary matching contributions. The discretionary matching contributions were computed based on eligible compensation contributed to the Plan.

The Employer also has the option under the terms of the Plan of making discretionary non-elective contributions for participants who have completed 1,000 hours of service during the year and are employed on the last day of the year. The discretionary non-elective contributions will be allocated using a calculation based on individual Plan participants' compensation in proportion to total compensation paid to all eligible Plan participants. The Company did not make an additional discretionary non-elective contribution to the Plan in 2024 or 2023.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, allocations of the Employer's contribution, and Plan earnings and losses. The allocation of earnings and losses is performed based on individual participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions (including rollover contributions) plus the annual allocation of Plan earnings on those contributions, at the time of allocation. Participants become fully vested in the Employer discretionary matching and discretionary non-elective contributions plus the annual allocation of Plan earnings on those contributions in 25% increments over a 4-year period. Employees hired on or after January 1, 2024 become fully vested in QACA safe harbor matching contributions after 2 years of service. Employees hired before January 1, 2024, with QACA safe harbor matching contributions are immediately vested in those contributions. In the event of retirement, disability or death, participants immediately become 100% vested in their account.

***Participant Notes Receivable***

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 (reduced by the highest outstanding loan balance during the prior 12-month period) or 50% of their vested account balance. No more than one note per participant may be outstanding at any time. Note terms range from 1 to 5 years, or up to 10 years for the purchase of a primary residence. The notes are secured by the vested balance in the participant's account and bear interest equal to the prime rate. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

Upon death, disability, retirement or termination of service, a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the vested balance of his or her account. Alternatively, the participant may elect to defer the distribution. If a participant terminates employment for any reason and their vested account balance does not exceed \$1,000, the Plan Administrator may distribute such amount as a lump-sum payment. If a participant's vested balance exceeds \$1,000 and is equal to or less than \$7,000 (increased from \$5,000, effective January 1, 2024), the amount will be rolled over to an individual retirement plan designated by the trustee, unless otherwise directed by the participant.

***Early Withdrawals***

Participants, by written notice to the Plan Administrator, may request a financial hardship withdrawal from their vested account subject to the provisions of the IRC. Participants who have attained age 59½ may elect to withdraw all or a portion of their vested account while still employed.

***Forfeitures***

Participants in the Plan who terminate employment with the Employer before completing four years of service forfeit the non-vested portion of their accounts. Forfeitures may first be used to pay administrative expenses and any remaining amounts will be used to reduce Employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$86,905 and \$82,310, respectively. During the year ended December 31, 2024, forfeitures of \$120,387 were used to reduce Employer contributions.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Valuation of Investments and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan Administrator and investment advisor determine the Plan's valuation policies utilizing information provided by the trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Participant Notes Receivable***

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent participant notes receivable are reclassified as distributions based on terms of the Plan document.

***Contributions***

Participant deferrals and Employer discretionary matching contributions are recorded weekly or bi-weekly, coinciding with the dates employees are compensated, when the Employer remits the payroll deductions for investment into the Plan. Employer discretionary contributions are made at the end of the year, if applicable.

***Payment of Benefits***

Benefits are recognized when paid to participants or their designated beneficiaries.

***Administrative Expenses***

Administrative expenses of the Plan are paid by the Employer, unless the Employer directs that the expenses be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

***Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

***Financial Instruments with a Concentration of Credit Risk***

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside trustee's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

Plan investments in two mutual funds accounted for approximately 29% of total Plan investments as of December 31, 2024. Plan investments in three mutual funds accounted for approximately 35% of total Plan investments as of December 31, 2023.

***Subsequent Events***

Effective January 1, 2025, the Plan adopted a provision of the Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0, which increased the catch-up contribution limit for participants between the ages of 60 and 63 to the greater of \$10,000 or 150% of the regular catch-up contribution. Additional SECURE Act 2.0 provisions may also apply based on plan design and future regulatory guidance.

Management has evaluated subsequent events through October 14, 2025, which is the date these financial statements were available to be issued.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Money Market Fund:* The carrying amount of the money market fund is the deposit amount plus accrued interest, as determined according to stated terms.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As of December 31, 2024 and 2023, the Plan's investments in the money market fund and mutual funds are reported at level 1 within the fair value hierarchy.

#### **4. Plan Termination**

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

**5. Income Tax Status**

The Plan has adopted a Fidelity Pre-Approved Plan. Fidelity has obtained an advisory letter on the Plan dated June 30, 2020 stating that the form of the Plan is acceptable under Section 401 of the IRC. Generally, the Plan Administrator and the Plan may rely on the advisory letter received by Fidelity as to the form of the Plan qualifying under the IRC. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Summary of Financial Data Certified by the Trustee**

The following is a summary of financial information and data certified by the trustee, Fidelity:

Statements of Net Assets Available for Plan Benefits at December 31, 2024 and 2023, except for contributions receivable, if any;

Investment income and interest income from participant notes receivable on the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024; and

Investment information provided on the supplemental schedule, Schedule of Assets (Held at End of Year) at December 31, 2024.

**7. Differences from Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

**8. Related Party Transactions and Party-in-Interest Transactions**

Plan investments are held and managed by Fidelity, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan made aggregate payments of \$52,651 to its trustee and independent investment advisor during 2024. Participant notes receivable also qualify as party-in-interest transactions.

**9. Partial Plan Termination**

Effective June 26, 2024, the Company sold its Mishawaka, Indiana plant, which resulted in a reduced workforce. As a result, the Plan experienced a partial Plan termination for the 2024 Plan year, as defined by the IRC. Under the IRC, a partial plan termination may occur if at least 20% of eligible Plan participants are terminated by the Company within the applicable period. If a partial plan termination occurs, full vesting in the Employer's contribution is required for the affected participants, but the remaining participants' vesting continues to be determined per the Plan provisions. In accordance with IRC guidance, participants of the Plan whose employment terminated as a result of selling this plant during 2024 became fully vested in all contributions under the Plan.
