NOTE A - DESCRIPTION OF PLAN

The following description of Get Fresh Sales, Inc. 401(k) Retirement Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1998. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) covering substantially all employees of Get Fresh Sales, Inc., Fresh Cut LLC, and Get Fresh Kitchen, LLC (collectively referred to as the Company) who have completed three months of service, are age 21 or older, and are not nonresident aliens or residents of Puerto Rico. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute on a pre-tax basis or post-tax (Roth) basis to the Plan from 1% of compensation up to 90% of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Participant contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Company may, at its discretion, make fixed matching contributions and nonelective contributions to the Plan. For the years ended December 31, 2024 and 2023, the Company made fixed matching contributions to the Plan equal to 25% of participants' elective deferrals up to 4% of compensation each pay period. The Company did not make any nonelective contributions to the Plan for the years ended December 31, 2024 and 2023. Participants direct the investment of their employer contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary fixed matching contributions, an allocation of Company discretionary nonelective contributions, if any, and Plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest equal to the prime rate plus 2%. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants vest immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary fixed matching contributions and discretionary nonelective contributions, if any, is based on years of service as defined in the Plan document as follows:

If a participant dies or is disabled prior to attaining normal retirement age, the participant becomes 100% vested.

Payment of Benefits

Participants, or their beneficiaries, may receive the vested interest of their Plan account through a distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Hardship withdrawals are permitted by the Plan. In-service distributions may be made to a participant who has not separated from service provided the participant has attained age 59 ½. Benefit payments are made in the form of lump sum distributions, partial withdrawals of a minimum of \$500, or equal installments. Participants who terminate employment with a balance of less than \$1,000 may receive an automatic lump sum distribution of their balance. Effective January 1, 2024, participants who terminate employment with a balance of less than \$7,000, but more than \$1,000, may receive an automatic direct rollover of their account balance into an individual retirement account. Effective through December 31, 2023, participants who terminated employment with a balance of less than \$5,000, but more than \$1,000, may have received an automatic direct rollover of their account balance into an individual retirement account.

Forfeited Accounts

Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated employees or adjustments, if any. Forfeitures may be used to pay Plan expenses or to reduce Company contributions. The forfeiture balance as of December 31, 2024 and 2023 was \$2,128 and \$1,381, respectively. Forfeitures of \$7,257 and \$2,200 were used to reduce Company contributions during the years ended December 31, 2024 and 2023, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan is classified as deemed distributed. The notes receivable from participants in the statements of net assets available for benefits include the deemed distributed loan balances. For Form 5500 reporting, the participant loan balance is reduced, and a benefit payment is recorded, which results in a reconciling item between the financial statements and Form 5500.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to participant contributions.

Contributions

Contributions from Plan participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees for recordkeeping, third party administration, and investment advisory are included in administrative expenses and are allocated to participant accounts based on a pro rata formula. Fees related to the administration of benefit payments and participant loans are charged directly to the participant's account and are included in administrative expenses.

NOTE D - FAIR VALUE MEASUREMENTS

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a

specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust fund: The MetLife Stable Value Fund is a collective investment trust fund. The fund is invested in the MetLife Group Annuity Contract No. 25554 issued by Metropolitan Life Insurance Company, which is comprised of separate accounts. The Plan’s investment in the fund is valued at the NAV of the units held by the Plan at year-end. The value of the units is computed by dividing the total contract value of the assets of the fund, less its liabilities, by the total number of units outstanding. The fund is not registered with the SEC. There are no unfunded commitments. The redemption notice period is 60 days and redemption frequency is daily. The trustee may at any time, in its sole discretion, withhold payment on any distribution or withdrawal to be made from the trust fund for up to 12 months to meet liquidity demands on the trust fund. The Plan will receive the lesser of book value or market value if it chooses to terminate the fund as an investment option.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE F – TAX STATUS

The Plan adopted a non-standardized pre-approved profit sharing plan which obtained its latest opinion letter on October 6, 2020, in which the IRS stated that the Plan is designed in accordance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the letter, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ADP Retirement Services, an affiliate of ADP, Inc., is the third-party administrator and recordkeeper for the Plan. Fees paid to ADP, Inc. have been included in administrative expenses. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Effective January 27, 2024, LPL Financial became the investment advisor of the Plan. Fees paid to LPL Financial have been included in administrative expenses. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Prior to January 27, 2024, Centaurus Financial, Inc was the investment advisor of the Plan. Fees paid to Centaurus Financial, Inc have been included in administrative expenses. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Notes receivable from participants and related interest income are considered party-in-interest transactions, which are exempt from the prohibited transaction rules.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I – PLAN CORRECTIONS DUE TO OPERATIONAL FAILURES

During the 2023 Plan audit, operational failures were discovered due to the improper treatment of bonus compensation and the failure to process contributions on final paychecks. A corrective contribution was quantified by the Company to correct the operational failures in accordance with IRS regulations. The corrective contribution, which includes the qualified nonelective contributions (QNEC) and the employer match owed to impacted Plan participants, totaled \$69,988 and \$73,693 as of December 31, 2024 and 2023, respectively. A portion of the corrective contribution owed as of December 31, 2023, which is reported as other employer contributions receivable, was funded during the year ended December 31, 2024. Lost earnings will be calculated and remitted upon the funding of the balance in 2025.
