### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

### Note 1: Plan Description

The following description of North American Hoganas Union 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of North American Hoganas Company and N.A. Hoganas High Alloys, LLC (the “Companies”) who are members of the United Steelworkers of America, Local 2635-14 and Local 2632-22. In order to participate in the plan, an individual must be at least age eighteen and meet employment length requirements per the union agreements with plan participation beginning on the first day of the month following completion of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is not covered by the Pension Benefit Guaranty Corporation. Effective May 5, 2011, the Plan was amended to exclude from the definition of compensation, and therefore from the calculation of all contribution amounts, any amounts received from the Swedish Profit sharing bonus program.

#### Plan Administration

Reliance Trust Company serves as the Plan’s trustee. During the years ended December 31, 2024 and 2023, ADP Retirement Services was the record keeper of the Plan.

#### Participant Contributions

Participants are permitted to make contributions to the Plan on a pre-tax basis and/or an after-tax basis (as a Roth 401(k) deduction) through payroll deductions a percentage of their compensation up to a maximum of \$23,500 and \$23,000 for the years ended December 31, 2024 and 2023, respectively, with an additional \$7,500 and \$7,500 catch-up contribution available in the years ended December 31, 2024 and 2023, respectively, for individuals who are age 50 or older. In addition, the plan allows for a super catch-up contribution of up to an additional \$11,250 available in the year ended December 31, 2024, for individuals who are between the ages of 60 and 63. Participants are permitted to amend their salary savings agreements to change the contribution percentage on a daily basis. Participant pre-tax salary deferrals are exempt from federal income tax until withdrawn from the Plan.

#### Note 1: Plan Description (continued)

##### **Employer Contributions**

The Companies do not make matching contributions to the Plan; however, the Companies may decide to make a non-elective contribution to the plan, although they are not required to do so. Any employee not making elective deferrals are still eligible to receive the employer non-elective contribution. For these employees, the non-elective contribution is not considered to be self-directed and is allocated entirely to a target dated JP Morgan Smart Retirement Fund. For participants, the non-elective contribution is allocated based on individual participant-directed investment allocation.

Non-elective contribution of \$463,864 were made by the Companies for the year ended December 31, 2024.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the employer non-elective contributions, and an allocation of the plan earnings based on the participant's investment elections and charged with certain administrative expenses and any withdrawals and allocations of the Plan's losses based on the participant's investment elections. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are immediately vested in their voluntary contributions including rollover and transfer contributions from other qualified plans plus actual earnings thereon. Vesting in the employer's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is fully vested after three years of credited service.

##### **Investment Options**

Participants may direct the investment of all contributions into various investment options offered by the Plan. The Plan allows participants to direct their contributions and account balances among various investment options offered by Reliance Trust Company, the trustee of the Plan. Participants may change their investment options any time throughout the year via internet access.

#### Note 1: Plan Description (continued)

##### **Participant Loans**

The Plan also includes participant notes. Participants may borrow from their fund accounts a minimum of \$500 up to a maximum of \$50,000 or 50 percent of their account balance, whichever is less. The \$50,000 noted above is reduced by the highest outstanding loan balance under the Plan for the previous twelve-month period. Loan terms range from 1-5 years, unless the loan is used for the purchase of a primary residence, in which the repayment period may be a maximum of thirty years. The loans are secured by the balance in the participant's account and bear interest at prime rate plus one percent (1%). The prime rate is determined based upon the prime rate of interest that is published in the Wall Street Journal on the 14<sup>th</sup> day of each month. Principal and interest are paid ratably through semi-monthly payroll deductions.

##### **Payment of Benefits**

Upon retirement, a participant may elect to receive a lump-sum equal to the value of the participant's account, installments over a period of not more than the participant's assumed life expectancy or partial withdrawals. However, the participant must begin receiving payments by April 1 of the calendar year following the later of the calendar year in which the participant reaches age 72 (70 ½ if the participant reached the age of 70 ½ before January 1, 2023) or terminates with the Company. On termination of service due to death, disability, or for other reasons, a participant or beneficiary may receive the value of his or her account as a lump sum distribution. The Plan also provides for normal retirement benefits to be paid if an account balance is greater than \$5,000.

##### **Withdrawals**

Participants are entitled to withdraw all or any portion of their vested accounts in accordance with the terms of the Plan and applicable law. Participants may make full or partial withdrawals of their salary deferral or rollover accounts upon attaining age 59 ½ or for a hardship in certain circumstances (as defined in the Plan Document) before that age, with a minimum withdrawal of \$500. Withdrawals based on financial hardship results in a suspension of employee contributions for 6 months.

##### **Forfeitures**

If a participant terminates employment before becoming 100% vested in their account balance, the non-vested portion of the participant account balance will be forfeited after a three-year period of severance. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$39 and \$34, respectively. The forfeitures will be used to reduce employer contributions. For the years ended December 31, 2024 and 2023, \$0 and \$1,209 of forfeitures were used to offset employer contributions, respectively.

##### Administrative Expenses

Certain administrative functions are performed by officers and employees of the Companies. No such officer or employee receives compensation from the Plan. Certain other administrative expenses including legal, auditing and other fees are paid directly by the Companies and are not considered to be expenses of the Plan. During the year ended December 31, 2024, all administrative expenses recorded by the Plan were advisor fees, record keeper fees, loan origination fees and associated expenses charged to applicable participant accounts. There were \$24,195 of administrative expenses paid from the Plan's assets for the year ended December 31, 2024.

#### Note 2: Significant Accounting Policies

##### Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

##### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures. Actual results may differ from those estimates.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon terms of the plan document.

If a participant ceases to make scheduled repayments and the Plan administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced and a benefit payment recorded. For the year ended December 31, 2023, loan balances in the amount of \$32,679 were classified to be in default. Because no benefit payment was made as of year end, the total amount was included in the notes receivable from participants' balance reported on the Statements of Net Assets Available for Benefits. Benefit payments occurred during the year ended December 31, 2024; therefore, the loans were properly removed from notes receivable from participants. For the year ended December 31, 2024, there was a loan balance in the amount of \$34,821 identified to be in default.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the plan year.

Shares of registered investment companies (mutual funds) are reported at fair value based on the quoted market prices of the funds which represents the net asset value of shares held by the Plan at year-end. Units of common collective trust funds are reported at the net asset value of units held by the Plan at year end, as determined by the Trustee. The net asset value of units in the common collective trusts is determined by the Trustee based on the fair market value of the underlying assets.

##### **Net Appreciation (Depreciation) in Fair Value of Investments**

Net realized and unrealized appreciation (depreciation) is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedules related to the following assets as of December 31, 2024 and 2023:

### Note 4: Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 – Quoted prices (unadjusted) in active markets that are accessible at the measurement date for assets or liabilities.
- Level 2 – Observable market-based inputs other than quoted prices in active markets for identical assets or liabilities.
- Level 3 – Unobservable inputs that are used when little or no market data is available. These inputs reflect management's best estimate of fair value using its own assumptions about the assumptions a market participant would use in pricing the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds* – the Plan’s investments in mutual funds are classified in Level 1 of the valuation hierarchy with the fair value determined by quoted market prices, which represent the net asset value of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5: Income Tax Status**

The Plan received a determination letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the Plan is qualified under Section 401 of the Internal Revenue Code and therefore the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the acceptable requirements of the Code and therefore believes the Plan is qualified and the related trust is tax-exempt.

#### **Note 5: Income Tax Status (continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Companies reserve the right to terminate, discontinue making contributions to, amend or modify the Plan at any time. In the event of plan termination, participants would become 100 percent vested in their employer contribution.

#### **Note 7: Rollovers**

During the year ended December 31, 2024, rollovers of \$34,431 occurred as a result of employees transferring amounts from other qualified plans. If rollovers occurred, they would be included on the statement of changes in net assets available for benefits in the participant contributions.

#### **Note 8: Risks and Uncertainties**

The Plan invests in various mutual funds. Mutual funds are exposed to various risks such as interest rate, overall market volatility, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of the mutual funds will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements and supplemental schedule of the Plan.

#### **Note 9: Subsequent Events**

The Plan has evaluated subsequent events through the date of the audit report, which is the date the financial statements were available to be issued. The results of this evaluation indicated that there are no subsequent events or transactions that are required to be disclosed in these financial statements.
