NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1. Plan Description

The following description of the Group Insurance Plan for Certain Retirees of Anheuser-Busch Companies, LLC and its Subsidiaries (the Plan) is intended to give a general summary of its principal provisions. Participants should refer to the Plan Document for more complete information.

General

The Plan was established effective January 1, 2005 by Anheuser-Busch Companies, LLC (the Company) to provide employee health and life insurance benefits for those former common law employees who satisfied the requirements for retiree welfare benefits on their last day of active work for the Company and its subsidiaries, with the exception of certain subsidiaries and certain bargaining groups (Participating Employers). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan Amendments

Effective January 1, 2015, the Company adopted Plan changes related to certain brewery bargaining groups where the Plan was closed to new entrants as of the ratification date and the Company would no longer provide Plan benefits to most post-65 retirees and their dependents and salaried pre-65 Medicare disabled retirees and their Medicare disabled dependents.

Effective January 1, 2019, the Company adopted Plan changes for participants related to certain brewery bargaining groups. The more significant changes are as follows:

- Beginning in January 2020, pre-65 dependents will continue to be eligible for coverage to age 65 even if the retiree is not eligible for post-65 coverage
- Cost share of pre-65 increases by 5% per year until 2024
- For employees retiring after March 31, 2019, the annual HRA contribution is eliminated after December 31, 2029
- Beginning in January 2020, dependents of post-65 retirees will no longer be required to pay a premium for pre-65 coverage

Effective January 1, 2024, the Company adopted Plan changes related to certain brewery bargaining groups. The most significant change was that pre-65 cost share will be 53%.

Participation

Retired employees who meet the eligibility requirements, as described within the various health and welfare benefit plans, may participate in the Plan.

Benefits and Administration

Health, dental, vision and prescription drug benefits are provided primarily on a self-insured basis pursuant to the Plan's agreements. In addition, eligible former employees may participate in fully insured group insurance arrangements with designated Health Maintenance Organizations (HMOs).

Life insurance coverage is provided on an insured basis in accordance with the Plan's agreements.

Employee Benefit Trust

The Plan provides that some or all of its postretirement welfare benefits may be funded through the Anheuser-Busch Employee Benefit Trust (Master Trust) account at Bank of New York Mellon (Trustee and Custodian).

In August 2024, the Master Trust was terminated, and the Bank of New York Mellon account was closed. A separate plan, the Group Insurance Plan for Certain Employees of Anheuser-Busch Companies, LLC (Active Plan), funds certain benefits for its participants through the Master Trust. The Active Plan utilized all of its assets in the Master Trust to fund benefits. Therefore, the Plan owned the entire interest in the Master Trust as of December 31, 2023.

Contributions

The Company makes contributions to the Plan as necessary to pay claims under self-insured benefit programs and pay related claims administration expenses to the extent they are not paid by participant contributions. Under present law, the Company is not permitted to make deductible contributions to the Master Trust for future benefits to current participants.

Premiums paid for life insurance coverage and premiums paid to participating HMOs are paid directly to the insurance carriers by the Plan.

Participants are required to contribute specified amounts to obtain coverage. These amounts are based on the participants' elections and can vary significantly. Participant contributions are used directly to purchase coverage.

Expenses of the Plan

The Plan pays administrative expenses that consist of administrative fees paid to third party claims administrators and transitional reinsurance fees. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses.

Plan Termination

Although it has not expressed any intent to do so, the Company may amend or terminate the Plan at any time. In the event of Plan termination, benefit payments will be made for claims incurred to date of termination.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair market value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities held by the Master Trust investments, and related realized gains and losses, are accounted for on the trade date. The change in value of interest in the Master Trust consists of the Plan's interest in Master Trust interest income, which is recorded as earned.

Allocation of Assets in Employee Benefit Master Trust

The Master Trust was established for the investment of the Plan's assets and certain other Company sponsored health plans. As noted in Note 1, the Master Trust was terminated in August 2024. Effective December 31, 2024, the Plan was the only health plan with assets in the Master Trust.

The interest of each participant plan is represented in units. Each unit represents an undivided interest in the Master Trust. The value of each plan's interest in the Master Trust is based on the beginning of year value of the plan's interest in the trust plus actual contributions and allocated investment income, net of investment expenses and premium payments. The allocation of investment income and administrative expenses is based on each plan's ownership of Master Trust units at the end of each month.

Payment of Benefits

Benefit payments are recorded when paid.

Subsequent Events

Management has evaluated subsequent events through October 14, 2025, the date which the financial statements were available to be issued.

3. Benefit Obligations

The postretirement benefit obligation represents the total actuarial present value of those estimated future benefits that are attributed to employee service rendered prior to December 31, of the applicable year, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants.

Postretirement benefits include future benefits expected to be paid to or for currently retired or terminated employees and their beneficiaries and dependents and active employees and their beneficiaries and dependents after retirement from service with the Company. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan sponsor and from existing Plan assets, net of participant contributions. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligations is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Plan obligations at December 31, for health claims incurred by active participants but not reported at that date and for future disability payments to participants considered permanently disabled at December 31 are estimated by the Plan's actuary in accordance with accepted actuarial principles. Such estimated amounts are reported in the accompanying statement of the Plan's benefit obligations at present value based on the discount rate in the table below and include the plan amendments in Note 1. Health claims incurred by retired participants but not reported at year end are included in the postretirement benefit obligation.

For measurement purposes, the health care cost trend rate assumed for the next year was 6.50% at December 31, 2024 and 6.75% at December 31, 2023. The rate is assumed to decrease to 4.50% by 2033 and beyond.

Health care cost-sharing for salaried retirees under age 65 was 70% for 2024 and 2023.

The following were other key assumptions used in the valuations:

- Discount rate: 5.30% as of December 31, 2024 and 5.60% as of December 31, 2023.
- Mortality for bargaining and non-union hourly: PRI-2012 blue collar mortality tables adjusted with scale MP-2021 to reflect a long-term mortality improvement trend of 0.75% reached in 2037.
- Mortality for salaried: PRI-2012 white collar mortality tables with scale MP-2021 to reflect a long-term mortality improvement trend of 0.75% reached in 2037.
- Retirement age: Percentages vary depending on employment type with percentages distributed over a period from early retirement at age 55, to retirement at age 70 in 2024 and 2023.

The Plan's deficiency of net assets over benefit obligations at December 31, 2024 and 2023, relates primarily to the postretirement benefit obligation, the funding of which is not covered by the current contribution rate. It is expected that the deficiency will be funded through future Company and participant contributions.

The health care cost-trend rate assumption has a significant effect on the postretirement benefit obligations reported. If the assumed rates increased by one percentage point in each year, the obligation at December 31, 2024 and 2023 would increase by approximately \$872,000 and \$2,208,000, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

4. Other Benefit Obligations

Plan obligations for health claims payable are recognized when the Plan pays the claims processor based on information reported by the third-party administrators. Health claims incurred by retired participants but not reported at year end are included in postretirement benefit obligations.

5. Interest in the Master Trust

As noted in Note 1, the Master Trust was terminated in August 2024. Remaining funds in the Master Trust were transferred to the Plan to pay benefits. At December 31, 2024, the Plans undivided interest in the Master Trust was 100%. The following table presents the assets in the Plan's undivided interest in the Master Trust at December 31, 2023:

6. Fair Value Measurements

The Master Trust follows current accounting standards, which provide a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Master Trust has the ability to access.

Level 2 inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value:

Short-Term Investments: Short-term investments are considered to be cash equivalents due to their short maturities and are valued at amortized cost, which approximates fair value.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. Tax Status

As noted in Note 1, the Master Trust was terminated in August 2024. The trust was qualified pursuant to Section 501(c)(9) of the Internal Revenue Code (the Code) and, accordingly, any investment income is exempt from income taxes. The Company received a favorable tax-exempt letter from the Internal Revenue Service (IRS) on November 3, 1988, exempting the trust from federal income tax under section 501(c)(9) of the Code.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

9. Transactions with Party-In-Interest

The Master Trust invested in a short-term investment that was managed by the Trustee. These transactions are exempt party-in-interest transactions under ERISA.
