1. **Description of Plan**

The following description of the Surety Title Company ("Company") 401(k) Retirement Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The plan is a defined contribution plan covering all full-time employees who have one year of service, have been credited with at least 1,000 hours of service, and are age twenty-one or older. Upon satisfying these requirements, the employee becomes eligible to participate in the Plan on the first day of the following quarter. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute up to 90% of annual eligible compensation not to exceed \$23,000 in 2024, as defined in the Plan. Participants have the option to contribute through pretax 401(k) contributions, Roth 401(k) contributions or a combination of the two. For 2024, participants who are projected to be age 50 or older by the end of the calendar year may also make a catch-up contribution of up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers sixty seven mutual funds and one money market account as investment options for participants. The company may contribute a matching contribution to the plan. The amount of the matching contribution, if any, will be determined each year by the employer. The Company made matching contributions of \$148,067 and \$160,330 for 2024 and 2023, respectively. The Company may also contribute a profit-sharing contribution each year. The Company did not make a profit-sharing contribution for 2024 or 2023.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's matching contribution, if any, and allocations of (a) the Company's profit-sharing contribution, if any, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions and rollover contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

1. **Description of Plan** (continued)

**Notes Receivable from Participants**

Participants may borrow from their account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the excess, if any, of the highest outstanding balance of the participant's other loans during the last year, over the current outstanding balance of loans or 50% of the vested account balance, whichever is less. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loan terms may not exceed five years or, in the case of the purchase of a residence, the duration will be determined at the time of the loan. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. The interest rate is equivalent to the prime rate, as published by the Wall Street Journal, on the 14<sup>th</sup> day of each month, plus one percent. The interest rate will be fixed at the rate in effect in the month of origination for the duration of the loan except as otherwise required by law. Principal and interest is paid ratably through payroll deductions or alternative methods. To the extent that participants leave the Company and default on their loans, the Company is required to process the outstanding loan balances as distributions from the Plan.

**Payment of Benefits**

On termination of service due to death, disability, retirement, or for any other reason, a participant or beneficiary may request to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in the form of an annuity over a specified period of time, not to exceed the lifetime of the participant and payable to the participant, the designated beneficiary or a rollover into another qualified retirement plan.

A participant may elect to receive an in-service distribution from his or her deferral contribution account without terminating employment upon attainment of age 59 1/2. A participant may request a hardship distribution from his or her deferral contribution account.

**Forfeited Accounts**

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$33,605 and \$13,596, respectively. Forfeited amounts are to be allocated as described in the Plan document. During the years ended December 31, 2024 and 2023, \$31,490 and \$26,933, respectively, were applied to offset employer contributions.

2. **Summary of Accounting Policies**

**Basis of Accounting**

The Plan's policy is to prepare its financial statements on the modified cash basis of accounting. Consequently, contributions and investment income are recorded as received and expenses when paid.

**Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value as provided by Reliance Trust Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the date paid. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Income Taxes**

The Plan follows the provisions of ASC 740-10, "Accounting for Uncertainty in Income Taxes". This addresses the determination of whether tax benefits claimed, or expected to be claimed, on a tax return should be recorded in the financial statements. The Plan Sponsor recognizes the tax benefit from an uncertain tax position when, based on technical merits, it is more likely than not the position will be sustained on examination by the taxing authorities. The Plan Sponsor recognizes accrued interest and penalties associated with uncertain tax positions as part of the provision for income taxes. The Plan is exempt from federal income taxes and is acceptable under section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. It would be subject to federal excise taxes on prohibited transactions and unrelated business income, if any, as described by the IRC.

The Plan files Form 5500 and applicable schedules with the Department of Labor and the Internal Revenue Service. The Plan is subject to routine audits by those authorities; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to examinations for years prior to 2021.

**Subsequent Events**

Management has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

**3. Fair Value Measurements**

The *Financial Instruments Topic* in the ASC 820 requires disclosures about fair value of financial instruments, clarifies the definition of fair value for financial reporting, establishes a framework for measuring fair value and requires additional disclosures about the use of fair value measurements. The categorization of financial instruments within the valuation hierarchy is based on the lowest level of input that is significant to the fair value measurement. The hierarchy is prioritized into three levels (with Level 3 being the lowest) defined as follows:

Level 1 - Quoted prices in active markets for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Observable inputs other than prices included in Level 1, such as quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in markets that are not active; or other inputs that are observable or can be corroborated with observable market data.

Level 3 - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets and liabilities. This includes certain pricing models, discounted cash flow methodologies, and similar techniques that use significant unobservable inputs.

An asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in Level 1, Level 2, and Level 3 and no changes in valuation techniques for these assets or liabilities for the years ended December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for plan assets at fair value.

Interest Bearing Cash - Federal money market fund that invests in short-term money market instruments provides current income while maintaining liquidity and a stable share price of \$1. The fund generally invests 100% of its assets in U.S. government securities.

Registered Investment Companies – Registered investment companies are made up of a variety of mutual funds whose value is based on quoted market prices determined in an active market.

6. **Related Party Transactions**

Reliance Trust Company is the trustee and ADP Retirement Services is the administrator for the plan, and therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for administrative services amounted to \$49,948 and \$73,562 during the years ended December 31, 2024 and 2023, respectively.

Notes receivable from participants are reported as a party-in-interest. Notes are issued, upon participant request, in compliance with ERISA requirements. Unpaid note balances are \$148,985 and \$129,207 as of December 31, 2024 and 2023, respectively.

7. **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. **Tax Status**

The Internal Revenue Service has determined and informed the Company by letter dated October 6, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

9. **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits - modified cash basis.
