INDEPENDENT AUDITOR'S REPORT

To the Retirement Plan Committee, Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established on January 1, 2005. The Plan covers all eligible employees of Daljaco, Inc. (the Company) and its affiliate, Homecare Resources, Inc. (collectively, the Companies). The Plan is subject to the provisions of ERISA.

On December 29, 2022, the SECURE 2.0 Act of 2022 (SECURE 2.0 Act) was signed into law. The SECURE 2.0 Act makes various required and optional changes applicable to tax qualified retirement plans with varying effective dates through 2027. Certain mandatory changes to plan provisions or optional changes to be made to plan provisions as a result of the SECURE 2.0 Act are discussed in these financial statements. The plan document is required to be amended in regard to the requirements of SECURE 2.0 Act by December 31, 2026.

Eligibility: The Plan covers substantially all employees of the Companies who have completed three months of service, as defined, and are age 21 or older. Employees who are non-resident aliens and residents of Puerto Rico are excluded from participating in the Plan. Eligible employees may enter the Plan on the first day of the month coinciding with or next following the attainment of these requirements.

Contributions: Each year, participants may elect to contribute from 1% up to 90% of their eligible compensation, as defined, up to the maximum allowable contribution amount under the Internal Revenue Code (IRC). These contributions may be made as pre-tax or after-tax Roth deferral contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Companies provide the following contributions to the Plan:

A safe harbor matching contribution, on a pay period basis, equal to 100% of each participant's elective deferrals up to 3% of eligible compensation, plus 50% of each participant's elective deferrals that exceed 3% of compensation but do not exceed 5% of eligible compensation. For 2024, the safe harbor matching contribution totaled \$116,813.

An additional discretionary matching contribution, as determined by the Companies on an annual basis. No additional discretionary matching contribution was made for 2024.

A discretionary nonelective profit sharing contribution as determined by the Companies. Employees must be employed on the last day of the plan year and have completed 1,000 hours of service during the plan year in order to share in the allocation of the discretionary nonelective profit sharing contribution. The contribution will be allocated using an integrated allocation formula. No discretionary nonelective profit sharing contribution was made for 2024.

Qualified Nonelective Contributions (QNECs) and Qualified Matching Contributions (QMACs), as defined in the Plan. No QNECs or QMACs were made for 2024.

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

Participant Accounts: Each participant's account is credited with the participant's contributions and the Companies' contributions, as well as allocations of plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings/losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants may direct the investment of their contributions and the Companies' contributions into various registered investment companies (mutual funds) offered by the Plan. For those participants who do not make an investment selection, their contributions and the Companies' contributions are automatically invested in the Plan's qualified default investment account.

Vesting: Participants are immediately vested in all contributions, plus earnings thereon.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the Prime rate plus 2%. Notes must have a minimum repayment period of one month and can only exceed a repayment period of five years for the purchase of a principal residence, in which case the repayment period may not exceed 30 years. Only two notes may be outstanding at a time. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: Benefit payments may be in the form of lump sums, installment payments or partial withdrawals (\$500 minimum) and are payable upon termination of employment, death, disability or retirement at age 65. The Plan makes automatic distributions of vested account balances that are less than \$7,000 (as updated by the SECURE 2.0 Act) in accordance with plan provisions. Distributions from a participant's rollover account may be made at any time. Hardship withdrawals, in-service withdrawals beginning at age 59½ and effective August 1, 2024, qualified birth or adoption distributions, are also permitted, subject to provisions defined in the plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Basis of Accounting: The Plan's financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes are reclassified as distributions based on the terms of the plan document.

Contributions: Contributions from plan participants and the Companies' safe harbor matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Excess Contributions Payable: Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) plus earnings are recorded as a liability. The payable as of December 31, 2024 and 2023 relates to excess contributions made by one participant during prior plan years. The Company intends to distribute the excess amount plus earnings to the applicable participant (see Note 6).

Payment of Benefits: Benefits are recorded when paid. As of December 31, 2024 and 2023, there were no significant amounts due but unpaid to participants.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Investment management fees of individual fund investments are charged to the respective investment and included in the net appreciation/depreciation of the investment, as they are paid through revenue sharing. Third party investment advisory fees are paid through the Plan Administration Account (PAA). An annual service fee, which includes a base fee plus a per participant fee, and the portion of the plan fiduciary advisory services fee not covered by the PAA, are allocated to participant accounts based on a ratio of the participant's account balance to the total of all participants' account balances and are included in administrative expenses. Fees related to the administration of notes receivable from participants and participant distributions are charged directly to the participant's account and are included in administrative expenses.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2

Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 3 - FAIR VALUE MEASUREMENTS - CONTINUED

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 - INFORMATION CERTIFIED BY A QUALIFIED INSTITUTION

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company (Reliance), a qualified institution and trustee of the Plan.

NOTE 5 - DELINQUENT CONTRIBUTIONS

DOL regulations require employee contributions and repayments of notes receivable from participants to be remitted as soon as they can be reasonably segregated from the plan sponsor's assets, but in no instance later than the fifteenth business day of the month following the month of the contributions. During 2020 and prior plan years, there were various contribution and notes receivable payments totaling \$106,733 (as reported on the Schedule of Delinquent Participant Contributions) not remitted in accordance with the guidelines.

NOTE 5 - DELINQUENT CONTRIBUTIONS - CONTINUED

Several of these delinquent contributions (and the related safe harbor matching contributions) were not remitted to the Plan until 2021. In addition, lost earnings on all untimely contribution and loan repayments reported on the Schedule of Delinquent Participant Contributions were remitted to the Plan during 2021. The Company is in the process of officially correcting these delinquent remittances through the DOL's Voluntary Fiduciary Correction Program (VFCP).

NOTE 6 - TAX STATUS

The IRS has determined and informed ADP, LLC, by a letter dated October 6, 2020, that the prototype plan adopted by the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

During prior years, the Plan failed to operate in accordance with its terms with respect to timely remitting deposits, timely distributing excess contributions, correctly using the Plan's definition of compensation and applying matching contribution rates. The Company hired outside ERISA counsel and is in the process of applying to correct the operational errors under the DOL's VFCP and the IRS's Voluntary Correction Program (VCP). If the DOL and IRS accept the proposed corrections and the Company makes all corrections, the failures should not adversely impact the Plan's tax-qualified status. However, if the DOL and IRS do not accept the corrections, there could be a material impact on the Plan's tax-qualified status. The Company fully intends to correct all operational errors under the VFCP and VCP and expects the DOL and IRS to accept the corrections; therefore, the Company does not believe the Plan will lose its qualified or tax-exempt status.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

ADP Retirement Services (ADP) provides certain administrative services to the Plan pursuant to the Administrative Services Agreement (the Agreement) between the Company and ADP. The Agreement provides for an annual service fee, which includes a base fee plus a per participant fee, and a plan fiduciary advisory services fee, all of which are billed and payable monthly, as well as transactional fees relative to notes receivable and distributions. In conjunction with the Agreement, ADP receives compensation in the form of interest or similar income (float) on contributions, plan loan repayments and withdrawals from the Plan. In addition, ADP receives, as additional compensation, revenue sharing from one or more of the plans investment funds, or from affiliates or agents of such investment funds, for services provided by ADP with respect to such investment funds. A portion of these fees are paid back to the Plan and deposited into the PAA, which is used to offset third party investment advisor fees. Any remaining third party investment advisor fees, after the PAA offsets, are billed to the Plan. At December 31, 2024 and 2023, the PAA balance in the Plan totaled \$3 and \$2, respectively.

NOTE 7 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS - CONTINUED

The Plan or Company may make payments to ADPRS for administrative expenses not covered by revenue sharing. Fees paid by the Plan to ADP amounted to \$30,035 for 2024.

ADP has entered into a service agreement with Reliance under which Reliance has agreed to provide directed trustee services to certain retirement plans for whom ADP, LLC provides recordkeeping and administrative services. ADP compensates Reliance to provide services to the Plan as set forth in the Agreement. As part of Reliance's compensation, Reliance may earn interest on balances, including without limitation disbursement balances and balances arising from purchase and sale transactions.

Fees paid to the third party investment advisor, Founders Financial Securities, LLC, for investment advisory services totaled \$8,928 for 2024, net of revenue sharing credits, and is funded by the PAA.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. As of December 31, 2024 and 2023, 68% and 70%, respectively, of net assets available for benefits is invested in the American Funds Target Date Retirement Funds; however, by their nature, these funds are a diversified mix of equities and fixed income that rebalance over time.
