## INDEPENDENT AUDITOR'S REPORT

### *Opinion*

We have audited the financial statements of Brazos Electric Power Cooperative, Inc. Retiree Welfare Benefit Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### *Responsibilities of Management for the Financial Statements*

December 31, 2024 and 2023

(1) Description of Plan

The following brief description of the Brazos Electric Power Cooperative, Inc. (the “Company”) Retiree Welfare Benefit Plan (the “Plan”) provides only general information. Participants should refer to the employee handbook and Plan document for a more complete description of the Plan's provisions.

(a) General

The Plan provides medical, dental, and life insurance benefits to retired employees of the Company. For employees hired prior to October 1, 1990, an employee is eligible to participate in the Plan upon retirement if the employee is age 55 with ten years of service at the Company after age 45. For employees hired on or after October 1, 1990, an employee is eligible to participate in the Plan upon retirement if the employee is age 55 with twenty years of service at the Company after age 35. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

(b) Plan Benefits

Participants may elect lifetime medical, dental, and/or life insurance coverage for themselves, their beneficiaries, and dependents upon retirement from the Company. The benefits to which participants are entitled vary based on age, retirement date, and years of service.

The Plan is self-insured for medical benefits related to retirees under the age of 65 and dental benefits for all retirees pre-and post-age 65. For medical benefits related to retirees 65 and older, and for all life insurance benefits, the Plan is fully insured.

(c) Funding Policy

The Company makes contributions to the Plan to cover certain medical claims, insurance premium costs, and administrative expenses. Participant contributions represent their portion of insurance premium costs based on their age, retirement date, and years of service. Participants can optionally continue up to \$20,000 of retiree life insurance in effect at their retirement. Retiree life insurance premiums are fixed at retirement.

Retiree contribution rates for medical and dental benefits are as follows (in general):

<u>Participants Hired</u>	<u>Retiree Contribution</u>
Prior to October 1, 1990	Retirees with ten or more years of service from age 45 contribute from 15% to 33% of estimated cost of providing their postretirement benefits based on date of retirement occurring on October 1, 1990 and thereafter. All other retirees pay 100% of the estimated costs.
On or after October 1, 1990 and prior to January 1, 1997	Retirees with twenty or more years of service from age 35 contribute 75% of estimated cost of providing their postretirement benefits. All other retirees pay 100% of the estimated costs.
On or after January 1, 1997	Retirees pay 100% of estimated cost of providing their postretirement benefits.

A closed group of employees retired as of October 1, 1990 pay \$10 a month if under age 65 and \$6 a month if age 65 or older for medical benefits. This closed group pays \$3 a month for dental benefits.

Retiree contribution rates for life insurance benefits are as follows (in general):

<u>Participants Retired</u>	<u>Retiree Contribution</u>
Prior to October 1, 1990	Retirees contribute \$1.89 per thousand of life insurance coverage per month, and the Company pays the balance of the cost up to \$20,000 of coverage.
On or after October 1, 1990	The Company pays 50% of the cost for providing up to \$10,000 of coverage; retirees contribute the remaining 50% and 100% of any optional coverage above \$10,000.

The Company makes contributions to the Plan as needed to fund any claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis. Shares of mutual fund investments were redeemed to reimburse the Company for certain claims, insurance premiums, and administrative expenses paid from Company assets. Reimbursements were \$1,256,009 and \$-0- in 2024 and 2023, respectively.

Although they have not expressed any intention to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

(d) Stop Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount as well as its aggregate exposure for all claims).

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Risks and Uncertainties

The Plan invests in various mutual funds. Mutual funds are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

(d) Income Taxes

The Plan recognizes the effect of income tax positions only if those positions are more likely than not of being sustained. Recognized income tax positions are measured at the largest amount that is greater than 50% likely of being realized. Changes in recognition or measurement are reflected in the period in which the change in judgment occurs.

(e) Stop Loss

Premiums for stop-loss insurance are included in insurance premiums paid in the accompanying statements of changes in net assets available for benefits. Stop-loss refunds have been netted against medical claims paid for participants in the accompanying statements of changes in net assets available for benefits.

(f) Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, benefit obligations and changes therein, liabilities and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(3) Tax Status

The Plan's assets are held in a trust and income generated from such assets is tax-exempt. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently being operated in compliance with applicable sections of the Internal Revenue Code to continue to qualify for tax-exempt status.

(4) Plan Benefit Obligations

The accumulated postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to the valuation date. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the Company.

The actuarial present value of the accumulated postretirement benefit obligation is determined by the Plan's actuary, Willis Towers Watson, and is the amount that results from applying actuarial assumptions to adjust the accumulated benefit obligation to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or termination). The disclosures below were obtained from the December 31, 2024 actuarial valuation report. The significant actuarial assumptions used in the valuation as of December 31, 2024 were (a) life expectancy of participants (Pri-2012 mortality tables projected forward generationally from 2012 with Scale MP-2021 for males and females was utilized; for 2023, Pri-2012 mortality tables projected forward generationally from 2012 with Scale MP-2021 for males and females was utilized), (b) retirement age assumptions (the assumed weighted average retirement age is 65 for both years), (c) discount rate (5.75%; for 2023, the discount rate was 5.31%), and (d) assumed rate of return (8.00%; for 2023, the assumed rate of return was 8.00%)

For measurement purposes at December 31, 2024, a 6.50% annual rate of increase in the per capita cost of covered health care benefits was assumed. The rate was assumed to decrease gradually to 5% by 2031 and remain at that level thereafter. The health care cost trend rate assumption has a significant effect on the amounts reported. If the assumed rate increased by one percentage point in each year, that would increase the obligation as of December 31, 2024 by \$1,697,703.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

In addition, the Plan is self-funded for certain medical benefits. Claims payable of \$20,877 and \$25,387 at December 31, 2024 and 2023, respectively, including amounts incurred but not reported, are included in addition to the above benefit obligation. The provision for claims incurred but not reported is based on historical experience.

On December 8, 2003, the Medicare Prescription Drug, Improvement and Modernization Act of 2003 (the "Act") for employers sponsoring postretirement health care plans that provide prescription drug benefits was signed into law. The Act introduced a prescription drug benefit under Medicare, as well as a federal subsidy to sponsors of retiree health care benefit plans providing a benefit that is at least actuarially equivalent to Medicare Part D(1).

Under the Act, the Medicare subsidy amount is received directly by the plan sponsor and not the related plan. Further, the plan sponsor is not required to use the subsidy amount to

fund postretirement benefits and may use the subsidy for any valid business purpose. The accumulated postretirement benefit obligation information and the changes in the accumulated benefit obligation information do not reflect any amount associated with the Medicare subsidy because the plan is not directly entitled to the Medicare subsidy.

(5) Party-In-Interest Transactions

The Plan has not considered Company contributions to the Plan or medical claims, insurance premiums, and administrative expenses paid by the Plan for participants as party-in-interest transactions.

(6) Fair Value Hierarchy and Measurements

Generally accepted accounting principles establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.
- Level 3 inputs are unobservable inputs for the asset or liability.

The level in the fair value hierarchy within which a financial instrument in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

The following methods and assumptions were used to estimate the fair value of each class of financial instruments:

*Mutual funds:* Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
