**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Smallwood Management Co LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

**GENERAL**

The Plan was established on January 1, 2020. The Plan is a defined contribution retirement plan covering eligible employees of Smallwood Management Company, LLC (the “Plan Sponsor”) and Smallwood Hospitality Operating, LLC (collectively “the Company”). Employees of the Company are eligible to participate in the Plan on the next entry date after completing thirty days of service and attainment of age eighteen (18). Plan entry dates are the first day of each Plan quarter coinciding with or next following the date eligibility requirements are satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**PLAN ADMINISTRATION**

The Company appoints the Plan Administrator and Plan Trustees. The Plan Administrator and Plan Trustees are employees of the Company. The Plan’s third-party administrator, Resource Benefits Administrators (“RBA”), performs the Plan’s administrative duties such as preparation of the Form 5500, participant recordkeeping, compliance testing and enrollment.

**CONTRIBUTIONS**

Participants may elect to contribute pre-tax and Roth post-tax amounts from eligible compensation as defined by the Plan not to exceed the limits of Internal Revenue Service (“IRS”) Code Section 401(k). In addition, participants that reach age 50 before the close of the Plan year may make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions are invested in a designated balance fund until changed by the participant. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes a provision regarding the escalation of deferrals. The auto-enrolled participant’s rates will increase by 1% each year on the first day of the Plan year to a maximum auto-escalation of 5%. The Company will make a safe harbor matching contribution equal to 100% of participant deferrals up to 5% of Plan compensation. In addition, the Company may make additional discretionary matching contributions or profit-sharing contributions; however, none were made in 2024 or 2023.

**PARTICIPANT ACCOUNTS**

Each participant’s account is credited with the participant’s contribution, the Company safe harbor matching contributions, the Company discretionary profit-sharing contribution, and Plan earnings. Allocations of Plan earnings and administrative expenses are based on participant account balances as defined in the Plan provisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**VESTING**

Participants are immediately vested in their elective deferral contributions, rollover contributions, and matching contributions plus actual earnings thereon. Vesting of Company discretionary profit sharing contributions is as follows:

**NOTE 1 – DESCRIPTION OF PLAN – CONTINUED**

**NOTES RECEIVABLE FROM PARTICIPANTS**

The Plan does not permit participants to borrow from their account balance.

**PAYMENT OF BENEFITS**

On termination of service due to death, disability, normal retirement age, and other reasons, a participant may receive their vested benefit in a lump sum payment in cash. If the value of the participant's vested account balance is less than \$5,000 upon termination, the participant will automatically receive a distribution election form and can elect to receive entire balance in the form of a lump sum distribution or qualified rollover, however, if not timely elected the participant account will be transferred to an individual retirement account as specified by the Plan. Should a participant's balance upon termination be below \$1,000, the participant will receive their funds in the form of a lump sum distribution. A participant must be age 59 ½ or have incurred a financial hardship, as defined in Plan provisions, to qualify for an in-service distribution.

**FORFEITURES**

Forfeitures may be used to reduce employer contributions or pay Plan expenses. For the years ended December 31, 2024 and 2023, there were \$7 and \$3,351 of forfeited non-vested account balances, respectively. During the plan year ended December 31, 2024, the Plan received \$359 in new forfeitures and earnings. The Company used \$3,703 during the year ended December 31, 2024 to offset employer match contributions.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The financial statements of the Plan have been prepared in accordance with generally accepted accounting principles in the United States of America ("GAAP").

**USE OF ESTIMATES**

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by investment advisors and the Trustees. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**CONTRIBUTIONS**

Contributions from the Plan participants and matching contributions from the Employer are recorded in the year in which participant compensation is earned.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED  
EXPENSES**

The Company, at its sole discretion, may pay the administrative expenses (i.e., trustee fees, fund fees, loan fees, recordkeeping fees and other similar expenses) of the Plan and are excluded from these financial statements. If such expenses are not paid by the Plan Sponsor, they are paid out of plan assets. Investment related expenses are included in net investment appreciation from investments.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024:

*Money market fund:* Valued at the per unit price as quoted by the financial institution.

*Mutual funds:* The fair value of mutual funds are based on quoted net asset values of the shares as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Capital Bank and Trust Company and provided by RBA. Capital Bank and Trust Company is a Trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for administrative services amounted to \$4,425 for the year ended December 31, 2024. Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of investments.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 7 – TAX STATUS**

The Plan Sponsor has adopted a volume submitter plan which received a favorable opinion letter from the IRS that the form of the Plan is acceptable under Section 401(a) of the Internal Revenue Code (“IRC”). The Plan Administrator and tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits of any tax period in progress.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in a variety of investment funds. Investment securities are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 – SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued.
