Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Kari-Out 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was organized on January 1, 2000 and is a 401(k) and profit sharing plan covering substantially all employees of, Kari-Out, LLC (the "Sponsor"), and its affiliated entities, Special Quality Packaging, LLC and Tripak Industrial USA, LLC (collectively the "Company"), who are not covered by a collective bargaining agreement, and are not nonresident aliens who do not receive any earned income from the Company. The Plan was amended, effective January 1, 2023, to change eligibility to participate from immediate upon commencement of employment to at least three months of service. Employees must have also attained the age of 18 or older to participate in the Plan. The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974, as amended (ERISA).

The Board of Trustees and plan administrator are responsible for the oversight of the Plan and determine the appropriateness of the Plan's investment offerings and monitor investment performance.

On November 1, 2023, the Jadine Foods Inc. 401(k) Plan was merged into the Plan.

Contributions

Contributions to the Plan may be pre-tax Salary Deferrals or after-tax Roth Deferrals. Participants who have attained age of 50 before the end of the Plan year are eligible to make catch-up contributions. Rollover contributions are subject to the terms of the Plan and are fully vested and non-forfeitable.

For the year ended December 31, 2024, the Company made safe harbor matching contributions, net of forfeitures, of \$688,926 to the Plan. The Company did not make any other contributions to the Plan. Participants direct the investment of their balances into various investment options offered by the Plan. Contributions are subject to certain statutory limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, Company contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in Company discretionary matching contributions and nonelective contributions is based on years of continuous service as follows:

Participants are immediately vested in Company safe harbor matching contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% (50 percent) of their vested account balance. Notes receivable from participants are secured by the balance in the participant's account. The interest rates on outstanding loans range from 5.00% to 9.50% per annum. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement or other, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants are entitled to receive in-service withdrawals upon attainment of age 59½ or as a hardship distribution, as defined in the Plan agreement.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$32 and \$31, respectively. Forfeitures, if any, are used to reduce employer contributions. For the year ended December 31, 2024, employer contributions were reduced by \$22,135 from forfeited nonvested accounts.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and could cause our reported performance of the Plan to vary significantly from period to period.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment-related expenses are included in net change in fair value of investments.

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan’s financial statements and supplemental schedule of assets (held at end of year), that was prepared by or derived from information prepared by the trustee Reliance Trust or the insurer Voya Retirement Insurance and Annuity Company (“Voya”), and furnished to the Plan administrator. The Plan administrator has obtained the certifications from Reliance Trust and Voya as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that such information is complete and accurate.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. The mutual funds held by the Plan are deemed to be actively traded.

Common and Collective Trust

Composed primarily of fully-benefit responsive investment contracts and is valued at their NAV of units of the bank collective trust. The net asset value is used as a practical expedient to estimate the fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. There are no participant redemption restrictions for these investments.

NOTE 5 – GROUP ANNUITY CONTRACT WITH VOYA RETIREMENT INSURANCE AND ANNUITY COMPANY

On December 3, 2015, the Plan entered into a fully benefit-responsive guaranteed investment contract with Voya. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$-0- and \$76,136, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than an annual rate of 1%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Voya. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material

misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The Plan terminated the contract effective July 31, 2022, when the Plan changed third-party administrators from Voya to Automatic Data Processing, Inc ("ADP"). At the time of termination, the Plan had the option to surrender the contract for its full current adjusted value or surrender the contract over 5 annual installments, at contract value, plus accumulated interest with interest never to be less than the contract's minimum crediting rate of 1%. The Plan elected the 5-year pay spread option. As such, no further participant contributions or investment transfers are permitted.

As part of the 5-year pay spread option, Voya will permit the Plan's trustee to withdraw amounts from the remaining contract balance prior to the next annual scheduled installment date and transfer them to ADP, for the limited purpose of meeting tax-reportable benefit distributions for participant retirement, death, disability, separation from service, hardship, loan or in-service withdrawals after the participant attains age 59 ½. No additional withdrawals will be permitted. Voya will be paying the annual amounts to ADP and ADP will be depositing these funds in a common collective trust as elected by those participants invested in the contract.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE 7 – TAX STATUS

The Plan has adopted a non-standardized defined contribution pre-approved plan and is relying on an opinion letter received from ADP dated October 6, 2020, stating that the Internal Revenue Service has determined that the non-standardized defined contribution pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan utilizes ADP as the recordkeeper of the Plan and Reliance Trust as the trustee of the Plan. Prior to ADP, the Plan utilized Voya as the recordkeeper and insurer of the Plan. Therefore, certain transactions qualify as party-in-interest transactions. Fees of \$87,626 were paid to these providers from the Plan during the year ended December 31, 2024.

LPL Financial Corporation, an advisor of the Plan, are parties-in-interest and are paid from net investment earnings of the Plan.

NOTE 11 – NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS

During the year ended December 31, 2024, the Company failed to correctly apply the definition of compensation for certain types of compensation, resulting in missed participant deferrals in the amount of \$1,110, plus related employer safe harbor matching contributions of \$443 and earnings thereon. As a result, nonexempt party-in-interest transactions occurred. The Company is in the process of self-correcting these nonexempt transactions by depositing the missed participant and employer contributions, along with the related earnings, into the affected participants' accounts.

NOTE 12 – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 14, 2025, the date the financials were available to be issued.
