### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Thrift World 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by state or federal agency, provided that the statements or information regarding assets held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

#### 1. Description of the Plan

The following description of the Thrift World 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### A. General

The Plan is a defined contribution plan covering substantially all employees of Thrift Holdings, LLC ("the Company"). Employees become eligible to participate in the Plan upon completing six months of service, as defined by the Plan. Participants may enter the Plan on the first day of each month coinciding with or following the date eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

##### B. Contributions

Participants may contribute up to 90% of their annual eligible compensation, as defined by the Plan, not to exceed limitations set by the Internal Revenue Code (IRC) as either pre-tax or after-tax Roth contributions. Participants who have attained age 50 during the Plan year are eligible to make catch-up contributions. Participants and eligible employees who are not yet participants may also contribute rollover contributions from other qualified plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their pre-tax deferral set at 3% of eligible compensation, and their contributions invested in a target date investment fund based on anticipated retirement date, until changed by the participant. The Plan does not provide automatic escalation of deferral rates.

The Company may make annual discretionary matching and discretionary nonelective contributions to be determined annually. The discretionary nonelective contribution is allocated to participants as a ratio of each participant's compensation to the total compensation of all participants. To receive either employer contributions participants must be employed at year-end (unless separated due to death, disability, or retirement) and have 1,000 hours of service during the year. The Company made no discretionary nonelective contributions in 2024 and 2023. In 2024 and 2023 the Company made a discretionary matching contribution of 100% of participant deferrals up to 2% of total eligible compensation totaling \$74,705 and \$68,477, respectively. Company contributions are subject to IRC limitations. Participants are allowed to direct the investment of all contributions into various investment options offered by the Plan.

##### C. Participant Accounts

Each participant's account is credited with the participant's contribution and Company discretionary matching and discretionary nonelective contributions, as well as allocations of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### D. Vesting

Participants are immediately vested in their elective contributions. Vesting in Company discretionary contributions, if any, is based on years of credited service. Participants vest 20% after one year of credited service and 20% each year thereafter and are fully vested after five years of credited service.

##### E. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account. Participants may have only one outstanding loan at any given time. The loans are secured by the balance in the participant's account and bear interest at 1% over the prime rate at the time the loan is granted. Principal and interest are paid ratably through payroll reductions.

##### F. Payment of Benefits

Upon attainment of age 59 ½, termination of service, death, or disability, a participant (or their beneficiaries) may elect to receive the vested portion of his or her account in a lump sum or partial withdrawal in the form of cash.

##### G. Forfeitures

At December 31, 2024 and 2023, there were no forfeited nonvested accounts. These accounts are used to pay Plan administrative expense or reduce the Company's contributions. During 2024 and 2023, forfeitures of \$6,893 and \$0, respectively, were used to pay plan expenses.

#### 2. Summary of Significant Accounting Policies

##### A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

**B. Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**C. Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**D. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**E. Payment of Benefits**

Benefits are recorded when paid.

**F. Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company, at its discretion. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable and distributions from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### G. Subsequent Events

#### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trust (CCT) Funds:* Valued at NAV, based upon the market value of underlying investments, which may include separate accounts, equities, preferred stock, bonds, real estate, mutual funds, investment contracts, and security-backed contracts. The CCT NAV is provided by the sponsor, Invesco Trust Company, and is not a publicly quoted price in an active market.

#### 5. Party-in-Interest Transactions

The Plan engages the services of Automatic Data Processing and Reliance Trust Company (collectively, "ADP"), whose responsibilities include investing assets, paying benefits to participants under the direction of the Plan's management team, and performing the recordkeeping of the Plan. Administrative expenses paid by the Plan are paid to ADP and qualify as party in interest transactions.

#### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in any employer discretionary contributions.

#### 7. Tax Status

This Plan is a non-standardized preapproved plan created by ADP and adopted by the Plan on October 1, 2022. On October 6, 2020, the Internal Revenue Service (IRS) stated the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the IRC. The Plan has not received a determination letter specific to the Plan, however, the plan administrator believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

#### 7. Tax Status - Continued

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination of the IRS. The plan administrator has analyzed the tax positions taken by the plan, and concluded as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 8. Risks and Uncertainties

The Plan provides for investment options in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investments will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.
