Independent Auditor's Report

To the Plan Administrator of BTG Pactual 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of BTG Pactual 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of BTG Pactual 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about BTG Pactual 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of the Plan

General

The following description of BTG Pactual 401(k) Plan (the “Plan”) is provided for general information purposes only. More complete information regarding the Plan’s provisions may be found in the Plan document and Summary Plan Description, copies of which may be obtained from the Plan sponsor.

The Plan was established on January 1, 2014 and is a defined contribution plan covering employees of BTG Pactual US Capital LLC, BTG Pactual Asset Management US LLC, Engelhart CTP US LLC, BTG Pactual Timberland Investment Group LLC and TTG Forestry Services LLC (together “BTG Pactual” or the “employer”). All employees of BTG Pactual above, after completion of 3 months of service, are eligible to participate in the Plan, with the exception of certain employees as identified in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Automatic Data Processing, Inc. (ADP) serves as recordkeeper and Reliance Trust Company (the “Trustee”) as trustee of the Plan.

Participant Contributions

Participants may elect to contribute up to 90% of their annual compensation, as defined, subject to Internal Revenue Code (“IRC”) limitations. All participant elective contributions and earnings thereon are 100% vested upon contribution. A participant who is eligible to make elective pre-tax contributions and is at least age 50 by the end of the Plan year, may make pre-tax catch-up contributions up to \$7,500 (in 2024). Participants can also make Roth 401(k) contributions. The Plan may receive, on behalf of a participant, rollover contributions from another qualified plan prior to meeting eligibility requirements of the Plan. These contributions are 100% vested upon contribution.

Any contribution in excess of the participant’s aggregate contribution made to the Plan over the limit pursuant to Internal Revenue Service (“IRS”) regulations must be refunded to the participant. Such amounts are reflected as “Excess contributions payable” in the accompanying statements of net assets available for benefits. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

Employer Contributions

BTG Pactual provides a matching contribution in an amount equal to: (i) 100% of the employee’s Matched Employee Contributions that are not in excess of 3% of the employee’s compensation, plus (ii) 50% of the amount of the Matched Employee Contribution that exceeds 3% of the employee’s compensation but that do not exceed 5% of the employee’s compensation, as defined.

BTG Pactual may make a discretionary matching contribution in a percentage determined by the employer each Plan year based on a percentage of the employees’ pre-tax contributions of the current year. In addition, discretionary nonelective employer contributions are allowed by the Plan, if any. There were no discretionary matching or nonelective contributions made to the Plan during 2024.

Employer matching contributions become vested upon contribution.

Participant Accounts

Each participant's account is credited with the participant's contribution, BTG Pactual's matching contributions and allocations of Plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct all contributions into various investment options offered by the Plan and can change their investment options on a daily basis.

Payment of Benefits

Benefits are paid at retirement, death or termination of employment. Further, while still employed by BTG Pactual, participants may withdraw the employee contribution portion of their account under certain hardship circumstances, as defined by the Plan. Upon termination of service, participants with vested account balances of \$1,000 or less will receive a lump-sum distribution. Participants with vested account balances greater than \$1,000 have various payment options such as a lump-sum distribution or installment distributions, as described in the Plan agreement.

Notes Receivable From Participants

A participant may apply to borrow the lesser of 50% of his or her vested account balance or \$50,000 reduced by the highest outstanding loan balance in his or her account during the prior one-year period, with a minimum loan amount of \$1,000. Loans are repayable through payroll deductions over a period not to exceed 5 years, except for the purchase of a primary residence. The interest rate is determined by the Plan administrator based on prevailing market conditions.

Termination of the Plan

Although it has not expressed any intent to do so, BTG Pactual has the right to terminate the Plan by action of the designated principal(s), subject to the provisions of ERISA. The Plan administrator will facilitate the distribution of account balances in single lump-sum payments to each participant in accordance with Plan provisions until all assets have been distributed by the Trustee. Each participant in the Plan upon Plan termination will automatically become 100% vested in his/her account balance.

Forfeitures

The Plan may use forfeitures to reduce employer contributions or pay Plan expenses if so elected. At December 31, 2024 and 2023, total forfeitures amounted to \$190,151 and \$186,597, respectively. For the year ended December 31, 2024, forfeitures used to reduce the employer contributions were \$11,109.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles ("U.S. GAAP").

2. Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of the financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and changes in net assets available for benefits during the year. Accordingly, actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year such adjustments are determined.

Investment Valuation

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Mutual funds are valued at quoted market prices, which represent the net asset value ("NAV") of shares held by the Plan at year-end. Common collective trust funds are measured at the NAV practical expedient as determined by the issuer.

Investment Transactions and Income Recognition

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected in the net appreciation or depreciation in the fair market value of such investments.

Contributions

Contributions are recorded in the period in which payroll deductions occurred.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

Administrative fees in the amount of \$3,700 for the year ended December 31, 2024, reflected in the statement of changes in net assets available for benefits, included recordkeeping and other administrative expenses. Administrative expenses can be paid directly by either the Plan or BTG Pactual, as provided by the Plan agreement.

3. Investments Certified by the Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the Plan administrator and certified as complete and accurate by the Trustee.

The Plan administrator has elected the method compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023.

4. Fair Value Measurements

The Plan follows the guidance of Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) Topic 820, “*Fair Value Measurements and Disclosures*,” which defines fair value and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable. Prices are determined using significant unobservable inputs. In situations where quoted prices or observable inputs are unavailable (for example, when there is little or no market activity for an investment at the end of the period), unobservable inputs may be used. Unobservable inputs reflect the Plan administrator's own assumptions about the factors market participants would use in valuing a portfolio instrument, and would be based on the best information available.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

(1) This category includes a common/collective trust fund that is designed to deliver safety and stability by preserving principal and accumulating earnings. This fund is primarily invested in guaranteed investment contracts and synthetic investment contracts. Participant-directed redemptions have no restrictions; however, the Plan is required to provide a 60 days redemption notice to liquidate its entire share in the fund.

5. Tax Status

The Plan has adopted a non-standardized “Pre approved” plan which received an opinion letter from the IRS dated October 6, 2020, stating that the form of the plan is qualified under Section 401 of the IRC. Any employer adopting the form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan provides for various investment options in any combination of funds offered by the Plan. These funds are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

7. Related-Party and Party-in-Interest Transactions

The Plan sponsor is a party-in-interest with respect to the Plan, as personnel and facilities of the company have been used to perform administrative functions for the Plan at no charge to the Plan. Notes receivable from participants are also party-in-interest transactions.

8. Subsequent Events

Management evaluated subsequent events for the Plan through October 13, 2025, the date the financial statements were available to be issued. There were no material subsequent events that require disclosure under FASB ASC 855, *Subsequent Events*.
