### NOTE A - DESCRIPTION OF PLAN

The following description of Commonwealth Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan sponsored by E J Stewart, Inc. covering all full-time employees, except for highly compensated employees, union employees, nonresident aliens, and residents of Puerto Rico as defined in Section 414(q) of the IRC, who have six months of service and are employed by the following companies and individual (the “Company”).

Commonwealth Real Estate Investors (“CREI”)  
Keystone Quality Transport, Inc.  
Keystone Care Administrative Services  
Martin Drugs, Inc.  
Rockwell Center  
Lifestar Response of Maryland  
Walter M. Strine, Jr.

The Plan was amended and restated effective October 1, 2018. Under this restatement, the Plan adopted the Principal Financial Group 401(k) volume Submitter Plan. The Plan was restated on December 1, 2022, with Automatic Data Processing (“ADP”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

#### **Contributions**

Each year, participants can elect to defer a percentage up to a maximum of 75% of their compensation, as defined in the Plan, on a pre-tax or Roth basis. Participants could make maximum contributions of \$23,000 for 2024. Certain eligible employees were allowed to make additional catch-up elective deferrals of up to \$7,500 for 2024. Participants may also contribute amounts representing distributions from another qualified plan (rollover). A matching contribution for eligible employees may be made at the discretion of the Company. For the 2024 plan year, the Company elected to match 25% of an eligible employee’s deferred salary reduction up to a maximum salary reduction amount equal to 4% of compensation during the plan year. The Plan can also make nonelective contributions at management’s discretion. There were no nonelective contributions for the year ending December 31, 2024.

**Investment Options**

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds with various investment strategies, a pooled separate account, and common collective trusts.

**Participant Accounts**

A separate investment account is maintained for each participant. Participants may direct the investment of their accounts into various funds specified by the Plan. Participant accounts are credited with the participant's contribution, an allocation of the Company's discretionary contributions and an allocation of Plan earnings (losses) and charged with an allocation of administrative expenses, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Participant loans are permitted under the Plan. Participants may elect to take up to two loans from the Plan at any given time. The minimum loan amount is \$1,000. As required by law, a loan amount is limited to the lesser of \$50,000 or 50% of the participant's vested account and must be repaid within five years unless the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

**Vesting**

Participants are always 100% vested in their own 401(k) salary deferral contributions. Vesting in the Company's contribution portion of their accounts is based on years of service in accordance with the following schedule:

**Forfeitures**

Under the Plan, forfeitures are kept in the Plan assets and can be used to reduce Company matching contributions or to pay administrative expenses out of the Plan. The forfeited non-invested accounts at December 31, 2024 and 2023 were \$42 and \$41, respectively. During the year ended December 31, 2024, \$3,260 of forfeitures were used to reduce employer contributions.

**Payment of Benefits**

Upon termination of service, including instances due to death, disability, or retirement, a participant or their beneficiary may elect to receive an amount equal to the value of the participant's account as a lump-sum distribution. In the event of a hardship, an active employee may elect a withdrawal from their elective deferral contributions.

**Plan Expenses**

Certain administrative expenses of the Plan are paid by the Company and are excluded from these financial statements. Investment and recordkeeping expenses are paid by the Plan and/or the participants to the extent that such expenses are not paid by the Company. Any investment expenses associated with the Plan's investments are netted with investment earnings and reported to the Plan as a net amount.

**Plan Termination**

The Plan may be terminated at any time by the Company. If the Plan is terminated or if contributions to the Plan are permanently discontinued, participants will become fully vested in all amounts credited to the participants' separate accounts in the Plan. In the event of Plan termination, distribution of participant accounts shall be in accordance with the Plan document.

**Plan Amendments**

On December 29, 2022, the "Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act" was signed into law in the United States. The Secure 2.0 Act is an expansion of the Secure Act passed during 2019. The Act includes several mandatory and optional provisions that will become effective across several years. The Secure 2.0 Act aims to expand retirement access, increase retirement savings, and simplify plan administration. Plans may choose to operationally implement the provisions of the Secure 2.0 Act, however plan administrators have until December 31, 2026 to officially amend the plan document to reflect the provisions adopted by the plan.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### **Investment Valuation and Income Recognition**

Plan investments in mutual funds (registered investment companies), common collective trusts and pooled separate accounts are stated at fair value. Shares of mutual funds and pooled separate accounts are valued at quoted market prices. The Plan's investments in the common collective trust are stated at net asset value per share as a practical expedient. Net appreciation or depreciation of investments is reported on the statement of changes in net assets available for benefits and consists of realized gains and losses and the unrealized appreciation or depreciation of these investments. All underlying investments options are valued daily. This daily price is considered the selling price for transfers and withdrawals and is calculated each day the principal market is open and available to any participant in the Plan.

All transactions are recorded on the accrual basis. Purchases and sales of investments are recorded based on the trade date. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Realized gains or losses on security transactions are determined using the average cost of securities sold on the trade date. Expenses are recorded as incurred.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Any individual credit risk related to participant loans is mitigated by the fact that these loans are secured by the participant's vested balance. If a participant were to default, the participant's account balance would be offset by the unpaid balance of the loan, and the participant would be subject to tax on the unpaid loan balance. As such, the participant is the only party affected in the event of a default. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan.

#### **Party-in-Interest Transactions**

The U.S. Property Separate account as well as the Principal common collective trusts of the Plan are managed by a Plan custodian, therefore, all transactions involving these investments qualify as allowable party-in-interest transactions.

The Plan also allows loans to participants, which are secured by the balances in the participants' accounts. These transactions qualify as allowable party-in-interest transactions.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE D - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Accounting Standards Codification 820-10 establishes a valuation hierarchy for disclosure of the inputs to the valuation used to measure fair value. This hierarchy prioritizes the inputs into three broad levels.

*Level 1* inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities. *Level 2* inputs are quoted prices to similar assets and liabilities in active markets or inputs that are observable for the asset or liability, either directly or indirectly through market corroboration, for substantially the full term of the financial instrument. *Level 3* inputs are unobservable inputs based on our own assumptions used to measure assets and liabilities at fair value. A financial asset or liability’s classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement.

The underlying mutual funds held in the pooled separate account are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price.

Common collective trust funds are composed primarily of target retirement funds that are valued at the NAV of units of the bank collective trust. The NAV, as determined by the Trustee, is based on the fair value of the underlying investments held by the fund less liabilities. Participant transactions (purchases and sales) may occur daily.

### **NOTE E - TAX STATUS**

The Plan is operating under a prototype non-standardized 401(k) profit sharing plan prepared by ADP. The prototype plan obtained its latest opinion letter dated October 6, 2020, in which the Internal Revenue Service ("IRS") stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter; however, the plan administrator and the plan's advisors believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax-exempt. The Plan is aware of certain operational errors during 2024 and 2023 and is in the process of correcting the operational errors with assistance from ADP.

Management has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

### **NOTE F - RISKS AND UNCERTAINTIES**

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **NOTE G - OPERATIONAL FAILURES**

After the year ended December 31, 2024, the plan administrator discovered that the Plan's compensation definition was not applied correctly, resulting in the inadvertent exclusion of certain compensation when calculating plan contributions, including employer match. The plan administrator is working to identify the affected participants and subsequently deposit a Qualified Non-elective Contributions ("QNEC") into the Plan to correct these operational failures.
