- 36) We acknowledge our responsibility for fairly presenting the Schedule of Assets (Held at End of Year) as of December 31, 2024, including its form and content, in accordance with U.S. GAAP and in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The method of measurement and presentation of the supplemental schedule has not changed from those used the prior year, and we have disclosed to you any significant assumptions or interpretations underlying the measurement and presentation of the supplemental schedule.
- 37) We have analyzed the tax positions taken by the Plan, and have concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognitions of



a liability or disclosure in the financial statements. In addition, currently there are no audits for any tax periods in progress.

- 38) There were no participant complaints during the year.
- 39) The Plan trustees have reviewed vendor contracts and fees associated with administration and fund management and are satisfied to the reasonableness of these fees.
- 40) We acknowledge that administrative expenses paid by the Plan sponsor on behalf of the Plan will not be reimbursed by the Plan.
- 41) We will notify you in advance of our intent to include your report, in whole or in part, in any document other than Form 5500 filed with a regulatory agency or printed, in whole or in part, for any reason, and you will have the opportunity to review such matter before its filing or issuance.
- 42) We have obtained the service auditor's report (SOC 1) from our service organization Reliance Trust Company. We have reviewed such report, including the complementary user controls. We have implemented the relevant user controls, and they were in operation for the year ended December 31, 2024.
