### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of The Deep Foods Group Retirement Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

**Note 1. Description of the Plan**

The following brief description of The Deep Foods Group Retirement Plan (Plan) provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

***General***

The Plan was established on February 1, 2017, amended and restated in April 2022, and is a defined contribution plan covering all eligible employees of Deep Foods, Inc., Deep Dairy Products, L.L.C., Chetak Chicago, L.L.C., Chetak San Francisco, L.L.C., Chetak New York, L.L.C., Chetak Orlando, L.L.C., Champa New Jersey, L.L.C., Trikam New York, L.L.C., Trikam New Jersey, L.L.C., Chetak Los Angeles, L.L.C., (collectively the "Company" or "Employer"). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Effective January 1, 2025, the Plan's trustee changed from Reliance Trust Company to ADP Retirement Trust Company, LLC.

***Eligibility***

An employee becomes eligible to participate in the Plan after completing six months of service and attainment of 21 years of age. An eligible employee who has satisfied the eligibility requirements can become a participant on the first day of the following month.

***Contributions***

Participants may elect to contribute pre-tax and/or Roth deferral contributions, up to the maximum amount permitted by the Internal Revenue Code. Participants may also make rollover contributions from other qualified plans. Effective May 1, 2020, participants salary deferral contributions are not to exceed 90% of compensation, subjected to the limitations of the Internal Revenue Code.

The Company is required to make a safe harbor matching contribution equal to 100% of a participant's salary deferral contributions up to 3% of their compensation and 50% of the participant's salary deferral contributions that exceed 3% of their compensation not to exceed 5%. The Company may also make a discretionary employer match to participants in accordance with provisions contained in the Plan document. The Company did not make a discretionary employer match for the year ended December 31, 2024.

***Participant Accounts***

Each participant's account is credited with their contributions, employer contributions and the earnings thereon. Contributions to the Plan are invested by the custodians as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provision of the Plan.

***Vesting***

Participants are immediately vested in participant's deferral contributions and safe harbor matching contributions. Vesting in the Company's discretionary matching contributions, plus actual earnings thereon is as follows:

***Notes Receivable From Participants***

Participants are permitted to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum term of a loan is five years. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate determined by the plan administrator based on prevailing interest rates at the time of the loan. Notes receivable from participants are repaid through payroll deductions and monitored by the plan administrator. Notes receivable from participants are measured at their unpaid principal balance, plus any accrued interest. As of December 31, 2024, the interest rates on notes receivable from participants range from 4.25% to 9.50%.

Effective May 1, 2020 participants are permitted to have up to two outstanding loans.

***Benefits***

A participant's vested interest in the Plan's assets is distributable upon termination, disability, retirement or death. Participants may withdraw from their individual accounts pursuant to specific guidelines as set forth in the plan document.

***Administrative Expenses***

All transaction fees for loans and distribution requests and recordkeeping fees are paid from participants' accounts. All other administrative expenses are paid by the Company.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, when applicable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value as determined by the Plan's Management (see Notes 3 and 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Subsequent Events***

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available for issuance.

**Note 3. Certification of Plan Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Disclosure About Fair Value of Plan Assets**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the assets or liabilities; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- *Common collective trust*: The fair value of the common collective trust is determined by the trustee of the common collective trust based on the underlying assets, which represent the net asset value of units held by the Plan. Participant-directed redemptions can be made on any business day and do not have a redemption notice period. There were no unfunded commitments.
- *Mutual funds*: Shares held by the Plan at year-end are valued at unadjusted quoted prices in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Related-Party Transactions**

ADP is the third-party administrator of the Plan and therefore, these transactions qualify as party-in-interest transactions. UBS Financial Services, Inc. is the investment advisor for the Plan. Fees paid to the third-party administrator and investment advisor for the year ended December 31, 2024 were \$71,095.

**Note 6. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

**Note 7. Income Tax Status**

On October 6, 2020, the Internal Revenue Service stated that the prototype plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes it is no longer subject to income tax examinations for years prior to January 1, 2021.

**Note 8. Risks and Uncertainties**

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.
