Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hyundai Translead Employee Savings and Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF THE PLAN

Plan Description

The following description of the Hyundai Translead Employee Savings and Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan covering all full-time employees of Hyundai Translead (the "Company") who are older than 21 years and have at least three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 of 1974 ("ERISA").

B. Contributions and Forfeitures

Participants may elect to defer a percentage of their compensation, as defined in the Plan, up to 90% of annual compensation. Participants who have attained age 50 before the end of the Plan year may be eligible to make catch-up contributions. Effective March 1, 2024, the Plan was amended to include automatic enrollment for eligible participants at a deferral rate of 4% of compensation. In addition, the Company matches a participant's contribution to the Plan in an amount equal to 100% of the first 3% of annual compensation that participants contribute to the Plan. Effective March 1, 2024, Company match contribution was increased to 100% of the first 4% of annual compensation.

Forfeited nonvested amounts totaled \$10 and \$11 at December 31, 2024 and 2023, respectively. Forfeitures may be used to pay Plan expenses and reduce Company contributions; \$1 of forfeitures were used to reduce Company contributions for the year ended December 31, 2024.

C. Vesting

Participants are immediately vested in their contributions, rollover contributions, and actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus earnings thereon is based on years of continuous service according to the following schedule:

Effective March 1, 2024, the Plan was amended to provide for 100% immediate vesting in Company matching contributions upon entering the Plan.

D. Payment of Benefits

Upon termination of service, including termination due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Normal retirement age is 65. Benefits are recorded when paid.

D. Payment of Benefits (Continued)

A participant may elect a hardship distribution if it is deemed that the participant has an immediate and heavy financial need, as described by the Plan. This distribution is subject to the applicable federal and state taxes and/or penalties.

E. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000, up to the lesser of \$50,000 less the highest outstanding loan balance during the prior 12 months, or 50% of their vested account balance. A loan is secured by a participant's vested account balance, bears interest at available market financing rates, and must be repaid to the Plan in five years unless the loan is used for the purchase of a principal residence, in which case the plan administrator may permit a longer repayment period. The plan administrator establishes the specific terms and conditions of loans to participants. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50%.

F. Administrative Expenses

Most administrative expenses are paid by the Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

B. Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

The participants select how their share of Plan assets will be invested among those investment vehicles made available.

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

The objective of the fund is to maintain safety and preservation of principal and accumulated interest. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares of the common/collective trust.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividends and interest. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

D. Risks and Uncertainties

Plan investments are exposed to risks such as interest rate, market fluctuations, and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in market values, interest rates, or other factors in the near term would materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 3 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023, and investment income for the years ended December 31, 2024 and 2023 that is disclosed in the accompanying financial statements and supplemental schedule were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

NOTE 4 - INCOME TAX STATUS

The Company adopted a prototype plan that has received an opinion letter from the Internal Revenue Service dated July 16, 2014 stating that the form of the prototype plan is acceptable under Section 401 of the Internal Revenue Code (the "Code"). The Plan has since been amended. However, the plan administrator believes that the Plan is currently being operated in compliance with the applicable provisions of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts and Plan assets will be distributed based upon the participants' account balances at the time.

NOTE 6 - PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the trustee or an affiliate of the trustee. Any purchases and sales of these investments are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibitions of party-in-interest transactions under ERISA.

NOTE 7 - PLAN AMENDMENTS

Effective March 1, 2024, the Plan adopted the following amendments:

- Participants will be 100% vested in Company match contributions upon entering the Plan.
- Participants will be automatically enrolled into the Plan with a deferral rate of 4% of compensation, upon meeting eligibility requirements.
- Company will match an amount equal to 100% of the first 4% of annual compensation contributed by a participant.

On September 25, 2024, the Plan adopted the following amendments with an effective date of January 1, 2025:

- To begin making safe harbor matching contributions equal to 100% of participant deferrals up to 4% of compensation.

NOTE 8 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
