Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of EQT Redwood Residential 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

NOTE 1 - Description of Plan

The following description of EQT Redwood Residential 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

- A. General - The Plan is a defined contribution plan with an Internal Revenue Code ("I.R.C.") Section 401(k) provision covering all eligible employees of the Redwood Residential, LLC and Redwood Residential CA Inc. (the "Company" or "Employer") who meet the eligibility requirements of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan trustees and administrators are responsible for oversight of the Plan including monitoring of investment performance and determining appropriate investment offerings.

EQT Redwood Residential 401(k) Plan is a spin-off of the TriNet 401(k) Plan, effective January 1, 2023. During 2022, EQT Exeter Property Group, LLC ("Exeter") acquired Redwood Capital Group, LLC ("Redwood"). Redwood's eligible employees had the option to participate in the TriNet 401(k) Plan. Certain participants of the TriNet 401(k) Plan merged into the EQT Exeter Property Group, LLC 401(k) Plan in September 2022. The remainder of the Redwood employees who participated in the TriNet 401(k) Plan kept their accounts within that plan through February 20, 2023.

The participant balances for Redwood employees from TriNet 401(k) were transferred to EQT Redwood Residential 401(k) Plan during a blackout period which commenced February 21, 2023 and ended on April 11, 2023. Employer contributions merged in from the TriNet 401(k) Plan were immediately 100% vested. See Note 8 for more information.

- B. Eligibility Requirements - Each employee is eligible to participate in the Plan and receive Employer matching contributions when they have completed three months of service and attained the age of twenty-one.
- C. Participant Contributions - Eligible employees may make salary deferral contributions not to exceed 90% of their pretax annual compensation up to \$23,000 and \$22,500, which is the maximum dollar limit set by law for the years ended December 31, 2024 and 2023, respectively.

Participants who have attained age 50 before the end of the Plan year are eligible to make "catch-up contributions." For both years ended December 31, 2024 and 2023, the maximum catch-up contributions were \$7,500.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Participants who do not affirmatively opt-out of participating in the Plan are automatically enrolled with a deferral election of 3% and automatically escalate by 1% per year each July following the date the participant's deferrals were implemented, up to a maximum of 6%.

- D. Employer Contributions - The Employer will make a qualified automatic contribution arrangement ("QACA") safe harbor contribution of the participants' elective deferrals. For the years ending December 31, 2024 and 2023, the Employer matched salary deferred contributions at 100% of a participant's elective deferrals that do not exceed 1% of a participant's eligible compensation plus 50% of the participant's elective deferrals that exceed 1% of the participant's eligible compensation but do not exceed 6% of the participant's eligible compensation.
- E. Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of the Employer's contribution, plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specified participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- F. Payment of Benefits - A participant will receive a lump sum, substantially equal installments, or partial withdrawals (minimum of \$500) in amounts equal to the value of the individual's vested account upon termination of service due to death, disability, or upon attaining a Normal Retirement age or an early Retirement benefit if certain age and service requirements are met. Withdrawals from the Plan may also be granted based upon circumstances of financial hardship or attaining age 59 ½, in accordance with provisions specified in the Plan Document. Participants with vested balances that do not exceed \$5,000 will receive a lump sum payment as soon as administratively feasible following termination. Participants with vested balances that exceed \$1,000 but do not exceed \$5,000 who do not consent to a lump sum payment will automatically be rolled over into an individual retirement account. If total vested benefits exceed \$5,000, no distribution is made from the Plan without consent of the participant.
- G. Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Participants become fully (100%) vested in the Employer QACA safe harbor contribution upon the occurrence of death and total or permanent disability.

Other than as stated above, Employer QACA safe harbor contributions vest based upon the following:

A year of vesting service is a vesting service period without regard to hours of service, and is based on the plan year.

- H. Income Tax Status - The Plan is structured and follows a prototype non-standardized cash or deferred profit sharing plan, pre-approved by the IRS. The IRS issued an opinion letter dated October 6, 2020, that the prototype non-standardized profit sharing plan is acceptable with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- I. Forfeited Accounts - Any participant who terminates employment without being fully vested (100%) in their Employer contribution account forfeits their nonvested portion of the Employer contribution. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,159 and \$4,497, respectively. These accounts are used to reduce future Employer contributions or offset Plan expenses. During 2024 and 2023, the Employer contributions were reduced by \$39,932 and \$13,486 from forfeited nonvested accounts, respectively.

NOTE 2 - Summary of Significant Accounting Policies

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are a representation of the Plan's management, who is responsible for their integrity and objectivity. The accounting policies described below conform to accounting principles generally accepted in the United States of America and have been applied consistently in the preparation of the financial statements.

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued) - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Administrative expenses for maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of participant's accounts, and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events - Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 6, 2025.

NOTE 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Shares of Registered Investment Companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The shares of Registered Investment Companies held by the Plan are deemed to be actively traded.

Common/Collective Investment Trust (CCT): The Plan's investment in the MetLife Great Gray Stable Value Fund Series 25554 is valued at the NAV of the units in the CCT. NAV is readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a CCT, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 5 - Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their nonforfeitable account balance. Loan transactions are treated as transfers between the investment fund and the participant notes fund. Loan terms range from one to five years, unless for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 8.75% to 9.50%, which is based on the Prime rate plus 1%. Certain outstanding loans that were transferred in from TriNet 401(k) Plan bear interest at rates determined by the previous plan trustee, ranging from 4.17% to 7.01%. Principal and interest are paid ratably through semi-monthly and biweekly payroll deductions. Balances outstanding at December 31, 2024 and 2023 were \$31,268 and \$21,869, respectively.

NOTE 6 - Plan Termination

On September 11, 2025, the Company's trustee and Plan administrator approved a resolution to terminate the EQT Redwood Residential 401(k) Plan as of October 31, 2025. Effective September 10, 2025, all participants became fully vested in their account balances in accordance with IRC Section 411(d)(3).

The termination of the Plan represents a non-recognized subsequent event. Accordingly, the accompanying financial statements as of and for the year ended December 31, 2024 do not reflect any adjustments related to the Plan's termination. The Plan will continue normal operations until all required regulatory approvals are obtained and all assets are distributed to participants as soon as administratively feasible following the termination date.

NOTE 7 - Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - Plan Spin-off

Effective January 1, 2023, participants from the TriNet401(k) Plan who were employed by Redwood Capital Group, LLC were segregated and the plan assets were spun-off into EQT Redwood Residential 401(k) Plan. Prior to the spin-off, the plan was a multiple-employer plan which covered eligible employees of Redwood Capital Group, LLC. The transferred net assets have been recognized in the accounts of the EQT Redwood Residential 401(k) Plan as of January 1, 2023, at their balances as previously carried in accounts of the TriNet 401(k) Plan. The employer matching contributions that were transferred in from the TriNet 401(k) Plan were immediately 100% vested and participants' prior service with Redwood Capital Group, LLC was recognized in the Plan. See Note 1 for more information. A summary of the transferred net assets follows:

NOTE 9 - Related Party Transactions

Certain plan investments are administered by Reliance Trust Company and ADP Retirement Solutions. Reliance Trust Company is the trustee for the Plan and ADP Retirement Solutions provides record keeping services to the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments for financial reporting purposes. Fees paid directly by the Plan to ADP Retirement Solutions for record keeping and administrative services amounted to \$29,826 and \$20,677 for the years ended December 31, 2024 and 2023, respectively. Certain administrative functions of the Plan are performed by officers or employees of the Company, at no charge to the Plan. The Company pays directly any other fees related to the Plan's operations.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.
