- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF PLAN

The following description of LifeSpring 401(k) Plan, (formerly “Lifecare Oklahoma 401(k) Plan”, (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan established January 1, 2011 and last amended on January 1, 2023, for the benefit of the employees of the following commonly controlled group of companies (the “Companies” or “Employers”):

- Lifecare Oklahoma, Inc.
- Lifecare Oklahoma Hospice, Inc.
- Shiloh Home care, Inc. (d/b/a Lifecare Oklahoma Personal Services)
- Lifecare Holdings, LLC
- Legacy Homecare Associates, LLC
- Vahlberg Enterprises, LLC
- LifeSpring Home Care of Sayre, LLC
- Lifespring In-home Care Network, LLC
- Calvert Home Healthcare, LLC
- Cordova Bay, LLC
- Hands of Compassion Homecare, LLC
- Stewart Healthcare Enterprises, Inc.
- LifeSpring Home Care & Hospice, LLC
- Calvert Hospice, LLC
- Lifecare Hospice, LLC

The Plan is administered by LifeSpring Home Care & Hospice, LLC. Two employees have been appointed as advisors to oversee the safekeeping of the Plan.

Eligibility – All employees, except those employed under a collective bargaining agreement or those defined as a certain type of nonresident, that have completed two months of service are automatically enrolled in the plan. Employees may enter on the first day of the month coinciding with or following the date of satisfaction of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions and Forfeitures – Eligible participants may elect to make pre-tax or after-tax Roth contributions through a salary deferral agreement with the Companies up to the annual deferral limit allowed under the Internal Revenue Code of 1986. Participants are auto-enrolled at 1%, with successive increases of 1% on each anniversary date up to a maximum of 3% unless the participant opts out or changes their deferral election. The Plan allows participants age 50 and older to make catch-up contributions. Employee rollover contributions are also permitted. The employers may, but are not required to, make matching contributions in an amount the employers, in their sole discretion, may determine. The employers’ matching contributions totaled \$141,266 for the year ended December 31, 2024. All investments of contributions are participant-directed.

During 2024, employer contributions were reduced by approximately \$21,600 from forfeited non-vested accounts. Amounts totaling approximately \$12,600, net of gains and losses, were forfeited during the year

and made available to reduce future employer contributions or pay Plan expenses. The Plan had approximately \$900 and \$800 in forfeitures available for use at December 31, 2024 and 2023, respectively.

Participant Accounts – Separate accounts are maintained for each participant in the Plan. Each participant’s account is credited with the participant’s contributions, and allocations of employers matching contributions and Plan earnings, and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested balance.

Vesting – Participants are immediately 100% vested in their elective deferral contributions, rollovers, and actual earnings thereon. Participants become vested in employers matching contributions, and the earnings thereon, at retirement age, as defined in the Plan, or in the event of death or disability.

Prior to participants’ retirement age, employers matching contributions become vested as follows:

Investment Options – Upon enrollment in the Plan, participants may direct contributions into any of the applicable investment options available to Plan participants.

Payment of Benefits – Upon termination of employment, a participant may elect to have the vested benefit distributed as soon as administratively feasible. Vested balances under \$7,000 may only be distributed as a single lump-sum payment. For balances exceeding \$7,000, a participant may elect to receive a distribution as a single lump sum payment or partial withdrawal. Rollover of distributions to an IRA or another employer plan is permitted. Withdrawals other than for termination are permitted under certain circumstances.

Administrative Expenses – The Plan permits the payment of Plan expenses to be made from Plan assets. The expenses will generally be allocated among the accounts of all participants in the Plan either proportionally based on account balance values or as an equal dollar amount based on the number of Plan participants. Certain other expenses that are directly attributable to a specific participant will be allocated fully to that individual’s account.

Plan Termination – Although it has not expressed any intent to do so, the Plan sponsor has the right to terminate the Plan subject to the provisions of ERISA.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are presented on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition – The Plan’s investments, except for fully benefit responsive contracts, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan’s valuation policies utilizing information provided by investment advisors, trustees, and other third-parties.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date, and interest income is recorded on the accrual basis. Net appreciation/depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Use of Estimates – The preparation of financial statements in conformity with GAAP requires the Plan’s management to make estimates and assumptions that affect the reported amounts of Plan assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits – Benefits are recorded when paid.

Subsequent Events – The plan administrator has evaluated subsequent events through October 14, 2025 the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The Plan measures fair value in accordance with accounting standards that establishes a fair value hierarchy based on the observability of inputs used to measure fair value. These inputs are summarized in the three broad levels listed below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value of measurement.

In many cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The fair values of registered investment companies are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs). Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – TAX STATUS

The Plan operates under an adoption agreement in connection with a non-standardized prototype plan document sponsored by ADP Retirement Services (“ADP”) which has received a favorable determination letter dated October 6, 2020 from the Internal Revenue Service which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax exempt, as of the financial statement date. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 5 – INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFP 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and investments, at contract value, as shown in the statements of net assets available for benefits as of December 31, 2024, and 2023.
- Net change in fair value of investments, and interest, dividends, and capital gains as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Line 4i – Schedule of Assets (Held at End of Year), as of December 31, 2024.

NOTE 6 – RISKS AND UNCERTANTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment

securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7 – REALTED PARTIES AND PARTIES-IN-INTEREST TRANSACTIONS

Fees paid by the Plan to ADP for administrative services and record keeping totaled \$74,044 for the year ended December 31, 2024.

An advisor with Wealth Management Group; LLC (“WMG”), provides investment services as a registered representative of FSC Securities Corporation. These investment advisory fees totaled \$24,085 for the year ended December 31, 2024. Certain other investment management fees were netted with investment income on the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 8 – OPERATIONAL ERRORS AND CORRECTIVE ACTIONS

During the year ended December 31, 2024, the Plan identified certain operational errors related to participant deferrals:

- Certain employees who became eligible for participation in the Plan were not automatically enrolled at the earliest enrollment date as required by the Plan document. The Plan Sponsor is reviewing impacted participants and determining the corrective actions in accordance with IRS correction principles, including making qualified nonelective contributions (‘QNEC’) to the affected participants’ accounts to compensate for missed deferrals and related employer matching contributions, as well as any applicable earnings.
- Certain employees who transferred between covered employers within the controlled group did not have their existing deferral elections carried over to the new employer’s payroll system, resulting in missed elective deferrals. The Plan Sponsor is determining any corrective actions required for affected participants, including making QNEC to the affected participants’ accounts for the missed deferral amounts and related employer matching contributions, including applicable earnings.

The Plan sponsor has determined that any corrective contributions will be immaterial to the Plan as a whole. The Plan Sponsor has implemented additional controls to help ensure compliance with the Plan’s automatic enrollment and deferral election provisions in the future.
