NOTE A - DESCRIPTION OF PLAN

The following description of the Art Guild, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement and/or Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code covering full and part-time employees of Art Guild, Inc. (the Company) who have reached the age of twenty-one and have 60 days of service. Non-resident aliens and employees subject to collective bargaining agreements are not eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 90% of annual compensation, as defined in the Plan, up to the maximum allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Company may elect to make a discretionary matching contribution. There were no matching contributions made for the years ended December 31, 2024 and 2023. All contributions are invested as directed by the participant. The Plan also allows employer profit sharing contributions. There was no profit sharing contribution for the years ended December 31, 2024 and 2023.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds as investment options for participants. Participants should refer to each funds prospectus for a more complete description of the risks associated with each fund.

Vesting

Participants are immediately vested in their voluntary contributions. Vesting in the Company's matching contributions plus earnings thereon is based on years of continuous service, as follows:

2 years, but less than 3 years	20%
3 years or more	100%

Participants Loan Receivable

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 5.25% to 9.50% which are commensurate with local prevailing rates as determined by the Plan Administrator at the time the loans are made. Principal and interest are repaid through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant shall receive all amounts credited to such participant's account. Benefit payments to participants are recorded when paid. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

The normal retirement age under this Plan is 65.

Forfeited Accounts

There were no unallocated forfeitures at December 31, 2024 and 2023, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with generally accepted accounting principles in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Plan's investments in mutual funds are stated at fair value. Shares of mutual funds are valued at quoted market price. Net appreciation or depreciation of investments is reported on the statements of changes in net assets available for benefits and consists of realized gains and losses and the unrealized appreciation or depreciation of these investments. All underlying investment options are valued daily. This daily price is considered the selling price for transfers and withdrawals which is calculation each day the principal market is open and re-available to any participant in the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Participants Loan Receivable

Participants loan receivable are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Operating Expenses

Certain expenses to maintain the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Date of Management's Review

Management has evaluated subsequent events through September 18, 2025, the date which the financial statements were available to be issued.

NOTE C - RELATED PARTY TRANSACTIONS

The Plan issues loans to participants, which are secured by the balances in the participants' accounts. Certain operating expenses are paid by the Plan sponsor on behalf of the Plan.

NOTE D - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

NOTE E - RELIANCE ON CUSTODIAN'S REPORT

The Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, no auditing procedures are required to be performed with respect to the investment information certified by the custodians of the Plan, Reliance Trust Company, other than comparing such information to that contained in the financial statements and the supplemental schedule.

NOTE F - FAIR VALUE MEASUREMENTS

The Plan utilizes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds

Mutual funds have quoted prices for identical assets in active markets; therefore, the investments are measured at fair value using these readily available level 1 input.

The method described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE G - RISKS AND UNCERTAINTIES

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H - TAX STATUS

The Plan participates in a non-standardized pre-approved profit sharing/Cash or Deferred Arrangement plan sponsored by ADP. The Internal Revenue Service has provided a favorable opinion letter to the Company for the prototype plan. Although the Plan has been amended since receiving the opinion letter on October 6, 2020, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor and Internal Revenue Service. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.
