Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of TaskUs, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Opinion



NOTE 1 PLAN DESCRIPTION

The TaskUs, Inc. 401(k) Profit Sharing Plan and Trust (Plan) is administered by TaskUs, Inc. (Company). The following description of the Plan is provided for general information purposes only. More complete information is provided in the Summary Plan Description and Plan Document, which are available from the Company.

General

The Plan is a voluntary, participant directed, defined contribution savings plan that became effective April 4, 2011. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Employees are eligible to participate in the Plan, except for union employees. The Plan has a minimum age requirement of 18, and no service requirement. Employees are eligible to begin contributions on the first day of the month following the date the requirement is met.

Contributions

Participants may make voluntary pretax contributions and Roth 401(k) contributions to the Plan up to 90% of eligible compensation, up to the applicable annual Internal Revenue Service (IRS) dollar limit. The Plan accepts rollover contributions from other qualified retirement plans in accordance with ERISA. The Plan accepts Roth rollover contributions that are properly segregated in the participant's accounts as Roth contributions. Participants who have attained age 50 before the end of the Plan Year are eligible to make catch-up contributions in accordance with, and subject to, IRS limitations.

The Plan includes an employer-matching provision, as well as a discretionary profit-sharing contribution. Employees are immediately eligible for the matching provision and must have obtained at least one year of service and be active at any time during the year in order to be eligible for the discretionary profit-sharing contribution. Eligible employees receive an employer-match of 100% of employee contributions up to 3% of the participant's eligible compensation, plus 50% of the next 2% of the participant's eligible compensation. The Plan's discretionary profit sharing is allocated to employees based on total compensation among the participants eligible to share. The total discretionary profit-sharing contribution cannot exceed 4% of compensation in a Plan year. For the years ended December 31, 2024 and 2023, total employer contributions into the Plan were \$1,521,744 and \$2,373,132, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of: (a) the Company's discretionary matching and profit-sharing contributions; (b) Plan earnings, gains or losses; and (c) charged with an allocation of administrative expenses. Allocations are based on a participant's compensation or account balances, as defined in the Plan Document.

NOTE 1 PLAN DESCRIPTION (CONTINUED)

Vesting

Participants are immediately 100% vested in their voluntary employee contributions, rollover contributions, qualified nonelective contributions, plus earnings thereon. Vesting of the Company's matching contributions and nonelective profit sharing contributions are based on years of vesting service.

For the employer match and discretionary profit-sharing contributions, participants with less than two years of credited service are 0% vested. Vesting increases 25% per annum from year two through year five. For both contributions, participants become 100% vested upon attainment of age 65, or upon death or disability of the participant.

Investment Options

Investments with the trustee may be made in 39 fund vehicles and participants may elect to have their contributions invested in any of these funds. A separate account is maintained for each participant, and interest and dividends earned by each fund are reinvested in that fund. Participants may change their investment options daily.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributes any excess contributions back to the applicable participants in the following year. There were \$0, and \$55 in excess contributions payable as of December 31, 2024 and 2023, respectively.

Forfeitures and Fee Sharing

Forfeitures are used to pay administrative expenses and, if any, the remaining amount will be used to offset employer contributions. Fee sharing revenue is generated based on participant investment balances, investment selections, and are credited by fund family and share class at varying rates. These balances are maintained in a money market fund to be utilized annually by the Plan.

The balance in the forfeiture and fee sharing account at December 31, 2024 and 2023, was \$59,402 and \$41,025, respectively. The Plan utilized \$4,434 and \$1,589 during the years ended December 31, 2024 and 2023, respectively, to reduce employer contributions.

In-Service Withdrawals

Participants attaining the age of 59½ may request a withdrawal of all or part of the vested portion of their account.

Retirement

The Plan's normal retirement age is 65. There is no early retirement provision under the Plan.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of one-half of their vested account balances or \$50,000 (reduced by the highest value of any outstanding loan balance in the preceding 12 months), whichever is less. Loans bear interest at rates that are commensurate with local prevailing rates being charged by institutions that are in the business of lending money for similar types of commercial loans. The interest rate will remain fixed throughout the duration of the loan. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Terms depend on the type of note; a general note must be repaid within five years, while notes used to acquire a primary residence must be repaid within a 30-year period. Notes must be repaid through payroll deductions and are secured by the balances in the participants' accounts. Participants may be granted up to five loans during a 12-month period. Only two loans per participant can be outstanding at a time, and only one may be used to acquire a primary residence. At December 31, 2024 and 2023, notes receivable from participants amounted to \$687,940 and \$570,612, respectively.

Payment of Benefits

After retirement, death, or disability, participants are entitled to receive a lump sum distribution, monthly installments, annual installments, or a variety of annuity options. Participants have the option to leave amounts in the Plan up to the mandatory distribution date, which is defined as the later of April 1st following the calendar year of attaining the age of 72, or age at retirement. Upon termination, vested benefits can be rolled over to another qualified plan or an individual retirement account (IRA) or distributed in a lump sum payment or partial withdrawals. If the vested balance is \$5,000 or less, the participant will receive a lump sum distribution without consent.

Hardship withdrawals are subject to approval by the Plan Administrator and also subject to income tax withholding and penalty.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses and Participant Transaction Fees

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Participant level fees, such as fees related to the administration of notes receivable from participants, investment fees, and certain Plan administration fees not covered by the Company are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation of fair value of investments.

Mutual Fund Fees

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. Allowable fees under Section 12b-1 of the Investment Company Act of 1940 are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity and, thus, not separately identifiable as an expense.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Subsequent Events

The Plan has evaluated its subsequent events and transactions occurring after December 31, 2024 through October 13, 2025, the date that the financial statements were available to be issued.

NOTE 3 INVESTMENTS CERTIFIED BY THE PLAN TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

NOTE 4 FAIR VALUE MEASUREMENTS

Fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1 input).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

Any transactions involving TaskUs, Inc., the Plan Sponsor, Automated Data Processing, Inc., the Plan Recordkeeper, Reliant Trust Company, the Plan trustee, the accountant involved with the Plan, and the third-party administrator, are therefore considered party-in-interest transactions. Notes receivable from Plan participants also qualify as party-in-interest transactions.

The Plan Sponsor paid certain administrative expenses on behalf of the Plan during the year. Additionally, certain administrative functions are performed by employees of the Plan Sponsor who do not receive compensation from the Plan for such functions.

NOTE 6 PLAN TERMINATION

Although the Company has not expressed intent to terminate the Plan, it may do so at any time under the provisions of ERISA. Upon termination of the Plan, participants will become 100% vested and entitled to their full account balance, including all Company contributions, as of the termination date.

NOTE 7 TAX STATUS

The prototype Plan Sponsor obtained an opinion letter from the Internal Revenue Service on October 6, 2020, in which the IRS stated that the prototype Plan Document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended; however, the Plan Administrator believes the Plan is being designed and operated in compliance with the Plan Document and applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any periods in progress.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. To the extent that a participant directs that their contributions be invested through the self-directed brokerage account option, the participant solely determines the extent to which such amounts will be diversified, if at all.
