## Notes to Financial Statements

---

### Note 1: Description of Plan

The following description of the Braden Health, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan sponsored by Braden Health, Inc. (the "Employer"), commonly known as a Code Section 401(k) savings plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Delaware Charter Guarantee and Trust Company d/b/a Principal Life Insurance Company ("Principal") is the custodian of the Plan.

Upon enrollment in the Plan, a participant may direct his or her account balance among various investments offered by the Plan.

#### Eligibility

The Plan is available to employees who are at least 18 years old. Students and nonresident aliens are not eligible to participate in the Plan.

#### Contributions

Participants are permitted to make salary contributions up to the current Internal Revenue Service (IRS) deferral limits. Participants who are over the age of 50 may make additional pretax "catch up" contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan has an automatic enrollment feature which provides that newly eligible employees who do not affirmatively elect either to participate in the Plan, or decline participation in the Plan, will automatically be enrolled in the Plan, and will defer 3% of their eligible compensation into the Plan.

The Plan allows for an employer matching contribution and profit-sharing contribution on an elective basis. For the year ended December 31, 2024, the employer did not make any elective employer contributions to the Plan.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's matching contributions, and allocations of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1: Description of Plan (Continued)

#### Vesting

Participants are vested immediately in their contributions into the Plan. Vesting in the Organization's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after two years of credited service.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, or up to ten years for the purchase of a primary residence. The notes are secured by the balance in the participant's accounts and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Interest rates on existing loans at December 31, 2024, were 5.25% - 10.50%. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum or in installments if the account balance is greater than \$5,000. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon disability or attaining age 59 1/2.

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Employer before becoming 100% vested in the Employer's contributions. Forfeited balances of terminated participants nonvested accounts are used to reduce future Employer contributions or pay Plan expenses. There were no forfeitures during the year ended December 31, 2024.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan values its investments at fair value for financial reporting purposes (except for the fully benefit-responsive investment contract ("FBRIC"), which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Changes in fair value of investments are reflected in the statement of changes in net assets available for benefits in the year in which such changes occur.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Expenses can be paid by either the Plan or the Employer. Expenses paid by the Employer are excluded from these financial statements. Administrative expenses paid by the Plan include record keeping and custodian fees. Certain fees incurred by the Plan are included in the net change in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

*Mutual funds held in pooled separate accounts and unit investment trusts:* Fair value is estimated using the net asset value (NAV) per unit by the issuer of the pooled separate accounts and unit investment trusts; however, because the majority of the underlying investments are invested in mutual funds which are publicly traded, fair value is based on the fair value of the underlying investments held by the pooled separate accounts and unit investment trusts. The pooled separate accounts and unit investment trusts trade continuously and there are no funding commitments and redemption notice periods.

In accordance with Subtopic 820-10, certain investments that were measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy. Since all investments at December 31, 2024 and 2023 are measured at NAV as described above, there is no fair value hierarchy table presented related to the years included in the accompanying financial statements.

### **Note 4: Fully Benefit-Responsive Investment Contracts (FBRICs)**

The Plan invests in a FBRIC with the Delaware Charter Guarantee and Trust Company d/b/a Principal Life Insurance Company ("Principal") in the form of a guaranteed investment contract ("GIC") that invests in traditional investment contracts. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%. Such interest rates are reviewed periodically for resetting. The crediting interest rate was 1.55% at December 31, 2024.

Certain events limit the Plan's ability to transact at contract value with Lincoln including Plan termination and other events as specified in the GIC. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GIC does not permit Principal to terminate the agreement prior to the scheduled maturity date.

### **Note 5: Information Prepared and Certified by the Trustee**

Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024, and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified by Principal, the custodian, as complete and accurate.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.

### **Note 7: Tax Status**

The base documents for the Plan utilized The Retirement Advantage 401(k)/Profit Sharing Non-Standardized Plan design and documents which received a favorable determination letter in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 9: Party-in-Interest Transactions**

Plan investments are managed by the custodian; therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.
