12/31/2024**

In July 2023, a new separate trust and benefit plan was established for the participants of the GAWDA Group Insurance Trust Fund. Contributions to this plan were ceased as of June 30, 2023 and participation ceased as of June 30, 2023. The plan is intended to be terminated as of December 2025.

There were no new contributions to the plan for 2024, and all plan income was sourced to investments that continued to be held as of 12/31/2024. However, because the plan is a Multiple Employer Welfare Arrangement, a schedule of contributing employers will continue to be required to be attached to the Small Plan Form 5500.

For 2024, the Schedule will list the Employers participating in the plan as of the plan freeze date, and an indication of 0 contributions for 2024 with a note regarding the reason for 0 contributions.
