Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Phillips Farms, LLC 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Phillips Farms, LLC 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter—Supplemental Schedules Required by ERISA**

The supplemental schedule of assets held for investment purposes at end of year as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1. Plan Description**

The following description of Phillips Farms, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General:

The Plan is a defined contribution plan covering all employees of Phillips Farms, LLC (the “Company”) who are 21 years of age or older and have completed 3 months of service. The Plan was established on January 1, 2007 and most recently restated for the Cycle 3 Restatement effective June 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan was amended effective January 1, 2020 to change the eligibility requirement from one year of service to 3 months of service. In addition, the safe harbor matching contribution was amended where the match will be applied each payroll period and a “true-up” contribution will not be made.

Contributions:

Eligible employees of the Company may elect to contribute up to the maximum limit established annually by the Internal Revenue Service. Effective January 1, 2015, the Company makes safe harbor matching contributions equal to 100% of an employee’s salary deferrals that do not exceed 3% of their compensation, plus 50% of the employee’s salary deferral between 3% and 5% of the employee’s compensation. In addition, the Company may elect discretionary profit sharing and employer matching contributions. Participants direct the investment of the contributions into various investment options offered by the Plan.

Vesting:

Participants are immediately vested in their elective deferral contributions and the Company’s safe harbor contributions plus actual earnings thereon. Discretionary profit sharing and employer matching contributions are vested at 20 percent each year starting at two years of credited service. A participant is 100 percent vested after six years of credited service, after reaching normal retirement age, or upon death or total and permanent disability.

Participant Accounts:

The recordkeeper of the plan maintains an account for each participant. Each participant account is credited with the participant’s contributions and allocations of (a) the Company’s contribution and (b) Plan earnings, and charged with administrative expenses, not paid by the Company. Allocations are based on participant compensation or account balances, as defined. The earnings are based on the earnings of the investments selected by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### NOTES TO FINANCIAL STATEMENTS

#### Note 1. Plan Description (Cont.)

##### Investment Options:

Upon enrollment in the Plan, a participant may direct contributions into numerous investment choices offered by ADP Retirement Services (“ADP”). Participants may change their investment options through written request through the Company or directly with ADP via the internet.

##### Payment of Benefits:

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or various options as defined in the Plan. Similar options are available upon termination of employment. The Plan provides a lump sum distribution on a terminated participant’s account with a non-forfeitable balance of less than \$5,000. The terminated participant may provide rollover instructions to an IRA or to another qualified plan. The Plan permits a financial hardship distribution to an active participant in accordance with the Plan’s hardship policies. The Plan permits an in-service distribution to a participant in accordance with the Plan’s in-service policies.

##### Forfeited Account:

Forfeited non-vested accounts totaled \$22 as of December 31, 2024 and 2023. Amounts accumulated in the forfeiture account will be used to reduce future employer contributions and Plan administrative fees. Forfeitures of \$1 and \$0 were used to reduce employer contributions during the years ended December 31, 2024 and 2023, respectively.

#### Note 2. Summary of Significant Accounting Policies

##### Basis of Accounting:

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

##### Investment Valuation and Income Recognition:

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation in fair value of investments presented on the statement of changes in net assets available for benefits includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

#### Note 2. Summary of Significant Accounting Policies (Cont.)

##### Benefits:

Benefits are recorded when paid.

##### Administrative Expenses:

Plan administrative expenses and the annual audit and tax return preparation fees are paid by the Company. Expenses related to specific participant transactions are charged to the respective participant's account.

##### Use of Estimates:

The preparation of financial statements is in conformity with accounting principles generally accepted in the United States of America. Those standards require management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

##### Date of Management's Review of Subsequent Events:

The Plan has evaluated subsequent events through October 6, 2025, the date on which the financial statements were available to be issued. There were no material modifications to the Plan or plan provisions.

#### Note 3. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 measurements consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), and Level 3 measurements are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

##### Level 1 Fair Value Measurements:

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

**Note 5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions set forth in ERISA and the Internal Revenue Code. Upon termination of the Plan, the total net assets of the Plan are to be distributed to the participants in proportion to their account balances.

**Note 6. Related Party and Party-in-Interest Transactions**

During the December 31, 2024 and 2023 plan years, the trustee of the plan provided participant-level services as defined by the Plan and, therefore, these transactions qualify as party-in-interest. These transactions are covered by an exemption from the “prohibited transaction” provisions of ERISA and the Internal Revenue Code.

**Note 7. Income Tax Status and Plan Amendments**

The Plan obtained its latest advisory letter on October 6, 2020, in which the Internal Revenue Service has determined and informed the sponsor of the prototype plan that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code. Plan management and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code; and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan’s tax returns remain open for three to four years for income tax examination.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
