Notes to Financial Statements

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of Johnstone Supply 401(k) Profit Sharing Plan (the "Plan") have been prepared on the accrual basis.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for discussion of fair value measurements.

The Plan presents in the Statement of Changes in Net Assets Available for Benefits the net appreciation or depreciation in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments bought and sold as well as held during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Benefit Payments

Benefit payments are recorded when paid.

Related Party Transactions

Certain employees of the Company provide the Plan with certain accounting and administrative services for which no fees are charged.

Expenses

Certain expenses and costs of the Plan were paid by the Company and, accordingly, are not reflected in the Plan's financial statements. Certain investment related expenses are included in the net appreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles (GAAP) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Event Evaluation

Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

Notes to Financial Statements (Continued)

NOTE 2 DESCRIPTION OF PLAN

The following description of the Johnstone Supply 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Controls Center, Inc. DBA Johnstone Supply (the "Company"). Those employees over the age of 18 are eligible for plan participation. Eligible employees enter the Plan the first day of the plan quarter coinciding with or following their eligibility date. Effective January 1, 2019, all employees hired after January 1, 2019 are automatically enrolled into the plan unless specifically opting out. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established by the Company effective January 1, 1984, and subsequently amended and restated in its entirety effective March 1, 2021.

Contributions

Each year, participants may elect to contribute a percentage of their pretax or post-tax annual compensation, as defined in the Plan. These contributions are not to exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986, as amended (\$23,000 at December 31, 2024). The Plan permits catch-up elective deferrals for participants over 50 years of age subject to Internal Revenue Code limitations.

The Company makes matching contributions under a safe harbor match to the Plan each year. The safe harbor match is 100% of the first 3.50% of compensation. The Company made matching contributions of \$515,086 for 2024.

The Plan allows for the Company to make a discretionary matching contribution as well as a profit-sharing contribution based on a formula determined by the Company. The Company did not make a discretionary matching contribution or a profit-sharing contribution for 2024.

Rollover Contributions

Participants may roll over their taxable portion of funds previously held for their account in another qualified retirement plan to the Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements (Continued)

NOTE 2 DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants become immediately vested at the time of participation in the Plan in their contributions as well as the safe harbor employer matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching contributions and profit sharing contributions, plus actual earnings thereon, is based on years of continuous service. Participants become fully vested after two years of service.

Forfeitures can be used by the plan to reduce Plan expenses or matching contributions. The balance of unallocated forfeitures was \$709 and \$597 at December 31, 2024 and 2023, respectively. During 2024, the Company used \$10,072 of forfeitures to offset matching contributions.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

In-service distributions are permissible from the Plan for participants that have attained the age of 59 1/2.

In conditions of "financial hardship", a participant may apply to the Plan administrator for approval to withdraw that portion of his or her 401(k) retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

NOTE 3 FAIR VALUE MEASUREMENTS

GAAP provisions for Fair Value Measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP provisions for accounting for Fair Value Measurements are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from our corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must also be observable for substantially the full term of the asset or liability.

NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measure at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common/collective trusts: Value based on the NAV of units of a collective trust published by the custodian.

Money market fund: Valued based on the net asset value of units of a money market fund as published by the trustee.

NOTE 4 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, all amounts credited to participants' accounts will become fully vested and non-forfeitable.

NOTE 5 TAX STATUS

The Plan has adopted a volume submitter profit sharing plan, which received an opinion from the IRS dated October 6, 2020 which states that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
