Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of EQT Exeter Property Group, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

NOTE 1 - Description of Plan

The following description of EQT Exeter Property Group, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document, as amended, for a more complete description of the Plan's provisions.

- A. General - The Plan is a defined contribution plan with an Internal Revenue Code ("IRC") Sec 401(k) provision covering all employees of Exeter Property Group, LLC (the "Company" or "Employer") who meet the eligibility requirements of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Directors is responsible for oversight of the Plan including monitoring of investment performance and determining appropriate investment offerings.

Effective March 24, 2025, the Company changed its legal name from Exeter Property Group, LLC to EQT Real Estate, LLC and thus the Plan was amended May 1, 2025 to change the name from EQT Exeter Property Group, LLC 401(k) Plan to EQT Real Estate, LLC 401(k) Plan.

- B. Eligibility Requirements - Each employee who is not part-time, temporary, an intern, or seasonal employee is eligible to participate in the Plan and receive employer matching contributions when they have completed one month of service and attained the age of twenty-one.
- C. Participant Contributions - Eligible employees may make salary deferral contributions not to exceed 90% of their pretax annual eligible compensation up to \$23,000 and \$22,500, which is the maximum dollar limit set by law for the years ended December 31, 2024 and 2023, respectively.

Participants who have attained age 50 before the end of the Plan year are eligible to make "catch-up contributions." For both years ended December 31, 2024 and 2023, the maximum catch-up contributions were \$7,500.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

- D. Employer Contributions - The Employer will make a safe harbor matching contribution of the participants' elective deferrals. For the years ending December 31, 2024 and 2023, the Employer matched salary deferred contributions at a rate of 100% of the first 3% of the employee's deferral and 50% of the remaining deferral up to 5%. Additional discretionary contributions may be contributed at the option of the Board of Directors. There were no additional discretionary contributions made for the years ended December 31, 2024 or 2023.
- E. Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of the Employer's contribution, plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specified participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- F. Payment of Benefits - A participant will receive a lump sum or substantially equal installments in amounts equal to the value of the individual's account upon termination of service due to death, disability, or upon attaining a Normal Retirement age or an early Retirement benefit if certain age and service requirements are met. Participants with vested balances that do not exceed \$5,000 will receive a lump sum payment as soon as administratively feasible following termination. Withdrawals from the Plan may also be granted based upon circumstances of financial hardship or attaining age 59 ½, in accordance with provisions specified in the Plan. Participants with vested balances that exceed \$1,000 but do not exceed \$5,000 who do not consent to a lump sum payment will automatically be rolled over into an individual retirement account. If total vested benefits exceed \$5,000, no distribution is made from the Plan without consent of the participant.
- G. Vesting - Participants are immediately vested in their contributions and employer safe harbor contributions plus actual earnings thereon. Participants become fully (100%) vested in the employer discretionary contribution upon the occurrence of death and total or permanent disability.

Other than as stated above, employer discretionary contributions vest based upon the following:

A year of vesting service is a vesting service period without regard to hours of service, and is based on the plan year.

- H. Income Tax Status - The Plan is structured and follows a prototype non-standardized cash or deferred profit sharing plan, pre-approved by the IRS. The IRS issued an opinion letter dated October 6, 2020, that the prototype non-standardized profit sharing plan is acceptable with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- I. Forfeited Accounts - Any participant who terminates employment without being fully vested (100%) in their employer contribution account forfeits their nonvested portion of the employer contribution. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10. These accounts are used to reduce future employer contributions or offset Plan expenses. During 2024 and 2023, the employer contributions were reduced by \$0 and \$451 from forfeited nonvested accounts, respectively.

NOTE 2 - Summary of Significant Accounting Policies

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are a representation of the Plan's management, who is responsible for their integrity and objectivity. The accounting policies described below conform to accounting principles generally accepted in the United States of America and have been applied consistently in the preparation of the financial statements.

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Administrative expenses for maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of participant's accounts, and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in net appreciation of fair value of investments.

ERISA Budget (Revenue-Sharing) Account - Certain investment options pay revenue-sharing or servicing fees to the recordkeeper. Under the Plan's service agreement, amounts in excess of negotiated fees are deposited into an unallocated ERISA Budget Account within the Plan and are used to pay reasonable administrative expenses in accordance with ERISA and DOL guidance. Any remaining balance may be allocated to participants or retained to offset future administrative expenses. During the years ended December 31, 2024 and 2023, revenue-sharing of \$148,026 and \$111,607, respectively, were deposited to the ERISA Budget Account and \$120,915 and \$89,475, respectively, of plan administrative expenses were paid from the account (See Note 8).

Subsequent Events - Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 6, 2025.

NOTE 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Shares of Registered Investment Companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The shares of Registered Investment Companies held by the Plan are deemed to be actively traded.

Common/Collective Trust (CCT): The Plan’s investment in the MetLife Great Gray Stable Value Fund Series 25554 is valued at the NAV of the units in the CCT. NAV is readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a CCT, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The common collective investment trust in which the Plan participates is maintained by Reliance Trust Company, the trustee of the Plan. Interests in the trust is represented by units, each of which represents an undivided pro-rata share of the net assets of a fund. Although similar in nature to mutual funds, the trust is not traded on an active market. Participant transactions (purchases and sales) may occur daily, without requiring notice or restrictions of redemption. The Plan has no unfunded commitments as of December 31, 2024 and 2023.

NOTE 5 - Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowances for credit losses have been recorded as of December 31, 2024 or 2023. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their nonforfeitable account balance. Loan transactions are treated as transfers between the investment fund and the participant notes fund. Loan terms range from one to five years, unless for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which is based on the Prime rate plus 1%. Principal and interest are paid ratably through bimonthly payroll deductions. Balances outstanding at December 31, 2024 and 2023 were \$392,480 and \$398,632, respectively.

NOTE 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Employer contributions.

NOTE 7 - Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - Related Party Transactions

Certain plan investments are administered by Reliance Trust Company and ADP Retirement Solutions. Reliance Trust Company is the trustee for the Plan and ADP Retirement Solutions provides record keeping services to the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than direct payment. Fees paid directly by the Plan to ADP Retirement Solutions for record keeping and administrative services amounted to \$28,606 and \$26,753 for the years ended December 31, 2024 and 2023, respectively. Fees paid directly by the Plan to investment advisors amounted to \$120,915 and \$89,475 for the years ended December 31, 2024 and 2023, respectively, and were paid from the ERISA Budget Account (See Note 2). Certain administrative functions of the Plan are performed by officers or employees of the Company, at no charge to the Plan. The Company pays directly any other fees related to the Plan's operations.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.
