To the Participants and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of College Internship Program, Inc. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of College Internship Program, Inc. Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section –

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of College Internship Program, Inc. Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about College Internship Program, Inc. 1. DESCRIPTION OF PLAN:

The following description of the College Internship Program, Inc. Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Summary Plan Description or Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on February 1, 1988, covering substantially all employees of College Internship Program, Inc. who have elected to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Administration of the Plan

College Internship Program, Inc. (the "Company") is the plan sponsor and is responsible for the monitoring and administration of the Plan. ADP Retirement Services, the Plan's third-party administrator, is responsible for the general administration of the Plan and acts as the trustee for the Plan.

Eligibility provisions

Full-time, or part-time employees who are over the age of 21 are eligible to enroll in the Plan, on the first day of the month coinciding with or next following the date of hire. There is no eligibility service requirement. The Company has two annual enrollment dates, January 1 and July 1. Effective January 1, 2024, the Plan has an auto enrollment feature at 3% deferral with no future escalations.

Participants' accounts

Each participant's account is credited with the participant's voluntary contributions and the Company's safe harbor matching and Plan earnings (losses) and reduced by any expenses, if applicable. Allocations are based on participant account balances, participant earnings, compensation or transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Contributions

Effective January 1, 2024, the Plan was amended for an auto enrollment feature at 3% deferral with no future escalations. The Plan provides for eligible employees to contribute up to the maximum limit allowable under the Internal Revenue Code. Pre-tax and ROTH deferrals are limited to \$23,000 and \$22,500 for 2024 and 2023, respectively. For participants over age 50 additional catch-up deferrals are allowed. Participants direct their contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

The Plan provides for an employer safe harbor matching contribution equal to 100% of the first 3% and 50% of the next 2% for a maximum of 4%. Amounts allocated to participant accounts are determined by the participant's compensation as a percentage of total participant's compensation. The Plan provides for a discretionary profit-sharing contribution and employer match as determined by the Company on an annual basis. Amounts allocated to participant accounts are determined by the participant's compensation as a percentage of total participant's compensation. No discretionary profit sharing contributions or additional employer matches were made for the years ended December 31, 2024 and 2023.

1. DESCRIPTION OF PLAN: (CONTINUED)

Notes receivable from participants

Participants may borrow against their vested account balances. Only one loan may be outstanding at any point in time. The minimum borrowing amount is \$1,000 and may not exceed the lesser of \$50,000 or fifty percent of the participant's vested benefits. The interest rate on the outstanding loan corresponds to prime rate plus 1% and ranged from 8.75% to 9.50%. Loans are for a period not to exceed five years (except longer terms are available for loans issued for the purchase of a principal residence). Principal and interest is paid through payroll deductions. If an employee is no longer with the Company, the outstanding loan is immediately due and payable.

Payment of benefits

Participants' normal retirement, disability or death benefits are determined by the value of their accounts as of the most recent valuation date, plus any participant contributions made since such valuation date. Participants in the event of retirement, disability, or their beneficiary in the event of death, will receive their benefits in a lump-sum payment.

Hardship distributions are allowed if the participant satisfies certain conditions. Additionally, on attainment of the normal retirement age of 59½, a participant may elect to withdraw funds from the Plan.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Vesting

Participants are immediately vested in their voluntary contributions and the employer safe harbor matching contributions plus actual earnings thereon.

Vesting in discretionary profit-sharing contributions is based on years of credited service. A participant must work 1,000 hours during each Plan year to earn a year of vesting service. A participant becomes 100% vested in the event retiring at a normal retirement age, disability, death, the Plan is terminated or contributions to the Plan are discontinued, or after three years of credited service in the following increments:

Forfeited accounts

A forfeiture is a loss of all or a portion of employer discretionary profit sharing contributions and earnings thereon allocated to an account of a participant separating from service before becoming fully vested. Forfeitures of terminated participants' nonvested accounts will be allocated to the Company's matching contribution for each succeeding Plan year, if necessary, until such forfeitures have been exhausted. At December 31, 2024 and 2023, there were no forfeited nonvested accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 (the “Act”) was signed into law on December 29, 2022, to increase retirement savings, improve retirement rules, and lower employer costs of setting up a retirement plan. Plan amendments required by the Act generally need not to be made until the end of the first plan year beginning on or after January 1, 2026, however, plans must operate in accordance with effective date of each new provision.

Major provisions of this Act that may effect the Plan include:

- Effective January 1, 2024, the limit for mandatory cash outs was raised from \$5,000 to \$7,000.
- Effective January 1, 2026, catch up contributions for any participants over age 50 who earn over \$145,000 are now required to be made on a Roth basis.

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States if America.

Investment valuation and income recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The Plan administrator determines the Plan’s valuation policies utilizing information provided by the investment advisors, custodians and the insurance company. See Note 4 for further discussion of fair value measurements. All investments are participant directed.

In accordance with the policy of stating investments at fair value, the statements of changes in net assets available for benefits includes the net appreciation in the fair value of investments, which consists of the realized gains or losses and the unrealized appreciation on those investments.

Purchases and sales of securities are reflected on the trade date and gains and losses are determined on the basis of identified cost. Interest income is recorded as earned on the accrual basis and dividends are recorded on the ex-dividend date.

Earnings on investments, with the exception of participant loans, are allocated on a pro rata basis to individual participant accounts based on the type of investment and the ratio of each participant’s individual account balance to the aggregate of participant account balances. The portion of interest included in each loan payment made by a participant is recognized as interest income in the participant’s individual account.

Benefit payments

Benefit payments to participants are recorded when paid.

Plan expenses

Certain plan expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefits paid to participants or their beneficiaries are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES: (CONTINUED)

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America and the Department of Labor's ("DOL") rules and regulations for reporting and disclosure under the Employee Retirement Income Security Act of 1974 requires the Plan Administrator to make estimates and assumptions that affect the reported amount of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

3. INFORMATION CERTIFIED BY THE TRUSTEE:

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under Employee Retirement Income Security Act of 1974. Accordingly, Reliance Trust Company (Reliance), the trustee of the Plan, certified to the Plan administrator the fair value and physical custody of investments, participant loans and investment transactions to be complete and accurate as of December 31, 2024 and 2023, which are included in the Statements of Net Assets Available for Benefits, as well as dividend and interest income and net appreciation in the fair value of investments included in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023 and the information contained in Note 4 concerning investments, and the information included in the Schedule of Assets (Held at End of Year).

4. FAIR VALUE MEASUREMENTS:

The Plan follows established guidelines for a fair value hierarchy that prioritizes the inputs used to measure fair value. An asset or liability's classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement. The hierarchy prioritizes the inputs into three broad levels as follows:

- Level 1 Quoted prices (unadjusted) in active markets for identical assets or liabilities. Market price is generally obtained from exchange or dealer markets.
- Level 2 Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. Inputs are obtained from various sources including market participants, dealers and brokers.
- Level 3 Unobservable inputs that are supported by little or no market activity as they trade infrequently or not at all and that are significant to the fair value of the assets or liabilities.

4. FAIR VALUE MEASUREMENTS: (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that registered with the Securities and Exchange Commission. These funds are valued at the closing price recorded on the active market in which these individual securities are traded.

Stable value fund / Collective trust fund: The fund is composed primarily of investment contracts contained in an insurance company general account. Fair value is determined by the net asset value ("NAV") based on the quoted market price of the underlying funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS:

ADP Retirement Services (“ADP”) was administrator/recordkeeper of the Plan and Reliance was the trustee/custodian. Fees paid by the Plan to ADP are party-in-interest transactions. Contract administrator fees paid to ADP for the years ended December 31, 2024 and 2023 totaled \$4,511 and \$2,013, respectively.

Certain other fees paid by the Plan for investment management services were included in net appreciation in the fair value of the investments, as they are paid through revenue sharing rather than a direct payment.

Certain employees and officers of the Company, who may also be participants in the Plan, perform administrative services at no cost to the Plan.

6. TAX STATUS:

The Plan is a prototype Plan administered by ADP and a determination letter was received dated October 6, 2020, in which the Internal Revenue Service stated that the Plan as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

7. RISKS AND UNCERTAINTIES:

The Plan provides for various investment fund options in any combination of mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

8. SUBSEQUENT EVENTS:

Management has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued.
