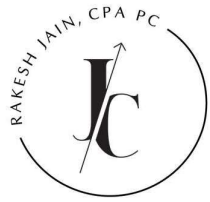

Note 1: Description of plan

The Commure, Inc. 401(k) plan effective 01/01/2019 is a defined contribution plan established for the benefit of the employees of Commure, Inc. ('the Company'). Employees are eligible to participate in the plan if they are employed by Commure, Inc. or any affiliate who has adopted the Plan. The following is the brief general description of the plan:

Contributions

Participants may elect to make deferral contributions to the Plan from the pretax annual compensation, as defined in the plan, subject to certain limitations of the Internal Revenue Code (IRC). Participants who have attained the age 50 before the end of the Plan year are eligible to make catch-up contribution. Federal law also limits the amount the participants may elect to defer under this Plan and any other retirement plan permitting Elective Deferrals during any calendar year to \$23,000 and additional \$7,500 for participants at age over 50 in 2024. Rollover contribution from other qualified retirement plans are allowed by the plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make discretionary matching contribution equal to a uniform percentage or dollar amount of the participant's elective deferrals.

Employer Matching Contributions

The Company may, in its sole discretion, make a matching contribution on employee's behalf if they make a "Matched Employee Contribution". A "Matched Employee Contribution is any Elective Deferral Contribution or Catch-up Contribution that an employee may make during the Plan Year. If an employee make a "Matched Employee Contribution", the Company may contribute to your Employer Matching Contribution Account in an amount and allocation formula as determined by the Company in its sole discretion.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of Company contributions, if any and Plan earnings and losses. Allocations are based on participant earning or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are always fully (100%) vested with respect to their contributions and related earnings thereon. Participants are immediately vested in their Elective Deferral Account and Rollover Contribution Account.

Commure, Inc.**Notes to Financial Statements****For the Years Ended December 31, 2024 and December 31, 2023****Employer Matching Contribution Account**

Participants are immediately vested in their elective (voluntary) contributions and income or loss thereon. Matching Employer contributions paid on the participants' behalf are fully vested after one year of eligible service.

However, if the company must make a matching contribution to employees' account in order to satisfy certain non-discrimination tests required by the Internal Revenue Code, employees' will be 100% vested in those matching contributions.

Non-Elective Contributions

Employees' interest in their Non-Elective Contribution Account will vest based on employees' years of Vesting Service defined below in accordance with the following schedule:

Participant loans

The Plan Administrator, in its discretion, may permit Participants to apply for a loan from the Plan. The Plan Administrator may further adopt any administrative rules or procedures that it deems necessary or appropriate with respect to the granting and administering of loans. Total outstanding participant loans as of December 31, 2024 is \$69,966, which was \$20,520 as of December 31, 2023.

Payment of benefits

On retirement, disability, or other termination of service, a participant may elect to receive a lump-sum distribution in the participant's vested account.

Forfeited Accounts

As of December 31, 2024, forfeited non-vested accounts totaled \$NIL. These accounts will be used to reduce future employer contributions or to offset plan expenses.

Note 2 - Summary of significant accounting policies

Basis of Accounting

The preparation of financial statements is in conformity with generally accepted accounting principles and on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investment is reported at fair market value except for the fully benefit responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing the information provided by the investment advisor and trustee.

Investment transaction are recorded on trade-date basis. Interest Income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investment bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024.

Payment of benefits

Benefits are recorded when paid.

Corrective Distributions

Amounts payable to participants for contribution in excess of amounts allowed by the IRS are recorded as liability.

Plan expenses

Operating expenses of the Plan are absorbed by the plan sponsor and are included in these financial statements.

Use of Estimates

The preparation of financial statements is in conformity with accounting principles generally accepted in United States of America which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of changes in net assets during the reported period. Actual results could differ from these estimates.

- Level 2 – Quoted prices for similar instruments in active markets; quoted prices for identical or similar instruments in markets that are not active; and model-derived valuations in which significant value drivers are observable.
- Level 3 – Valuations derived from valuation techniques in which significant value drivers are unobservable.

Note 4 - Income Tax Status

The Internal Revenue Service has ruled that the plan qualifies under section 401(a) of the Internal Revenue Code (IRC) and is, therefore not subject to tax under present income tax law. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualifications.

The plan obtained its latest determination letter on June 30, 2020 in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue code. Accounting principles generally accepted in United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdiction, however there are currently no audits for any tax periods in progress.

Note 5 – Plan Merger

Effective 10/01/2024, the Athelas, Inc 401(k) Plan and Golden Gate Pharmacy Services 401(k) Plan merged into the Commure, Inc. 401(k) Plan.

Pursuant to the terms of the merger agreements and in accordance with the Employee Retirement Income Security Act of 1974 (ERISA), the assets and liabilities of the Merging Plans were transferred to the Plan's trust at their respective fair values as of the merger date.

As a result of the merger:

- Participant account balances from the Athelas, Inc 401(k) Plan and Golden Gate Pharmacy Services 401(k) Plan were transferred to the Plan and invested according to participants' existing investment elections.
- All rights and obligations of participants in the Merging Plans were assumed by the Plan; and
- The Athelas, Inc 401(k) Plan and Golden Gate Pharmacy Services 401(k) Plan ceased to exist as separate plans following the completion of the transfer.

All assets transferred were valued based on information provided and certified by the respective trustees or custodians of the Merging Plans, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 6 - Plans termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan. Upon termination, all participants' account balances become fully vested in the amounts credited to their accounts after payment of any expenses, allocation of profit or loss, adjustment as a result of determination of the fair market value of Plan assets at the termination date, and reallocation of the Plan asset to the date of termination.

Note 7 - Information Certified by the Plan Trustee

Management has elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the Trustee of the Plan, has certified that the following investment information is complete and accurate:

- Fair value of investments and the carrying amount of notes receivable from participants as reflected in the Statements of Net Assets Available for Benefits as of December 31, 2024 and December 31, 2023.
- Dividends, net realized and unrealized depreciation in fair value of investments, and interest income on notes receivable from participants as reflected in the Statement of Changes in Net Assets Available for Benefits for the Year Ended December 31, 2024.

accounts balances and the amounts reported in the statement of net assets available for benefits.

Note 10 - Related Party Transactions

During 2024, the plan's investments were managed by Fidelity. Accordingly, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rule under ERISA.

Note 11 - Subsequent events

The date to which events occurring after December 31, 2024 have been evaluated for possible adjustments to the financial statements or disclosure is October 14, 2025, which is the date on which financial statements were available to be issued.
