Notes to Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following description of the Stova Group, LLC 401(k) Profit Sharing and Trust (the Plan) (formerly Aventri, Inc. 401(k) Profit Sharing Plan and Trust) is provided for general purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established on January 1, 2002, is a defined contribution plan that, prior to January 1, 2023, was available to all employees of Aventri, Inc. who have met the eligibility requirements stipulated by the Plan.

Effective January 1, 2023, Aventri, Inc. (previously named Plan sponsor) was rebranded to Stova Group, LLC (the Company), after the acquisition of Aventri, Inc. by MeetingPlay, LLC and the Plan was amended to include employees from two Stova Group, LLC affiliated companies, MeetingPlay, LLC and Eventcore, LLC. Employees of the affiliated companies were eligible to contribute to the Plan beginning January 1, 2023.

In connection with the termination of the affiliated companies' previous plans, the Plan received transferred assets totaling \$2,865,656 in January 2023.

Effective in June 2023, the Plan was formally amended to change the name to Stova Group, LLC 401(k) Profit Sharing and Trust.

The Plan is administered by the management of the Company (Plan Administrator) and is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Eligibility

In general, employees are eligible to participate in the Plan upon completing 3 months of employment and attainment of age 18. Employees who meet the eligibility requirements can enter into the Plan at any time by contacting the Plan's record-keeper. The Plan does not provide an automatic enrollment feature.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Contributions

Each year, participants may contribute a dollar amount or percentage from 1% through 90%, in increments of 1%, of their pretax annual compensation as defined by the Plan. Participant contributions are subject to limitations imposed by the Internal Revenue Code, which was \$23,000 for 2024 and \$22,500 for 2023 (plus \$7,500 for eligible catch-up contributions made by participants of the age of 50 and older in 2024 and 2023). Participants may also designate any portion of their contributions as Roth contributions, which are taxable to the participant at the time of deferral.

The Company follows safe harbor deferral provisions and makes enhanced matching contributions in the amount equal 100% of employees' elective deferrals that do not exceed 4% of their compensation for the Plan year to all eligible participants. Effective September 1, 2023 the Plan was amended to eliminate the employer safe harbor deferral matching provisions, which were subsequently reinstated on January 1, 2024.

The Company may also make a profit-sharing contribution to the Plan. Employees must have 500 hours worked during the Plan year to qualify for the Company profit sharing contribution. The amount of the employer profit sharing contribution, if any, will be determined according to a discretionary formula in an amount determined each year by the Company and will be allocated to each qualifying participant's individual account based on the qualifying participant's compensation in relation to the total compensation of all qualifying participants. There were no employer profit sharing contributions made by the Company to the Plan for the years ended December 31, 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans under the rollover provisions of the Plan.

Participant Accounts

Each participant's account is credited with the participant's elective deferrals (pre-tax and/or Roth segregated), rollover contributions, safe-harbor matching contributions, allocations of Company profit sharing contributions and Plan earnings (losses). Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant directed transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

1. Description of Plan (continued)

Vesting

Participants are immediately vested in their elective deferrals, the actual earnings thereon, and Company's matching contributions. The Company profit sharing contributions to qualified participants, and any earnings thereon, are vested in accordance with the following schedule:

<u>Years of Service</u>	<u>Percent Vested</u>
Less than 2 years	0%
At least 2 years, but less than 3	20%
At least 3 years, but less than 4	40%
At least 4 years, but less than 5	60%
At least 5 years, but less than 6	80%
6 years or more	100%

Participants are credited with a year of service for 1,000 hours worked during the Plan year.

Retirement, Death and Disability

A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, and a minimum of \$1,000, and may only have two loans outstanding at a time. Loans must be repaid over a period of no more than 5 years except in the case of a loan used to acquire a principal residence, in which case the Plan Administrator may permit a longer repayment term, up to 30 years. Payments of principal and interest are made through payroll deductions over the loan period. A loan is secured by the vested balance in the participant's account. The loan bears interest at a rate that is determined by the Plan Administrator based on prevailing market conditions and is fixed over the life of the note. The interest rates on participant loans outstanding as of December 31, 2024 ranged from 4.25% to 9.50%.

1. Description of Plan (continued)

Payment of Benefits

Upon a participant's separation from service due to death, disability, termination, or retirement, benefits may be distributed to them in a single lump sum amount equal to the vested value of their account or through installments over a certain period at the participant's election. Active participants may also withdraw funds from their accounts under certain hardship conditions. In addition, participants may request a distribution of their elective deferrals from the Plan if they are still working and reach the age of 59 ½.

If the vested benefit is less than \$5,000, the Plan Administrator may initiate an involuntary distribution. Prior to such distribution, the participant has the right to request that the amount be distributed directly to the participant in the form of a lump sum amount or request that it be rolled over to a different IRA provider or another retirement plan eligible to receive rollover contributions.

As recommended by the SECURE Act, the Plan raised the required minimum distribution age from 72 to 73.

Forfeitures

Forfeited non-vested amounts totaled \$196 at December 31, 2024 and 2023. During the Plan year ended December 31, 2024, \$370 of forfeitures were collected, and \$381 were used to offset employer contributions. During the Plan year ended December 31, 2023, \$3,353 of forfeitures were collected, and \$3,322 were used to offset employer contributions.

Administrative Expenses

All costs related to the administration of the Plan, other than loans, distributions and transactions servicing fees, are paid by the Company.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Benefit Payments

Benefits are recorded when they have been approved for payment and paid by the Plan.

Risk and Uncertainties

The Plan invests in various securities, including mutual funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities in the near term could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents in the statements of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of realized and unrealized gains (losses).

2. Summary of Significant Accounting Policies (continued)

Fair Value of Financial Instruments

The Plan follows Accounting Standards Codification (ASC) 820 for all financial assets and liabilities and nonfinancial assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring basis. ASC 820 defines fair value, establishes a fair value hierarchy, and expands disclosures about fair value measurements.

ASC 820 defines fair value as the price that would be received upon sale of an asset or paid upon the transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability.

The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity. In addition, the fair value of liabilities should include consideration of non-performance risk including the Plan's own credit risk.

3. Information Certified by the Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee of the Plan, Reliance Trust Company, as of and for the years ended December 31, 2024 and 2023, have certified to the Plan Administrator the following information as complete and accurate, which has been relied on by the Plan Administrator in the preparation of the Plan's financial statements.

- Investment balances at cost and fair value in the aggregate and by fund, as of December 31, 2024 and 2023;
- The amount of notes receivable from the participants plus any accrued but unpaid interest as of December 31, 2024 and 2023;
- Interest and dividend income credited to the Plan, in the aggregate and by fund, for the years ended December 31, 2024 and 2023; and
- Net appreciation (depreciation) in the fair value of Plan investments, in the aggregate and by fund, for the years ended December 31, 2024 and 2023.

4. Fair Value Measurements

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy prioritizes the inputs into three levels based on the extent to which inputs used in the measuring fair value are observable in the market. Each fair value measurement is reported in one of three levels which is determined by the lowest level input that is significant to the fair value measurement in its entirety. These levels are:

Level 1 - Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2 - Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 - Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

5. Party-in-Interest and Related Party Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Notes receivable from participants and interest also reflect party-in interest transactions.

6. Income Tax Status

Effective June 1, 2021, the Plan adopted an ADP Non-Standardized 401(k) Profit Sharing Plan and has chosen to rely on the advisory opinion letter dated October 6, 2020.

Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualification. The Plan has not been amended since receiving its latest advisory opinion letter. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.
