Basis for Opinion

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of the Prime Coordination, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for complete information regarding the Plan and its provisions.

General

The Plan is a defined contribution 401(k) plan which covers substantially all employees of Prime Care Coordination, LLC (the Company or employer) who meet certain eligibility criteria. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The plan was established effective April 1, 2023 to serve as a replacement for a separate plan sponsored by the Company. All plan assets within the previous plan have been transferred into the Plan on April 1, 2023, and has been reflected in the Transfer of Plan Assets line on the statement of changes in net assets available for benefits.

Plan Administration

Prime Care Coordination, LLC is the Plan sponsor. The Plan administrator is ADP, Inc and Reliance Trust Company serves as the Plan's trustee and custodian.

Participation

All benefit-eligible employees of the Company are eligible to participate in the Plan. Benefit-eligible employees who are 18 years of age or older may begin salary deferrals immediately upon hire. Benefit-eligible employees who are 18 years of age or older are eligible to receive the Company's contributions immediately upon hire.

Contributions

Active participants may make voluntary pre-tax and post-tax contributions in the form of salary reductions and any applicable rollovers from other qualified plans, subject to certain limitations of the Plan and the Internal Revenue Code (IRC) under Section 401(k). Eligible participants, who attain the age of 50 before the end of the Plan year, are eligible to make catch-up contributions, subject to certain limitations of the IRC. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan also provides for various employer contributions, including discretionary employer match and profit-sharing contributions. For the period ended December 31, 2024 and 2023, the Company made discretionary match contributions equal to 3% of eligible compensation for employees who met certain eligibility criteria defined in the Plan document. There were no profit-sharing contributions to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and allocations of Plan earnings/losses, and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their voluntary contributions and actual earnings/losses thereon. Participants are fully vested in employer contributions and actual earnings/losses thereon upon completion of three years of credited service. The Plan has no partial vesting provisions.

Forfeitures

If a participant's employment is terminated, the non-vested portion of the participant balance will become subject to forfeiture in accordance with the provisions of the Plan agreement. Forfeitures of non-vested participant accounts can be allocated to offset plan expenses or to reduce future employer contributions. Forfeitures in the amount of \$85,401 and \$29,695 were used to reduce employer contributions for the year ended December 31, 2024 and the period of inception (April 1, 2023) through December 31, 2023, respectively. Unallocated forfeited balances totaled \$85,136 and \$63,115 at December 31, 2024 and 2023, respectively.

Payment of Benefits

The Plan provides for payments of benefits upon reaching normal retirement age and has provisions for in-service, disability, death, and termination benefits for those participants who are eligible to receive such benefits. Participants can elect to receive benefits in the form of a lump-sum distribution or partial payments, as defined in the Plan document.

Hardship Withdrawals

Hardship withdrawals from a participant's account are permitted under certain circumstances. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

Notes Receivable from Participants

Plan participants may borrow up to the lesser of 50% of their vested account balances, or \$50,000 reduced by the difference between the highest outstanding balance of loans in the past 12 months and the outstanding balance of loans from the Plan on the date the loan is made. Loans are repayable over periods not to exceed five years, except in the case of a loan taken for the purpose of purchasing a primary residence. All loans bear interest at the prime rate plus 1%.

Administrative Expenses

Administrative expenses of the Plan are paid from Plan assets.

Plan Termination

Although the Company has not expressed any intent to do so, it has the right to terminate the Plan subject to provisions set forth by ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Changes in the current value of investments held during the year, including realized gains and losses on assets bought and sold during the year, are reflected in the statements of changes in net assets available for benefits as net appreciation (depreciation) in the fair value of investments. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis.

Fair Value Measurements

GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan uses various valuation techniques in determining fair value. GAAP establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that observable inputs be used when available. Observable inputs are inputs that market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's estimate about the assumptions market participants would use in pricing the asset or liability, developed based on the best information available in the circumstances.

GAAP establishes a fair value hierarchy. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

Mutual funds: Valued at fair value based on quoted prices in active markets.

Stable Value Funds: Fair value is valued at the NAV per unit by dividing the total assets of the fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Fund and included in the determination of unit values. These contracts contain certain restrictions on the Plan participants' ability to cash out their contracts and thus are not fully-benefit responsive contracts.

The Plan's investment in stable value funds is comprised of guaranteed insurance contracts established between the Plan's participants and the Plan's custodian. These contracts guarantee the participants' principal and a minimum interest rate. In addition, participants have the opportunity to earn amounts in excess of the guaranteed rate. The investment is included in the financial statements at NAV which approximates fair value.

There were no changes in the methods used to measure fair value at December 31, 2024 or 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurements (Continued)

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based on the terms of the Plan document.

Benefits Paid to Participants

Benefit payments are recorded when paid.

Estimates

The preparation of financial statements in accordance with GAAP requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

6. PARTY-IN-INTEREST TRANSACTIONS

Reliance Trust Company serves as the Plan trustee and custodian and ADP, Inc. is the Plan's Third-Party Administrator. The Plan administrator is ADP Inc. Consequently, transactions between Reliance Trust Company, ADP, Inc. and the Plan qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

7. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the year ended December 31, 2024 and the period of inception (April 1, 2023) through December 31, 2023

8. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
