**Scope and Nature of the ERISA Section 103(a)(3)(c) Audit**

We have performed audits of the accompanying financial statements of Endura Products Corp. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Endura Products Corp. 401(k) Plan's (the Plan) financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTES TO FINANCIAL STATEMENTS**

**1. DESCRIPTION OF PLAN**

The following description of Endura Products Corp. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General – The Plan, effective July 1, 2018, is a defined contribution plan covering substantially all of the employees of Endura Products Corp. and Novastar, LP. referred to collectively as “the Employer” and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility – Employees are eligible for participation in the Plan after completing six months of service and attainment of age 21 years. The Plan entry date is on the first day of each quarter coinciding with or next following the date eligibility requirements are met. The Plan has two participating employers who are owned and operated under the same group of common ownership.

Contributions – Under the Plan, the participant and the Employer are both allowed to make contributions. The participants are allowed to contribute a portion of their salary in pre-tax and Roth contributions to the Plan subject to those limitations provided for in Section 402(g) of the Internal Revenue Code. The Employer permits rollover contributions into the Plan. The Plan includes an automatic enrollment provision of 5%.

As determined annually, the Employer may contribute to the Plan discretionary matching contributions or discretionary profit-sharing contributions.

Participant Accounts – Each participant has one account that will consist of sub-accounts designated for participant contributions and Employer contributions. Participant contribution and Employer accounts are credited with the contributions and the earnings of the specific investment vehicles selected. Participants may self-direct their contributions to various mutual funds and a stable value collective trust fund.

Vesting – Participants are always fully vested in their contributions. Prior to July 1, 2023, each participant's Employer contribution account vests at a rate of 20% after two years until fully vested after six years. On July 1, 2023, the Plan was amended to include a new vesting policy in which employees are 33% vested after 1 year of service, 67% after 2 years of service, and 100% after 3 years of service. If a participant dies or becomes disabled, the participant's accrued benefit derived from Employer contributions becomes 100% vested without regard to the above schedule. In the event of full or partial termination of the Plan, an affected participant's rights to the accrued benefit shall be 100% non-forfeitable.

Forfeitures – Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. These may be used to reduce matching contributions or to pay administrative expenses of the Plan. Forfeitures totaled \$6,645 in 2024 and \$3,809 in 2023. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$76,908 and \$67,628, respectively. For the years ended December 31, 2024 and 2023, fees were reduced by \$0 and \$0, respectively, from forfeited nonvested accounts.

Payment of Benefits – Upon normal retirement age or death, a participant may elect to receive a lump-sum amount equal to the vested balance of the participant's account, or substantially equal installments over a period not to exceed the participant's lifetime or the assumed lifetime of the participant and beneficiary. If the vested balance does not exceed \$5,000, then the vested account balance may only be distributed in a single lump-sum payment. A participant may receive distributions prior to separation of service after normal retirement age is reached. Distributions to terminated participants will be made as soon as administratively feasible, and an automatic distribution will be made to those participants with a vested balance below \$5,000. If the participant dies prior to receiving all benefits under the Plan, the balance of the participant's account is paid to the beneficiary.

The Plan also allows hardship and in-service distributions. Hardship distributions are only permitted by participants that are employed with the Employer at the time of the hardship distribution. In-service distributions may be made by participants who have attained age 59 ½. The minimum amount a participant may receive as an in-service distribution is \$500.

Loans are not permitted under the Plan.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Benefits are recorded when paid.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the period. Actual results could differ from those estimates.

Concentrations of credit risk exist if a number of investments are engaged in similar activities and have similar economic characteristics that could cause their ability to meet contractual obligations to be similarly affected by changes in economic or other conditions. The Plan has invested in a variety of financial instruments and investments involving diverse industries and geographic areas to mitigate exposure to credit risk.

**3. ADMINISTRATION OF PLAN ASSETS**

The Plan assets are held by the trustee of the Plan. Employer and participant contributions are invested by the trustee as directed by the participants. The administrative expenses associated with the third-party administrator for the Plan are paid directly by the participants. Other expenses associated with the trustee of the Plan are paid by the Employer. Certain fees are paid by the participants' investment funds to their affiliated investment advisors, transfer agents and recordkeeper as further described in each fund prospectus, plan service agreements, or other published documents. These fees were deducted prior to allocation of the Plan's investment earnings activity.

**4. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

**5. FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds and Collective Trusts:* Valued at the Net Asset Value (NAV) of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. TAX STATUS**

The Plan is operating under a prototype plan filed by ADP, LLC. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan has adopted the "uncertain tax positions" provisions of accounting principles generally accepted in the United States of America. The primary tax position of the Plan is its filing status as a tax exempt entity. The Plan determined that it is more likely than not that its tax positions would be sustained upon examination by the Internal Revenue Service (IRS), or other State taxing authority. There were no penalties or interest recognized during the years ended December 31, 2024 and 2023. The Plan is no longer subject to U.S. federal income tax examinations by federal taxing authorities for years before 2021.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
