Notes to Financial Statements

A. PLAN DESCRIPTION

General. The following description of the Elite Flooring & Design Inc. (Company) 401(k) Profit Sharing Plan & Trust (Plan) provides only general information. The Company is the Plan administrator and sponsor and Reliance Trust Company is the Plan trustee. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan was established on 01/01/1999 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Section 401(k) of the Internal Revenue Code of 1986 (IRC).

All employees of the Company are eligible to participate upon completing the Plan's eligibility requirements. Employees who are 21 years of age and completed 6 months of service are eligible to participate.

Funding. The Plan is a defined contribution plan wherein participants elect to reduce their compensation and have such reductions contributed to the Plan on their behalf. Participants direct their investments in numerous investment options managed by ADP Retirement Services.

Participating employees may contribute 1% to 92% of eligible compensation through payroll deductions to the maximum amount permitted under applicable Internal Revenue Service provisions. Participants age 50 or over are allowed catch-up contributions. Rollover contributions to the Plan are also allowed.

The Company will make a matching contribution. The match will be 50% up to the first 6% of employee deferrals. The match will be deposited with each payroll. The Company may make a discretionary profit-sharing contribution to each participants account. Participants must make elective deferrals into the Plan and be employed on December 31 to receive a matching contribution. The Company did not make a discretionary profit-sharing contribution for the year ended December 31, 2024.

Allocation. Each participant's account is credited with the participant's contributions and the Company's non-discretionary matching contribution. Investment income or loss is allocated daily based on the ratio of each participant's account balance at the end of the day. Any discretionary or profit-sharing contribution is made annually to participants employed on the last day of the Plan year.

Forfeitures. The Company may reduce employer contributions by forfeitures occurring during the Plan year that are not used to pay Plan expenses. The Plan reduced employer contributions with forfeitures during the Plan year. The Plan's forfeiture balance as of December 31, 2024 was \$536.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

A. PLAN DESCRIPTION (Continued)

Vesting Employee contributions are 100% vested. Employer matching and nonelective contributions have the following vesting schedule:

<u>Years of Vesting Service</u>	<u>Vested Interest</u>
Less than 2 years	0%
At least 2 years, but less than 3	20%
At least 3 years, but less than 4	40%
At least 4 years, but less than 5	60%
At least 5 years, but less than 6	80%
6 years of more	100%

Termination. Although the Company has not expressed any intent to do so, management may terminate the Plan at any time. Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or one of various installment payments available under the Plan. In addition, upon termination of the Plan, participants' vested interest in employer contributions shall be 100%.

Participant Loans. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 95 percent of their account balance. Loan transactions are treated as a transfer to (from) the investment fund and from (to) the Participant Notes fund. Loan terms range from one to four and one half years or within a reasonable time if the purpose of the loan is to acquire a primary residence. The balance in the participant's account secures the loan. The interest rate, set in the plan document is prime plus 1%. Principal and interest are repaid ratably through semi-monthly payroll deductions.

Payment of Benefits. On retirement, death, disability, or termination of service, a participant may leave their account balance in the Plan if the balance is greater than \$5,000 or elect to receive a single lump-sum payment in cash. Benefits payments are recorded when paid.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

This summary of significant accounting policies of the Plan is presented to assist in understanding the financial statements. The financial statements and notes are representations of the Plan's administrator, who is responsible for their integrity and objectivity. The accounting policies conform to accounting principles generally accepted in the United States of America (GAAP) and have been consistently applied in the preparation of the financial statements.

Estimates. The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and Uncertainties. The Plan invests in various investment securities. Investments securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses had been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Administration of the Plan. Certain administrative expenses of the Plan may be paid by the Company. The Plan is not required to reimburse the Company for any administrative expenses paid by the Company. Expenses not paid by the Company are paid by the Plan.

C. INCOME TAX STATUS

The Plan Sponsor has adopted the ADP, LLC Prototype Non-Standardized Profit Sharing Plan with CODA. The ADP, LLC Prototype Plan received an Opinion Letter from the IRS dated July 16, 2014 stating that the form of the plan is acceptable under section 401(k) of the Internal Revenue Code for use by employers for the benefit of their employees. Accordingly, no provision has been made for federal income taxes in the accompanying financial statements.

D. PARTY-IN-INTEREST

Certain Plan investments are shares of mutual funds managed by Reliance Trust Company, the Trustee. Transactions in these investments qualify as party-in-interest transactions which are exempt from the prohibited transactions rules.

E. INVESTMENTS

Investments representing 5% or more of the Plan's net assets at December 31, 2024 and 2023 are as follows:

F. INFORMATION CERTIFIED BY TRUSTEE

Under the Department of Labor's regulations, certain assets and related information held by a bank, trust company or similar institution, or an insurance company, that is regulated and subject to periodic examination by a state or federal agency does not have to be audited, provided plan administrator exercises this option and the institution holding the assets certifies the required information. Reliance Trust Company has provided certification as to the completeness and accuracy of the investments presented in the accompanying statements of net assets available for plan benefits for the years ended December 31, 2024 and 2023. The accompanying supplemental schedule also includes investment information certified by Reliance Trust Company as being complete and accurate.

G. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the evaluation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

G. FAIR VALUE MEASUREMENTS (Continued)

Registered investment companies – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, the Plan believes its valuation methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date.

Certain Plan investments are shares of mutual funds managed by Reliance Trust Company, the Trustee. Transactions in these investments qualify as party-in-interest transactions which are exempt from the prohibited transactions rules.
