Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Hospitalists Now, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Hospitalists Now, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Hospitalists Now, Inc., 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

For information included in the supplemental schedule that agreed

to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1. DESCRIPTION OF THE PLAN

The following brief description of Hospitalists Now, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General:

The Plan is a defined contribution plan covering all employees (unless excluded) of Hospitalists Now, Inc. and nine wholly-owned subsidiaries, as well as HNI Medical Services of California, P.C. and HNI Hospital Services of Colorado, PLLC (collectively, the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). ADP Retirement Services is the recordkeeper (the “Recordkeeper”) and Reliance Trust Company is the trustee (the “Trustee”) for the Plan. The Plan is administered internally by employees of the Company.

Eligibility:

An employee is eligible to participate in the Plan on the first day of the month coinciding with or next following the completion of three months of service. Union employees and nonresident aliens are not eligible to participate in the Plan. A participant must be employed on December 31 and complete a year of service, as defined, to be eligible for a discretionary employer profit sharing contribution, unless terminated due to death, disability or retirement.

Contributions:

All newly eligible employees may join the Plan with the option to contribute pre-tax and Roth 401(k) contributions. Participants may authorize the Company to withhold up to 90% of his or her compensation, not to exceed the annual limit established by the Internal Revenue Code (“IRC”). A participant’s pre-tax and Roth 401(k) contributions are separately accounted for, as are the gains and losses attributable to each. Participants who have reached fifty years of age before the end of the Plan year are eligible to make catch-up contributions, which are also eligible for employer match contributions. Participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company makes a safe harbor employer matching contribution in an amount equal to 100% of the first 3% of contributed compensation and 50% of the next 2% of contributed compensation. The Company may also contribute a discretionary employer profit sharing contribution, although this was not elected for the year ended December 31, 2024.

Participant accounts:

Each participant’s account is credited with the participants’ contributions, the Company’s contributions and an allocation of Plan earnings, and may be charged with Plan expenses, if applicable. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Loans:

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum of 1) \$50,000 reduced by the excess, if any, of i) the highest outstanding note receivable balance during the prior twelve-month period, over ii) the outstanding note receivable balance on the date the new note is made or 2) 50% of their vested account balance, whichever is less. Participant notes receivable are secured by the vested balance in the participant's account and bear interest at the prime rate plus 1%. Participants may have one note receivable outstanding at a time. Notes receivable repayments are deducted through after-tax payroll deductions over a period not to exceed five years, unless the note receivable is for the purchase of a participant's primary residence, in which case the repayment period may not exceed thirty years.

When a participant fails to comply with the terms of the Plan loan, the outstanding principal is defaulted, and the participant is required to pay income taxes and penalties if applicable on the defaulted amount. The Plan administrator defaults loans on a periodic basis.

Vesting:

Participants are immediately vested in their pre-tax contributions, employer non-elective contributions and related earnings thereon. Participants are 100% vested in Company contributions and related earnings made after January 1, 2020. For all contributions and related earnings prior to January 1, 2020 vesting is based on years of credited service. A participant is 100% vested after four years of credited service, as defined, which is earned in 25% increments annually. Participants may also become fully vested upon reaching retirement age or upon termination of employment due to disability or death.

Forfeitures:

Forfeitures by participants of unvested Company contributions are used to pay Plan administrative expenses and to reduce future employer contributions. Forfeitures totaling \$48,064 were utilized to reduce the Company's contribution during the year ended December 31, 2024.

Payment of benefits:

Upon reaching age 59 1/2, disability, death, retirement or termination of employment, a participant or beneficiary may elect to receive a lump sum, installments or partial withdrawals equal to the participant's vested account balance. The Plan administrator may distribute terminated participant's account balances that are less than \$1,000 in a lump sum without the participant's consent. The Plan administrator may transfer

terminated participants' account balances that are at least \$1,000 but less than \$5,000 into an individual retirement account without the participants' consent. In-service distributions of rollover contributions may be made at any time. In-service hardship distributions are permitted if certain criteria are met.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates and assumptions.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The HNI Healthcare 401(k) Governance Committee determines the Plan's valuation policies utilizing information provided by the trustee and investment advisor. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the Plan year.

Stable Asset Fund:

The plan invests plan assets with ADP Retirement Services as trustee. One of the investment options provided is the Invesco Stable Assets Fund, which is a synthetic Guaranteed Investment Contract (GIC). The fund's objective is preservation of capital, and the contract guarantees the plan investment return will not drop below 0.0%. The fund holds Wrap contracts with multiple different insurance companies, which comprise 99% of the entire portfolio.

Participant Loans:

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest rates range from 3.5 to 9.5%. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits and withdrawals:

Benefits and withdrawals are recorded when paid.

Expenses:

The Plan pays for certain expenses, as provided for in the Plan document. These expenses are reflected in the Statement of Changes in Net Assets Available for Benefits as administrative expenses. All other expenses are paid by the Plan Sponsor. Expenses paid by the Company are excluded from the financial statements.

Risks and Uncertainties:

Financial instruments which potentially subject the Plan to concentrations of credit risk consist primarily of investment securities in which the Plan invests. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE 3. FAIR VALUE

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

Level 1 – Quoted prices in active markets for identical assets at the measurement date.

Level 2 – Observable inputs other than quoted prices for the asset, either directly or indirectly observable, that reflect assumptions market participants would use to price the asset based on market data obtained from sources independent of the Plan. This may

include the asset matrix pricing, yield curves and indices. No Level 2 inputs were available to the Plan.

Level 3 – Unobservable inputs that reflect the Plan’s own assumptions about the assumptions market participants would use to price an asset based on the best information available in the circumstances. No Level 3 inputs were available to the Plan.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value

(NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust Funds – The fair value of the investments in the Invesco Stable Asset Fund are based on the contractual terms of the underlying agreements which seek to provide a competitive interest rate without the risk of principal loss and is measured at net asset value. The investment strategy of the fund is to provide stable value.

NOTE 5. INCOME TAX STATUS

The Plan has not applied for a determination letter from the Internal Revenue Service (“IRS”) to determine if it is designed in accordance with applicable sections of the IRC. The Plan document is based upon a prototype instrument from the Recordkeeper which received an IRS opinion letter on October 6, 2020. Although the prototype plan has been amended since receiving the IRS determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for periods prior to 2021.

NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Fees earned by Reliance Trust, the Plan trustee, and ADP, the plan Recordkeeper, and its affiliates are included in administrative expenses and net appreciation in fair value of investments. Transactions such as these, as well as note receivable from participants, qualify as party-in-interest transactions. The Company pays directly certain other fees related to the Plan's operations.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9. SECURE 2.0
