## INDEPENDENT AUDITOR'S REPORT

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the 401(k) Employee Benefit Plan of Hamilton Health Center, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the 401(k) Employee Benefit Plan of Hamilton Health Center's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Principal Life Insurance Company, Principal Life Insurance Company on behalf of Principal Global Investors Trust Company, and Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (collectively "Principal"), a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the 401(k) Employee Benefit Plan of Hamilton Health Center's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

#### **NOTE 1 DESCRIPTION OF PLAN**

---

The following description of the 401(k) Employee Benefit Plan of Hamilton Health Center (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering substantially all employees of Hamilton Health Center (referred to herein as the Center or Employer). Excluded employees include those who are nonresident aliens with no U.S. source income and those who are classified or treated as independent contractors (even if a government agency or court with the jurisdiction determines that such persons are deemed to be employees for any purpose under common-law principals or federal, state or local law). Certain employees commonly called leased employees and other individuals who are not employees of the employer, but who are commonly called leased employees because they are employed by a leasing organization are not eligible to participate in the plan. The Center has no such employees. Employees are eligible to defer into the Plan and receive matching contributions once they attain age 18 and complete one year of service. The Plan is subject to the provisions of ERISA. The Center's Board of Directors is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

On May 1, 2019, the Center acquired the family medicine center of Pinnacle Health Medical Services (PHMS) in Millersburg, Pennsylvania. Effective August 1, 2019, the Plan was amended to allow for those employees of the acquired center to receive credit for their prior years of service under PHMS for purposes of determining Plan eligibility and vesting. The acquired employees had the option to enroll in the Plan at that time assuming they had met the Plan's eligibility requirements.

#### ***Contributions***

Each year, participants may contribute a percentage of pretax or post tax (Roth) annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Employer contributions consist of a discretionary employer match. For 2024, the employer matched 100 percent up to the first 3 percent on participants' bi-weekly deferrals. Contributions are subject to certain IRS limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and Center matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

#### *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Center's matching contribution portion of their accounts is based on years of continuous service. Employees hired after January 1, 2001 are 100 percent vested after five years of credited service, as follows:

3	50%
4	75%
5 or more	100%

Employees hired prior to January 1, 2001, are immediately 100 percent vested. Also, a participant becomes automatically 100 percent vested when they reach their early or normal retirement age (59 ½ and 65 years old, respectively), or in the event of disability or death.

#### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate which is commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through bi-weekly payroll deductions.

#### *Payment of Benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Effective January 1, 2024, the threshold increased from \$5,000 to \$7,000 for mandatory distributions. Participant account balances of less than \$7,000 that meet the provisions for a mandatory distribution will be directly rolled over into an individual retirement account in the participants name with a qualified institution designated by the Plan (for distributions between \$1,000 and \$7,000) or paid in cash (if the balance is less than \$1,000), if the participant does not elect a distribution method. In addition, hardship and in-service distributions are permitted if certain criteria are met.

#### *Forfeited Accounts*

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$5, respectively. Forfeitures are used first to pay administrative expenses and then to reduce future employer contributions. For the year ended December 31, 2024, \$10,261 was used to pay administrative expenses and \$0 was used to reduce employer contributions.

#### **NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

---

##### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Center's Board of Directors determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### ***Contributions***

Contributions from Plan participants and the matching contributions from the Center are recorded in the year in which the employee contributions are withheld from compensation and on compensation paid during the year.

##### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

##### ***Payment of Benefits***

Benefits are recorded when paid.

##### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Center and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, benefit payments and general bookkeeping fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### NOTE 3 FAIR VALUE MEASUREMENTS

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Mutual Funds***

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### ***Pooled Separate Accounts***

Valued at the net asset value of the underlying funds (mutual funds) on the last day of the plan year. The net asset value of the fund is based on the market value of its underlying investments, but it is not a publicly quoted price in an active market.

##### *Collective Investment Trust*

Valued at the net asset value of the underlying funds on the last day of the plan year. The net asset value of the fund is based on the market value of its underlying investments, but it is not a publicly quoted price in an active market. The fund is largely liquid and is designed to not lose much value. The fund is considered to be among the least risky forms of investment options. However, it typically has a lower rate of return than equities or longer-term fixed income investment options over long periods of time.

#### NOTE 4 CERTIFICATION BY CUSTODIAN

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to certain investments and notes receivable from participants held as of December 31, 2024 and 2023 totaling \$5,768,711 and \$5,794,399, respectively, and certain net appreciation in fair value of investments, dividends, capital gain distributions, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company, Principal Life Insurance Company on behalf of Principal Global Investors Trust Company, and Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (collectively "Principal"), a qualified institution.

#### **NOTE 5 RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

---

Certain Plan investments are pooled separate accounts and a collective investment trust managed by Principal Life Insurance Company and Principal Global Investors Trust Company (collectively "Principal"). Principal is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan made a direct payment to the recordkeeper of \$46,391 which was not covered by revenue sharing. The Center pays directly any other fees related to the Plan's operations.

#### **NOTE 6 PLAN TERMINATION**

---

Although it has not expressed any intent to do so, the Center has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

#### **NOTE 7 TAX STATUS**

---

The Plan adopted a non-standardized pre-approved profit sharing plan with CODA that was deemed acceptable under Section 401(a) of the Internal Revenue Code in a letter dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine audits by taxing jurisdictions, generally for a period of three years after the returns are filed; however, there are currently no audits for any tax periods in progress.

#### **NOTE 8 RISKS AND UNCERTAINTIES**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

#### NOTE 11 SUBSEQUENT EVENTS

---

The Plan has evaluated events and transactions subsequent to December 31, 2024 through October 9, 2025, the date these financial statements were available to be issued. The Plan has identified the following events between December 31, 2024 and October 9, 2025 that require recognition or disclosure in the Plan's financial statements.

Effective July 1, 2025, the Plan transitioned its service provider from Principal to ADP. In connection with this change, the Plan was restated and adopted a non-standardized pre-approved profit sharing/money purchase/CODA plan that was deemed acceptable under Section 401(a) of the Internal Revenue Code pursuant to a letter dated October 6, 2020. Under the restated plan, employees become eligible to participate upon their date of hire, provided they are at least 18 years of age and not part of an excluded class of employees. This represents a change from the previous eligibility requirement of one year of service.
