## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Comprehensive Care Services, Inc. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Comprehensive Care Services, Inc. Retirement Savings Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.



- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Comprehensive Care Services, Inc. **NOTE 1 - Description of the Plan**

The following summary description of Comprehensive Care Services, Inc. Retirement Savings Plan is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

General - All employees of Comprehensive Care Services, Inc. (the Company), as defined in the Plan Agreement, meeting the service requirements, are eligible to become participants in the Plan. The Plan also covers the employees of the Company's subsidiaries and related entities. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Contributions - Participants may elect to contribute a portion of their earnings to the Plan as part of the 401(k) feature. Participants' contributions are subject to annual maximums in accordance with the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants designate how their contribution will be invested in the investment funds selected by the Plan Administrator. The Plan provides for an employer safe harbor contribution of 4% of compensation plus 50% of deferrals between 4% and 6% of compensation, a discretionary matching contribution, and a discretionary profit sharing contribution. The Company did not make a discretionary matching contribution or profit sharing contribution for the years ended December 31, 2024 and 2023.

Participant Accounts - Each participant's account is credited with the participant's contribution, the employer's safe harbor contribution, the employer's discretionary contribution, if applicable, and Plan earnings. Allocations are based upon provisions as defined in the Plan.

Investment Options - Upon enrollment in the Plan, a participant may direct contributions in one percent increments in any of the 38 investment options. Participants may change their investment options at any time. The options consist of professionally managed mutual funds, a common collective trust fund, and self-directed brokerage accounts, and vary in their respective strategies, risks and goals.

Vesting - Participants are immediately vested in all contributions.

Notes Receivable from Participants - Participants may request a loan from the Plan of up to 50% of their vested balance or \$50,000, whichever is lower. The loan term is limited to five years unless it is for the purchase of a principal residence. The loan is secured by the participant's account and bears interest at prevailing rates as determined by the plan administrator. Principal and interest are paid through payroll deductions.

**NOTE 1 - Description of the Plan (Continued)**

Participants' Withdrawals - Benefits may be paid to the participant or beneficiary upon retirement, death, or termination of employment, as defined in the Plan Agreement. Benefit payments are payable to the participant or the beneficiary as a lump-sum amount. If the amount distributed is less than \$5,000, the distribution will be made without written consent. The Administrator may pay the distribution in a direct rollover to an individual retirement account if the administrator does not receive completed distributions forms as required. If the participant's account exceeds \$5,000, a distribution before normal retirement age can only be made with the participant's consent.

Forfeited Amounts - At December 31, 2024 and 2023, unallocated forfeited balances totaled \$4,296 and \$16,916, respectively. The Company may elect to use future forfeited accounts to reduce Plan expenses or employer contributions. The Company's matching contributions were reduced by \$17,397 for the year ended December 31, 2024. During the year ended December 31, 2023, the forfeited accounts were not used.

SECURE Act and CARES Act - The Plan has implemented certain provisions of the SECURE Act, which was effective January 1, 2020, and the CARES Act, which was signed into law in March 2020. The Plan has until December 31, 2026 to adopt amendments to reflect these provisions.

**NOTE 2 - Significant Accounting Policies**

Basis of Accounting - The financial statements were prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities, the disclosures at the date of financial statements, and the reported amounts of additions and deductions during the reporting period. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at current fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 2 - Significant Accounting Policies (Continued)**

Notes Receivable from Participants - Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as a distribution in accordance with the terms of the plan document.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - The Plan's administrative expenses are paid in part by earnings of the Plan. Fees for the administration of notes receivable from participants and processing of benefit payments are charged directly to the participant's account and are included in administrative expenses. Additional administrative expenses are paid by the sponsor of the Plan.

Subsequent Events - Management has evaluated events and transactions through September 29, 2025, the date the financial statements were available to be issued. There were no subsequent events that require adjustment to or disclosure in the financial statements.

The Plan's investments are reported at fair value in the statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels which are described below. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented above are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

**Level 1 Fair Value Measurements**

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end. The fair values of common stock, corporate bonds, and U.S. Government securities are based on the closing price reported on the active market where the individual securities are traded.

**Level 2 Fair Value Measurements**

Level 2 inputs consist of quoted prices for similar assets in active and inactive markets and other observable corroborated market data. Level 2 inputs are only used when Level 1 inputs are not available. This includes, but not limited to, quoted prices for similar assets or liabilities in markets that are not active. The Plan did not have any assets utilizing Level 2 inputs at December 31, 2024 and 2023.

**Level 3 Fair Value Measurements**

Level 3 inputs have the lowest priority. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available. There are no level 3 assets.

**NOTE 4 - Investments Measured Using the Net Asset Value Per Share Practical Expedient**

The Plan's investments include the T. Rowe Price Stable Value Fund with a net asset value of \$710,068 and \$520,722 at December 31, 2024 and 2023, respectively. There are no participant redemption restrictions for these investments.

**NOTE 6 - Information Certified by Trustees**

The financial statements, accompanying notes and supplemental schedule of assets were prepared in part from information certified by Newport Trust Company, for the period January 1, 2023 through November 13, 2024 and Ascensus Trust Company, for the period November 14, 2024 through December 31, 2024, the trustees, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The information certified includes: investments, notes receivable from participants, investment income, and participant loan interest.

**NOTE 7 - Related Party and Party-in-Interest Transactions**

Ascensus Trust Company and Newport Trust Company are the trustees as defined by the Plan, and Ascensus LLC & Newport Group, Inc. provide recordkeeping services to the Plan. Therefore, they are considered parties-in-interest. The Company sponsors the Plan and is considered a party-in-interest. The administrative expenses paid by the Plan include plan administration and investment advisory fees. These service providers, along with service providers paid on behalf of the Plan, are all considered parties-in-interest.

**NOTE 8 - Plan Termination**

Although it has not expressed any intent to do so, the Company shall have the right at any time to terminate the Plan subject to the provisions of ERISA. Upon termination, all amounts credited to the affected participants' accounts shall become 100% vested.

**NOTE 9 - Trust Agreement**

Effective November 14, 2024, Ascensus Trust Company was appointed Trustee of the Plan. Prior to November 14, 2024, Newport Trust Company was Trustee of the Plan. In accordance with the powers and duties of the trustee as designated in the Trust Agreement, the trustee invests the Plan's assets and the income therefrom for the benefit of the Plan participants. At the employer's discretion, trustee fees may be paid from the Plan's assets.

**NOTE 10- Tax Status**

The Plan adopted a prototype plan sponsored by Newport Group, Inc. Newport Group, Inc. has obtained a determination letter dated November 30, 2020 in which the Internal Revenue Service stated that the prototype plan was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The plan administrator has concluded that as of December 31, 2024 there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits in progress for any tax periods. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 11- Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

**NOTE 12- Timely Remittance of Contributions**

Amounts withheld for employee contributions and loan repayments are required to be remitted to the trustee as soon as they can be reasonably segregated. There were two occasions where the Company did not remit employee contributions to the trustees within the specified time frame. Untimely remittance of participants' contributions constitutes a prohibited transaction under ERISA section 406. The Company will correct the late contributions by remitting lost earnings.
