Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Orbus HoldCo 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1. Description of the Plan

The following brief description of the Orbus HoldCo 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

General

Effective January 1, 2023, the Plan name was changed from the Nimlok Company 401(k) Profit Sharing Plan to the Orbus HoldCo 401(k) Plan. The Plan is a defined contribution plan covering all full-time employees of Orbus, LLC, SEG Systems, LLC, and SEG Services, LLC (collectively, the Company) who have completed three months of service. The service requirement is waived for retained employees of SEG Systems, LLC employed on December 31, 2022. Any such eligible employees will enter the Plan on January 1, 2023. It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

Contributions

Subject to Internal Revenue Service limitations, each year participants may contribute a percentage of compensation, as defined in the Plan. In addition, all active participants who are eligible to make pre-tax contributions and who have attained the age of 50 before the close of the year shall be eligible to make employee catch-up contributions of up to \$7,500 and \$6,500 in 2024 and 2023, respectively. A participant's account may include after-tax contributions made to another plan and transferred to the Plan as part of a rollover contribution.

Effective January 1, 2022, newly eligible employees are automatically enrolled at a 3% pretax contribution rate, unless the employee elects otherwise. Automatic deferral amounts will increase by 1% of compensation as of the beginning of each subsequent February, up to a maximum of 6% of compensation. Effective January 1, 2023, the Plan was amended to no longer include automatic deferral provision.

During 2020, the Company suspended their employer-match contribution and safe harbor contributions. Effective January 1, 2022, the Company adopted a qualified automatic contribution arrangement (QACA) safe harbor match and matches 100% of the first 1% of compensation deferral amounts plus 50% of compensation deferrals between 1% and 6% of compensation. Participants direct the investment of contributions into various investment options offered by the Plan. Effective January 1, 2023, the Company froze the QACA safe harbor match and adopted to make traditional matching safe harbor contributions equal to the sum of 100% of the amount the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the Participant's Elective Deferrals that exceed 3% of the participant's compensation but do not exceed 5% of the participant's compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are immediately vested in the Company's 3% safe harbor contribution plus actual earnings thereon. Vesting in the Company's matching contribution plus actual earnings thereon is based on years of continuous service. A participant vests 20% beginning after the second year of service and an additional 20% after each additional year of service and is 100% vested in matching contributions after six years of credited service. In the event of death,

disability or retirement at designated ages, participants become fully vested. Effective January 1, 2022, participants fully vest after two years in QACA safe harbor contributions.

Notes Receivable From Participants

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years except for those loans utilized for the purchase of a primary residence, which could exceed five years. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50% at December 31, 2024, which are commensurate with local prevailing rates as determined by the plan administrator. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Principal and interest is paid ratably through weekly payroll deductions so there is no allowance for credit losses.

Payment of Benefits

Upon termination of employment or attainment of normal retirement age, the participant, or in the case of death, the surviving spouse, can elect to receive the participant's account balance in a single lump sum or in various installment annuities.

If a participant terminates prior to retirement, death or disability, the vested benefit will be distributed as soon as administratively feasible if it totals less than \$5,000. If the benefits are greater than \$5,000, the participant may elect a lump-sum distribution directly after their termination or may defer payment until their normal retirement date.

Hardship Withdrawals

Participants may elect to withdraw all or a portion of their elective or employer contribution accounts in the case of severe financial hardship, as defined in the plan document. The Company must approve any such hardship withdrawals.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts available for use totaled \$113,411 and \$19, respectively. Such forfeitures may be used to reduce administrative expenses and employer contributions. During 2024 and 2023, forfeitures of \$16,312 and \$43,228, respectively, were used to reduce administrative expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. The Plan's investments in shares of registered investment companies are valued at quoted market prices. The money market fund is valued at cost, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain expenses incurred in administering the Plan are paid by the Company and not reimbursed by the Plan. Administrative expenses paid by the Plan are recognized as paid. Certain investment fees are netted in the net appreciation (depreciation) in fair value of investments.

Revenue Sharing

The Plan recognizes income from revenue sharing agreements with its recordkeeper when received. Amounts received are utilized to pay qualified plan expenses. During the years ended December 31, 2024 and 2023, the plan received revenue sharing income of \$22,515 and \$22,500, respectively, which was used to pay qualified plan expenses.

Note 3. Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The money market fund is valued at amortized cost, which approximates fair value (Level 1).

The fair value of registered investment companies is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 5. Information Certified by the Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components and interest income from notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 7. Tax Status

The Plan operates under a non-standardized pre-approved profit sharing/money purchase/CODA plan sponsored by ADP, LLC. This non-standardized plan document has been filed with the appropriate agency and the sponsor has obtained an opinion letter dated October 6, 2020, from the Internal Revenue Service stating that the non-standardized plan constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Party-in-Interest Transactions

Expenses paid by the plan sponsor and the Plan for services rendered by the trustee and other parties-in-interest were for services required by the Plan. Expenses of \$81,596 and \$103,643 were paid by the Plan during 2024 and 2023, respectively before the effect of revenue sharing of \$22,515 and \$22,500 in 2024 and 2023, for professional services rendered by parties-in-interest. The Company provides certain administrative services at no cost to the Plan.
