We have conducted an ERISA Section 103(a)(3)(C) audit of the financial statements of American Society of Plastic Surgeons 401(k) Plan (the Plan), as of and for the year ended December 31, 2024, and have issued our report thereon dated August 29, 2025. Professional standards require that we advise you of the following matters relating to our audit.

### **Our Responsibility in Relation to the Financial Statement Audit**

As communicated in our engagement letter, our responsibility, as described by professional standards, is to conduct our audit in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, as permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution). ## **Our Responsibility in Relation to the Financial Statement Audit (continued)**

We are also responsible for communicating significant matters related to the audit that are, in our professional judgment, relevant to your responsibilities in overseeing the financial reporting process. However, we are not required to design procedures for the purpose of identifying other matters to communicate to you.

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, are presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditors' report, in order to identify any material inconsistencies between the draft Form 5500 and the financial statements. We identified no material inconsistencies in performing and completing our audit.

### **Planned Scope and Timing of the Audit**

We conducted our audit consistent with the planned scope and timing we previously communicated to you.

### **Compliance with All Ethics Requirements Regarding Independence**

The engagement team, others in our firm, as appropriate, and our firm have complied with all relevant ethical requirements regarding independence.

As communicated in our engagement letter, our performance of nonattest services does not include assuming management responsibilities or making management decisions. In relation to such nonattest services, you have agreed to assume all management responsibilities for the nonattest services we provide; oversee the services by designating an individual, preferably from senior management, with suitable skill, knowledge, or experience; evaluate the adequacy and results of the services; and accept responsibility for them. However, the performance of nonattest services creates the potential for circumstances that may impair independence ("threats"). We have identified and evaluated the self-review and management participation threats created by our performance of nonattest services. In order to reduce such threats to an acceptable level, we have taken certain measures or actions ("safeguards"), including the following:

- Policies and procedures that are designed to implement and monitor engagement quality control;
- The involvement of another professional accountant who (a) reviews the work that is done for a client or (b) otherwise advises the engagement team. This individual is someone from within the firm who is not otherwise associated with the engagement; and
- Policies and procedures that are designed to ensure that members of the engagement team do not make or assume responsibility for management decisions for the client.

## **Qualitative Aspects of the Plan's Significant Accounting Practices**

### *Significant Accounting Policies*

Management has the responsibility to select and use appropriate accounting policies. A summary of the significant accounting policies adopted by the Plan is included in Note 1 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the year ended December 31, 2024. No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

### *Significant Accounting Estimates*

Accounting estimates are an integral part of the financial statements and are based on management's current judgments. Those judgments are normally based on knowledge and experience about past and current events and assumptions about future events. We evaluated the key factors and assumptions used to develop the information used in the financial statements and determined that they are reasonable in relation to the basic financial statements taken as a whole.

### *Financial Statement Disclosures*

Certain financial statement disclosures involve significant judgment and are particularly sensitive because of their significance to financial statement users. There are no financial statement disclosures that are particularly sensitive because of their significance to financial statement users.

## **Significant Difficulties Encountered during the Audit**

We encountered no significant difficulties in dealing with management relating to the performance of the audit.

## **Uncorrected and Corrected Misstatements**

For purposes of this communication, professional standards also require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of management. No misstatements were noted during our audit.

## **Disagreements with Management**

For purposes of this letter, professional standards define a disagreement with management as a matter, whether or not resolved to our satisfaction, concerning a financial accounting, reporting, or auditing matter, which could be significant to the Plan's financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of the audit.

## **Representations Requested from Management**

We have requested certain written representations from management that are included in the management representation letter dated August 29, 2025.

## **Management's Consultations with Other Accountants**

In some cases, management may decide to consult with other accountants about auditing and accounting matters. Management informed us that, and to our knowledge, there were no consultations with other accountants regarding auditing and accounting matters.

## **Other Significant Matters or Issues**

In the normal course of our professional association with the Plan, we generally discuss a variety of matters, including the application of accounting principles and auditing standards, significant events or transactions that occurred during the year, business conditions affecting the Plan, and business plans and strategies that may affect the risks of material misstatement. None of the matters discussed resulted in a condition to our retention as the Plan's auditors.

## **Reportable Findings**

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit the attention of management and governance.

## **Reportable Findings (continued)**

Significant and relevant to you regarding your responsibility to oversee the financial reporting process are the following reportable findings:

- We noted during our audit that one participant made several hardship withdrawals during 2024. While the IRS doesn't technically limit the number of hardship withdrawals a participant can take in a year, some plans may impose stricter rules, like limiting them to two per plan year. An employer may generally rely on the employee's representation that they are experiencing an immediate and heavy financial need that cannot be relieved from other resources. However, an employer cannot rely on an employee's representation if the employer has actual knowledge that the employee's need can be relieved: (1) through reimbursement or compensation by insurance; (2) by liquidation of the employee's assets; (3) by stopping elective contributions or employee contributions under the plan; (4) by other currently available distributions (such as plan loans); or (5) by borrowing from commercial sources. Plans may not suspend making elective contributions following hardship distributions.
- We noted during our audit that the Plan Document available to participants on ADP's platform is actually the Plan Document for the related defined contribution plan, although the appropriate SPD and Adoption Agreement for this Plan is also available.
- The Employee Benefit Committee historically meets once per year. The Committee performs an important fiduciary role to the Plan and its meetings help to ensure the Plan Sponsor's fiduciary responsibilities are being met. We recommend the Committee consider meeting more often, at least twice a year. Furthermore, the minutes properly documented the meeting date, time, and attendees as well as meeting agenda, decisions made, and resulting action items. However, the Committee should consider items such as compliance with ERISA regulations, evaluation of service providers and related fees, review and approval of the annual audit report and any communications, and discussion of any employee complaints or concerns, or the lack thereof.

We also identified an internal control deficiency and provided our comments in a separate letter to you dated August 29, 2025.

## **Other Matter**

The ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, was subjected to the audit procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or the financial statements themselves, and other than additional procedures in accordance with GAAS. In addition, we made certain inquires of management and evaluated the form, content and methods of preparing the information in the ERISA-required supplemental schedule to determine that the information complies with the DOL's Rules and Regulation for Reporting and Disclosure under ERISA.

This report is intended solely for the information and use of Employee Benefit Committee and management of the Plan and is not intended to be and should not be used by anyone other than these specified parties.

**Notes to Financial Statements**

December 31, 2024 and 2023

**Note 1. Summary of Significant Accounting Policies**

**Method of Accounting** - The accompanying financial statements of American Society of Plastic Surgeons 401(k) Plan (the Plan) have been prepared using the accrual basis of accounting.

**Investments** - Investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of the investments are reflected on a trade-date basis.

Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when incurred. No allowance for credit losses has been recorded as of either December 31, 2024 or 2023. If a participant ceases to make repayments and the Plan Administrator determines the participant loan to be in default, the participant loan balance is recorded as a deemed distribution.

**Payment of Benefits** - Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan who were not yet paid at either December 31, 2024 or 2023.

**Expenses** - Virtually all administrative services incurred by the Plan are absorbed by American Society of Plastic Surgeons (the Society) without charge and are excluded from these financial statements. Transactional fees related to the administration of participants' accounts are charged directly to participants and are included in administrative expenses. Certain investment related expenses are included in net appreciation in fair value of investments.

**Reclassifications** - Certain reclassifications have been made to prior year amounts to conform the current year presentation.

## **Note 1. Summary of Significant Accounting Policies (continued)**

**Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Subsequent Events** - Subsequent events have been evaluated through August 29, 2025, which is the date the financial statements were available to be issued.

## **Note 2. Description of the Plan**

The Plan was established to provide retirement benefits for eligible employees of the Society. The Plan is primarily funded by contributions from participants and safe harbor contributions from the Society, and by the net earnings of the investments of the Plan. The Plan is a single employer defined contribution retirement plan covering all eligible employees of the Society who are 21 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Benefits under the Plan are not insured by the Pension Benefit Guaranty Corporation.

Each year, participants may contribute a percentage of pre-tax annual compensation, as defined by the Plan and subject to certain limitations. Participants may also contribute amounts representing rollover contributions from other qualified retirement plans. Under a safe harbor plan, the Society makes contributions equal to 3% of annual compensation. Safe harbor contributions are fully vested when made but are subject to restrictions on early withdrawal. Participants are immediately vested in all contributions plus actual earnings thereon.

Employees are eligible to participate in the Plan on the first day of the month following the date of hire. Participants are automatically enrolled in the Plan at a deferral rate of 3% of eligible compensation as defined by the Plan. Upon enrollment in the Plan, a participant may direct contributions to various investment options of the Plan. In the absence of participant direction, contributions are invested in accordance with default investment alternatives established under the Plan until changed by the participant. Participants must evaluate their own investment goals and objectives and choose investments best suited to achieve those goals and objectives. Poor investment performance by the funds selected by the participants may cause their vested balances to be lower than the amounts contributed to the Plan on their behalf. Participants may change their investment options daily.

In December 2022, the Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0 was enacted and increased the required minimum distribution age to 73 effective in 2023 and as late as 75 effective in 2033. The Plan also was amended pursuant to optional provisions of SECURE Act 2.0 to raise the required account balance threshold for an automatic lump-sum distribution to be made to a terminated participant from \$5,000 to \$7,000. The SECURE Act 2.0 also increases catch-up contribution limits in 2025 for individuals who have attained ages 60, 61, 62 and 63, which are indexed for inflation after 2025.

**Note 2. Description of the Plan (continued)**

Each participant's account is credited with the participant's contributions, employer contributions and an allocation of Plan earnings or losses thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit provided from the participant's account.

Upon termination of service due to death, disability or retirement, participants are eligible to receive a lump-sum amount equal to the value of the participant's account. Normal retirement age under the Plan is the attainment of age 65, or if later, the fifth anniversary of the first day of the Plan year during which a participant entered the Plan. Upon proof and to the satisfaction of the Plan Administrator of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Loans must be paid back within five years; however, this period may be extended to 30 years if the loan is used for the acquisition of a primary residence. Interest rates on outstanding participant loans as of December 31, 2024 and 2023 ranged from 4.25% to 9.50%. Principal and interest are generally repaid ratably through payroll deductions.

There were no unallocated amounts included in net assets available for benefits at either December 31, 2024 or 2023.

Participants should refer to the summary plan description for more complete information.

**Note 3. Priorities upon Termination**

Although it has not expressed any intent to do so, the Society has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain fully vested in their account.

**Note 4. Tax Status**

The Internal Revenue Service has advised that the Plan (a prototype plan), as designed, is a qualified plan under Internal Revenue Code Section 401(a), and is therefore exempt from federal income taxes under the provisions of Section 501(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator believes that the Plan was designed and is being operated in compliance with applicable regulations, and therefore believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

#### **Note 4. Tax Status (continued)**

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 5. Information Certified by Plan Trustee**

The following information in the accompanying financial statements and ERISA-required supplemental schedule, as of December 31, 2024 and 2023, and for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

#### **Note 6. Fair Value Measurements**

The *Fair Value Measurements and Disclosures* Topic of the FASB Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

### Level 1 Measurements

The fair values of the registered investment companies are determined by reference to the underlying assets, which are principally marketable equity and fixed income securities. Shares held in registered investment companies are traded on national securities exchanges and are valued at the net asset value as of the last business day of each period presented.

## **Note 6. Fair Value Measurements (continued)**

### Measurements Using Net Asset Value as a Practical Expedient

The common collective trust is valued at the net asset value per share, used as a practical expedient to estimate fair value. The net asset value is based on the fair values of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

The common collective trust is a direct filing entity (DFE) and files a Form 5500 annual report with the U.S. Department of Labor. The Plan is not required to disclose the significant investment strategies of DFE investments. Redemptions are available on a daily basis without notice.

## **Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of American Society of Plastic Surgeons 401(k) Plan (the Plan) as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing auditing procedures for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

Management has determined it is permissible in the circumstances and has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, as permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses, and therefore, material weaknesses may exist that were not identified. However, as discussed below, we identified a deficiency in internal control that we consider to be a material weakness.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis. The attached Memorandum identifies a deficiency in internal control that we consider to be a material weakness.

This communication is intended solely for the information and use of Plan management, the Employee Benefit Committee and others within the Plan, and is not intended to be and should not be used by anyone other than these specified parties.

We will review the status of the deficiency in internal control during our next audit engagement. Material weaknesses that have not yet been remediated are required to be repeated in subsequent years' communications. We have already discussed the deficiency in internal control with certain members of Plan management, and we will be pleased to discuss it in further detail at your convenience, to perform any additional study, or to assist you in implementing any recommendations.

This letter does not affect our report dated August 29, 2025 on the financial statements of American Society of Plastic Surgeons 401(k) Plan.

Management's written response to the material weakness identified herein has not been subjected to our audit procedures, and accordingly, we express no opinion on it.

## Memorandum

### *Material Weakness*

#### **Preparation of Financial Statements**

During our audit, we noted that the Plan retains competent professionals who understand the Plan's operations and its challenges. The Plan's Trustee records the day-to-day transactions of the Plan and provides a year end summary. However, the preparation of annual financial statements is not included in the services provided by this organization. As a result, the Plan engaged us to prepare the Plan's financial statements in accordance with accounting principles generally accepted in the United States of America, including the appropriate footnote disclosures. The potential effect of this control deficiency is that a misstatement or omission in the financial statements would not be prevented, detected or corrected on a timely basis.

#### Recommendation

We recommend that management evaluate the situation. Management should consider the amount of additional expense the Plan would incur as a result of training or hiring individuals with the necessary skills or knowledge to produce the Plan's financial statements including footnote disclosures.

#### *Management Response*

*We have discussed the options concerning the Plan obtaining the capabilities of preparing financial statements that would not require significant changes by the auditor. We have decided that it would not be cost beneficial to change from the present procedures. We believe it is in the best interest of the Plan to continue to retain the auditing firm to prepare the Plan's financial statements in conjunction with the year end audit.*
