Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed an audit of the financial statements of Markon, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Markon, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or Federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Markon, LLC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Markon, LLC 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Markon, LLC 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

1. DESCRIPTION OF PLAN

The following description of the Markon, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Markon, LLC (the Company or Plan Sponsor).

Prior to August 2023, Markon, LLC was a participating employer in the Anser Advisory, LLC 401(k) Profit Sharing Plan. Effective August 8, 2023, Markon, LLC was spun-off from the Anser Advisory controlled group. The Markon, LLC 401(k) Plan was established via a spin-off from the Anser Advisory, LLC 401(k) Profit Sharing Plan, with an effective date of January 1, 2023. The effective date of the Elective Deferral component of the Plan, which is also the first Entry Date for the Elective Deferral component of the Plan, was August 1, 2023. The Plan did not have any activity before August 2023.

Markon, LLC has the responsibility for remittance of participant and employer contributions, appointing a committee to administer the Plan, and determining funds available for investment under the Plan.

Markon, LLC pays for a portion of the administrative expenses and provides administrative and accounting services for the Plan.

Plan Transfers

On August 8, 2023, the Anser Advisory, LLC 401(k) Profit Sharing Plan transferred assets of \$37,577,117 to the Plan as shown on the prior year statement of changes in net assets available for benefits. The transferred assets included those of the Markon, LLC participants in the Anser Advisory, LLC 401(k) Profit Sharing Plan.

Eligibility Requirements

Employees, other than union employees and nonresident aliens, are eligible to participate upon immediate employment with the attainment of 21 years of age and two months of service.

Contributions

Each year, participants may elect to contribute a percentage of pretax annual compensation, as defined in the Plan. Participants may also make Roth (after-tax) elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. The Plan currently offers various common/collective trusts and mutual funds as investment options for participants.

Through March 2024, the Company made a safe harbor matching contribution equal to 100 percent of employee contributions, not to exceed 3 percent of compensation plus 50 percent of employee contributions, that exceeds 3 percent of compensation, not to exceed 5 percent of compensation. Effective April 2024, the Company contributed an additional 0.20 percent for each additional one percent an employee deferred over 5 percent not to exceed 10 percent of compensation deferred.

1. DESCRIPTION OF PLAN (continued)

Contributions (continued)

The Company may make discretionary employer profit sharing contributions to the Plan. The discretionary profit sharing will be allocated to participants at a ratio equal to the ratio of individual eligible compensation to the total eligible compensation paid to all eligible participants of the Plan. The participant must be an active employee of the Company on the last day of the Plan year to receive an allocation of the discretionary profit-sharing contribution. There were no discretionary contributions for the years ended December 31, 2024 and 2023.

The Plan automatically enrolls eligible participants for a 3 percent of compensation deferral under its automatic enrollment feature, unless the participant elects an alternative deferral amount or elects not to defer under the Plan in accordance with the deferral procedures of the Plan. If an eligible employee was automatically enrolled in the Plan, and did not make changes to the percentage automatically enrolled in, the elective deferral percentage will be increased in the year following the anniversary date of the first year automatically enrolled and on January 1 of each of the following years up to a maximum of 6 percent of compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or individual account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, if any, plus actual earnings thereon.

A participant will vest in the employer safe harbor qualified automatic contribution arrangement and match contributions as follows:

A participant will vest in the employer nonelective contributions as follows:

Regardless of the vesting schedule, a participant is fully vested in the event of permanent or total disability, or death. Participants with merged assets from the previously terminated Markon, LLC Retirement Plan are 100 percent vested in any merged or future contributions to their profit sharing or regular matching accounts.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 minus the highest outstanding loan amount during the prior 12-month period, or 50 percent of the participant's vested account balance.

Loans must be repaid within 5 years, unless the loan is used for the purchase of a primary residence. Loans bear interest at 1 percent above the prime rate. The loans are secured by the vested balance in the participant's account. Principal and interest is paid ratably through payroll deductions. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive the value of the participant's vested interest in his or her account as a lump sum amount. Upon termination of employment, if an account balance (excluding rollovers) is less than \$5,000, the participant will be forced out of the Plan.

In-service distributions may be made to a participant who has not separated from service after the participant has reached aged 59½.

Hardship Distributions

Hardship distributions are permitted from accounts that are fully vested. The minimum hardship distribution amount allowed is \$500, with a maximum of one distribution per participant per Plan year.

Forfeited Accounts

Forfeited balances resulting from the termination of nonvested participants may be used to reduce the Company's future contributions or administrative expenses of the Plan. There were balances of approximately \$28,000 and \$4,000 in the forfeiture account as of December 31, 2024 and 2023, respectively. Approximately \$18,000 and \$-0- of forfeitures were used for the years ended December 31, 2024 and 2023, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The accounting and reporting policies used in the financial statements conform to U.S. generally accepted accounting principles. The significant policies are summarized below.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Financial Statement Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

As permitted by U.S. generally accepted accounting principles, the Plan uses net asset value (NAV) as a practical expedient to determine the fair value of certain investments, and these investments have not been classified in the fair value hierarchy.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Income Taxes

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses, including fees paid through revenue sharing arrangements, are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date which the financial statements were available to be issued.

3. CERTIFIED FINANCIAL INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements as of December 31, 2024 and 2023, the ERISA-required supplemental schedule of Form 5500 - Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the custodian and trustee of the Plan.

4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value focuses on the price that would be received to sell the asset or paid to transfer the liability regardless of whether an observable liquid market price existed (an exit price). The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – inputs to the valuation methodology are based upon unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, inputs other than quoted prices that are observable for the asset or liability, and market-corroborated inputs. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement. Level 3 assets and liabilities measured at fair value are based on one or more of three valuation techniques (market, cost, or income approach). The market approach evaluates prices and other relevant information generated by market transactions involving identical or comparable assets or liabilities. The cost approach evaluates the amount that would be required to replace the service capacity of an asset (i.e., replacement cost). The income approach uses techniques that convert future amounts to a single present amount based on market expectations (including present value techniques, option-pricing models, and lattice models).

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the Plan's assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that pool the capital of many investors and invest it in stocks, bonds, short-term money market instruments, and other securities. Mutual funds are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Valued based on the NAV per share of the individual trusts included in each respective fund, which is based on the fair value of the underlying assets. The NAV is used as a practical expedient to estimate fair value.

4. FAIR VALUE MEASUREMENTS (continued)

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. RELATED PARTY TRANSACTIONS

Through December 31, 2024, Reliance Trust Company was the Plan's custodian and trustee (see Note 3), and Automatic Data Processing, Inc. Retirement Services (ADP) was the Plan's third-party administrator. Plan assets include investments in mutual funds and common/collective trusts, which are managed by the custodian. As ADP is the Plan's third-party administrator and Reliance Trust Company is the Plan's custodian, transactions with these entities qualify as party-in-interest transactions under ERISA.

The Plan made a direct payment to the third party administrator, which was not covered by revenue sharing, which is shown as administrative expenses on the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023. The Plan Sponsor pays directly any other fees related to the Plan's operations.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

8. TAX STATUS

Through December 31, 2024, the Plan adopted a Non-Standardized Pre-Approved Plan with an opinion letter dated October 6, 2020, in which the Internal Revenue Service stated that the form of the plan was acceptable for use by employers for the benefit of their employees under IRC Section 401. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and continues to be tax-exempt.

9. RISKS AND UNCERTAINTIES

The Plan invests in a combination of investment securities that are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

10. TRANSFER FROM ANSER ADVISORY, LLC 401(k) PROFIT SHARING PLAN

On August 8, 2023, the Anser Advisory, LLC 401(k) Profit Sharing Plan transferred the plan assets attributed to Markon, LLC's participants to the Plan via a spin-off. A summary of the transferred net assets is as follows:

11. SUBSEQUENT EVENTS

Subsequent to year end, the Plan changed its custodian from Reliance Trust Company to Principal Financial Group on January 1, 2025. On that date, the Plan initiated the transfer of all Plan assets, and all assets had been transferred out of Reliance Trust Company and were deposited into Principal's account effective January 2, 2025.

Effective January 1, 2025, the Plan was restated and it adopted a Non-Standardized Pre-Approved Profit Sharing Plan with an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the form of the plan is acceptable for use by employers for the benefit of their employees under IRC Section 401.
