NOTES TO THE FINANCIAL STATEMENTS**

NOTE 1 DESCRIPTION OF PLAN

The following description of The Iowa Clinic P.C. Employee Benefit Trust - Dental Premium Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan.

General

The Plan provides dental benefits covering all eligible employees of The Iowa Clinic, P.C. as the plan sponsor, as well as eligible employees of all other participating eligible employers who have adopted the plan, and their eligible dependents. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits

The Plan provides dental benefits, as outlined in the Plan document, covering all regular full-time and regular part-time employees of participating employers and their eligible dependents. Eligible enrolled dependents include a covered employee's spouse and children (with certain restrictions).

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections, which are determined annually by the Plan sponsor. Delta Dental, the third party administrator of the Plan, acts as claims paying agent of the Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Claim payments are recorded when submitted to the Plan by the claims processor for reimbursement. Claims incurred but not reported are included in the accompanying statement of benefit obligations.

NOTES TO THE FINANCIAL STATEMENTS**

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Claims Incurred but not Reported

Claims incurred but not reported are estimated by the Plan's management based on claims paid in the six months subsequent to year end. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Uncertain Tax Position

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has evaluated their material tax positions and determined there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 3 BENEFIT OBLIGATIONS

Plan benefit obligations at December 31, 2024 of \$21,562 represent the estimate of health claims incurred by active participants but not paid. Total claims reported and approved for payments, including benefits reclassified from benefit obligations were \$587,624 for the year ended December 31, 2024.

NOTE 4 ADMINISTRATION FEES

The Plan pays administration fees that consist primarily of fees paid to third-party claims administrators, audit fees, consulting fees, and wellness program expenses. All other administrative expenses are paid by the employer on behalf of the Plan.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intention to do so, The Iowa Clinic, P.C. reserves the right to terminate the Plan subject to the provisions set forth in ERISA. If the Plan is terminated, all eligible claims outstanding at that time will be paid in full or paid on a prorated basis.

NOTE 6 TAX STATUS

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to section 501(c)(9) of the Internal Revenue Code as a tax exempt organization. The Plan sponsor believes that the Plan continues to qualify and to operate as designed.

NOTE 7 ADMINISTRATION OF PLAN ASSETS

Certain administrative functions are performed by officers or employees of the Plan sponsor. No such officer or employee receives compensation from the Plan.

Employees of the Plan Administrator participate in the Plan.



