Notes to the Financial Statements

Years Ended December 31, 2024 and 2023

1. Description of Plan

The following description of the Wilson Logistics, Inc 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Wilson Logistics, Inc. and Transportation Management Group (collectively "the Company") who have completed 60 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants may make elective deferral contributions up to 100% of their wages, not to exceed the statutory limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes employer matching contributions equal to 100% of the first 3% of the participant's compensation which is deferred as a salary reduction.

Participant accounts: Each participant's account is credited with (a) the participant's contribution, (b) the Company's matching contributions (if any), and (c) plan earnings. Net income and asset revaluations are allocated to each participant based upon the earnings of the investments selected by the participant. These are allocated based upon the participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately 100% vested in their elective deferral contributions plus actual earnings thereon. Vesting in any employer matching or non-elective contributions are based on years of credited service. A participant is fully vested after five years of credited service.

Payment of benefits: A distribution of a participant's vested account balance can be made due to hardship, attainment of age 59½, death, disability, retirement, qualified military service, when required by law, or upon termination of service with the Company. Distribution payments can be made in the form of a rollover, lump-sum amount, installments of substantially equal amounts over a period of time, or a combination of the above.

A distribution of a participant's rollover balance can be made at any time regardless of the limitations described above.

Participants who terminate service and have account balances of \$5,000 or less will receive an automatic distribution of their vested balance. Participants with account balances that exceed \$5,000 may elect to receive a lump-sum amount equal to the value of the vested interest in their account or installments for a fixed period not to exceed their assumed life expectancy. Benefit payments are recorded when paid.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account, whichever is less. The loan terms may not exceed 60 months and are secured by the balance in the participant's account and bear interest at rates ranging from 8.75% to 9.5%, which are equal to 1% above the prime interest rate on the date of issuance. Principal and interest are paid ratably through payroll deductions.

Forfeitures: Forfeitures of employer contributions may be used to reduce required employer contributions. Forfeitures in the amounts of \$22,193 and \$14,637 were used to reduce employer contributions for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, remaining forfeitures in the amounts of \$12,942 and \$4, respectively, were available to be used in future years.

2. Summary of Accounting Policies

Basis of accounting: The Plan's policy is to prepare its financial statements on the accrual basis of accounting; consequently, certain revenue and the related assets are recognized when earned rather than when received, and certain expenses are recognized when the obligation is incurred rather than when paid. Benefit payments to participants are recorded upon distribution.

Accounting estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Investment valuation and income recognition: Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Subsequent events: Management has evaluated subsequent events between the end of the most recent fiscal year end and October 7, 2025, the date the financial statements were available to be issued.

3. Risks & Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

5. Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by ADP Retirement Trust Services, LLC for the year ended December 31, 2024 and Voya Institutional Trust Company for the year ended December 31, 2023 and for the period January 1, 2024 through January 9, 2024 (the custodians).

6. Separated Participants

At December 31, 2024, \$21,859 of the net assets available for benefits were for those participants who have separated from active service with the Company with a balance of less than \$5,000, and are due a distribution in accordance with the plan document.

7. Tax Status

The prototype plan document adopted by the Plan, obtained its latest determination letter on June, 30, 2020, in which the Internal Revenue Service stated that the prototype plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code and, therefore, not subject to tax. The Plan has been amended since receiving the determination letter. The plan administrator believes that the Plan and related trust are currently designed in compliance with the applicable requirements of the Internal Revenue Code.

During the plan years ended December 31, 2024 and 2023, the Plan's operations were not in accordance with certain plan provisions. These departures from plan provisions could have an unfavorable effect on the Plan's tax qualification; however, the plan administrator is taking corrective action and has put appropriate procedures in place to prevent future departures. The plan sponsor believes these measures will bring the Plan into compliance with the Plan document.

The plan administrator has analyzed tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. A tax liability would be recognized if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets and liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual and money market funds: Valued at the daily closing price as reported by the fund. Mutual and money market funds held by the Plan are open-ended funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual and money market funds held by the Plan are deemed to be actively traded.

Common collective trust funds: The Plan invests in common collective trust funds, which are commingled funds maintained by banks or trust companies that are not registered with the SEC. The funds are valued at net asset value (NAV), which is based on the fair value of the underlying assets of the fund less its liabilities. The funds held by the Plan are deemed to be actively traded.

Guaranteed interest accounts: Valued at the net asset value of units held by the trust provider using the net asset value of the shares of the underlying funds adjusted for income and expenses of the trust.
