We conducted our audit consistent with the planned scope and timing we previously communicated to you.

Compliance with All Ethics Requirements Regarding Independence

The engagement team, others in our firm, as appropriate, and our firm have complied with all relevant ethical requirements regarding independence.

As communicated in our engagement letter, our performance of nonattest services does not include assuming management responsibilities or making management decisions. In relation to such nonattest services, you have agreed to assume all management responsibilities for the nonattest services we provide; oversee the services by designating an individual, preferably from senior management, with suitable skill, knowledge, or experience; evaluate the adequacy and results of the services; and accept responsibility for them. However, the performance of nonattest services creates the potential for circumstances that may impair independence ("threats"). We have identified and evaluated the self-review and management participation threats created by our performance of nonattest services. In order to reduce such threats to an acceptable level, we have taken certain measures or actions ("safeguards"), including the following:

- Policies and procedures that are designed to implement and monitor engagement quality control;
- The involvement of another professional accountant who (a) reviews the work that is done for a client or (b) otherwise advises the engagement team. This individual is someone from within the firm who is not otherwise associated with the engagement; and
- Policies and procedures that are designed to ensure that members of the engagement team do not make or assume responsibility for management decisions for the client.

Qualitative Aspects of the Plan's Significant Accounting Practices

Significant Accounting Policies

Management has the responsibility to select and use appropriate accounting policies. A summary of the significant accounting policies adopted by the Plan is included in Note 1 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the year ended December 31, 2024. No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

Significant Accounting Estimates

Accounting estimates are an integral part of the financial statements and are based on management's current judgments. Those judgments are normally based on knowledge and experience about past and current events and assumptions about future events. We evaluated the key factors and assumptions used to develop the information used in the financial statements and determined that they are reasonable in relation to the basic financial statements taken as a whole.

Financial Statement Disclosures

Certain financial statement disclosures involve significant judgment and are particularly sensitive because of their significance to financial statement users. There are no financial statement disclosures that are particularly sensitive because of their significance to financial statement users.

Significant Difficulties Encountered during the Audit

We encountered no significant difficulties in dealing with management relating to the performance of the audit.

Uncorrected and Corrected Misstatements

For purposes of this communication, professional standards also require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of management. No misstatements were noted during our audit.

Disagreements with Management

For purposes of this letter, professional standards define a disagreement with management as a matter, whether or not resolved to our satisfaction, concerning a financial accounting, reporting, or auditing matter, which could be significant to the Plan's financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of the audit.

Representations Requested from Management

We have requested certain written representations from management that are included in the management representation letter dated August 29, 2025.

Management's Consultations with Other Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters. Management informed us that, and to our knowledge, there were no consultations with other accountants regarding auditing and accounting matters.

Other Significant Matters or Issues

In the normal course of our professional association with the Plan, we generally discuss a variety of matters, including the application of accounting principles and auditing standards, significant events or transactions that occurred during the year, business conditions affecting the Plan, and business plans and strategies that may affect the risks of material misstatement. None of the matters discussed resulted in a condition to our retention as the Plan's auditors.

Reportable Findings

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit the attention of management and governance.

Significant and relevant to you regarding your responsibility to oversee the financial reporting process are the following reportable finding:

- The Employee Benefit Committee historically meets once per year. The Committee performs an important fiduciary role to the Plan and its meetings help to ensure the Plan Sponsor's fiduciary responsibilities are being met. We recommend the Committee consider meeting more often, at least twice a year. Furthermore, the minutes properly documented the meeting date, time, and attendees as well as meeting agenda, decisions made, and resulting action items. However, the Committee should consider items such as compliance with ERISA regulations, evaluation of service providers and related fees, review and approval of the annual audit report and any communications, and discussion of any employee complaints or concerns, or the lack thereof.

We have also identified certain internal control deficiencies and have provided our comments in a separate letter to you dated August 29, 2025.

Other Matter

The ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, was subjected to the audit procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or the financial statements themselves, and other additional procedures in accordance with GAAS. In addition, we made certain inquiries of management and evaluated the form, content and methods of preparing the information in the ERISA-required supplemental schedule to determine that the information complies with the DOL's Rules and Regulation for Reporting and Disclosure under ERISA.

Intended Use of This Letter

This report is intended solely for the information and use of the Employee Benefit Committee and management of the Plan and is not intended to be and should not be used by anyone other than this specified party.

Report of Independent Auditors

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ASPS Defined Contribution Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting; and
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Basis of Accounting

We draw attention to Note 1 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, as described in Note 1, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Auditors' Responsibilities for the Audit of the Financial Statements (continued)

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit;
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements;
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed;
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements; and
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

December 31, 2024 and 2023

Note 1. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements of ASPS Defined Contribution Plan (the Plan) have been prepared on the cash basis of accounting, modified to record assets or liabilities that arise from cash transactions and events which provide a benefit or result in an obligation that covers a period greater than the period in which the cash transactions or events occurred. Except for unrealized gains or losses on investments, all transactions are recognized as either revenue or expenses when received or paid in cash. The modified cash basis of accounting is a basis of accounting other than accounting principles generally accepted in the United States of America (GAAP).

Investments - Investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of the investments are reflected on a trade-date basis.

Payment of Benefits - Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan who were not yet paid at either December 31, 2024 or 2023.

Expenses - Certain administrative expenses of maintaining the Plan are paid by the Plan's sponsor and are excluded from these financial statements. Administrative expenses paid by the Plan, including transactional fees related to the administration of participants' accounts, are charged directly to participants and are included in administrative expenses. Certain investment related expenses are included in net appreciation in fair value of investments.

Estimates - The preparation of financial statements requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Subsequent Events - Subsequent events have been evaluated through August 29, 2025, which is the date the financial statements were available to be issued.

Note 2. Description of the Plan

The Plan was established to provide retirement benefits for eligible employees of American Society of Plastic Surgeons (the Society). The Plan is funded by contributions from the Society, and by the net earnings of the investments of the Plan. The Plan is a single employer defined contribution retirement plan covering all eligible employees of the Society who are 21 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Benefits under the Plan are not insured by the Pension Benefit Guaranty Corporation.

Under current provisions of the Plan, employees are eligible to participate after being credited with one year of eligibility service. A year of eligibility service is earned once an employee is credited with at least 1,000 hours of service during the applicable determination period. Plan entry date is the first day of the month following the eligibility requirement being met.

Employer contributions are paid at 6% of each participant's eligible compensation, as defined by the Plan.

A participant's account becomes vested and non-forfeitable upon the completion of three years of vested service. A year of vesting service is earned during a Plan year in which a participant is credited with at least 1,000 hours of service.

Upon enrollment in the Plan, a participant may direct contributions to various investment options. In the absence of participant direction, contributions are invested in a default investment fund. Participants must evaluate their own investment goals and objectives and choose investments best suited to achieve those goals and objectives. Poor investment performance by the funds selected by the participants may cause their vested balances to be lower than the amounts contributed to the Plan on their behalf. Participants may change their investment options daily.

In December 2022, the Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0 was enacted and increased the required minimum distribution age 73 to effective in 2023 and as late as 75 effective in 2033. The Plan also was amended pursuant to optional provisions of SECURE Act 2.0 to raise the required account balance threshold for an automatic lump-sum distribution to be made to a terminated participant from \$5,000 to \$7,000.

Each participant's account is credited with employer contributions made on their behalf, and an allocation of Plan earnings or losses thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit provided from the participant's vested account.

Upon termination of service due to death, disability or retirement, participants are eligible to receive a lump-sum amount equal to the value of the participant's vested interest in their account. Normal retirement under the Plan is the attainment of age 65.

Note 2. Description of the Plan (continued)

Net assets available for benefits included forfeited nonvested accounts of \$6,507 and \$6,339 as of December 31, 2024 and 2023, respectively. Forfeitures are available to pay Plan administrative expenses and to reduce future employer contributions. No forfeitures were used during the years ended December 31, 2024 and 2023.

Participants should refer to the summary plan description for more complete information.

Note 3. Priorities upon Termination

Although it has not expressed any intent to do so, the Society has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account.

Note 4. Tax Status

The Internal Revenue Service has advised that the Plan (a prototype plan), as designed, is a qualified plan under Internal Revenue Code Section 401(a), and is therefore exempt from federal income taxes under the provisions of Section 501(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator believes that the Plan was designed and is being operated in compliance with applicable regulations, and therefore believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

The Plan is required to evaluate its tax positions and disclose the amount of a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Information Certified by Plan Trustee

The following information in the accompanying financial statements and ERISA-required supplemental schedule, as of December 31, 2024 and 2023, and for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

Note 6. Fair Value Measurements

The Plan prepares its financial statements on the modified cash basis of accounting. Because one of the modifications to the cash basis that the Plan has made is to carry its investments at fair value, the *Fair Value Measurements and Disclosures* Topic of the FASB Accounting Standards Codification, which established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, has been implemented by the Plan. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

The following tables set forth, by level within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. As required, assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the following tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

Level 1 Measurements

The fair values of the registered investment companies are determined by reference to the underlying assets, which are principally marketable equity and fixed income securities. Shares held in registered investment companies are traded on national securities exchanges and are valued at the net asset value as of the last business day of each period presented.

Measurements Using Net Asset Value as a Practical Expedient

The common collective trust is valued at the net asset value per share, used as a practical expedient to estimate fair value. The net asset value is based on the fair values of the underlying investments held by the fund less their liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

The common collective trust is a direct filing entity (DFE) and files a Form 5500 annual report with the U.S. Department of Labor. The Plan is not required to disclose the significant investment strategies of DFE investments. Redemptions are available on a daily basis without notice.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

At December 31, 2024 and 2023, the Plan held a significant portion of its assets in one investment fund, a common collective trust with a fair value of \$1,761,606 and \$1,478,367 respectively, which represented approximately 22% and 22%, respectively, of net assets available for benefits. The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across the participant directed fund elections. Additionally, the investments within each participant directed fund election are further diversified into varied financial instruments. Investment decisions are made, and the resulting risks are borne, exclusively by the Plan participant who made such decisions.

Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of ASPS Defined Contribution Plan (the Plan) as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing auditing procedures for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

Management has determined it is permissible in the circumstances and has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, as permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements of information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis. The attached Memorandum identifies a deficiency in internal control that we consider to be a material weakness.

A significant deficiency is a deficiency, or combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. The attached Memorandum identifies a deficiency in internal control that we consider to be a significant deficiency.

This communication is intended solely for the information and use of Plan management, the Employee Benefit Committee and others within the Plan, and is not intended to be and should not be used by anyone other than these specified parties.

We will review the status of these deficiencies in internal control during our next audit engagement. Material weaknesses and significant deficiencies that have not yet been remediated are required to be repeated in subsequent years' communications. We have already discussed these deficiencies in internal control with Plan personnel, and we will be pleased to discuss them in further detail at your convenience, to perform any additional study, or to assist you in implementing any recommendations.

This letter does not affect our report dated August 29, 2025 on the financial statements of ASPS Defined Contribution Plan.

Management's written response to the material weakness identified herein has not been subjected to our audit procedures, and accordingly, we express no opinion on it.

Memorandum

Material Weakness

Preparation of Financial Statements

During our audit, we noted that the Plan retains competent professionals who understand the Plan's operations and its challenges. The Plan's Trustee records the day-to-day transactions of the Plan and provides a year end summary. However, the preparation of annual financial statements is not included in the services provided by this organization. As a result, the Plan engaged us to prepare the Plan's financial statements in accordance with the modified cash basis of accounting, including the appropriate footnote disclosures. The potential effect of this control deficiency is that a misstatement or omission in the financial statements would not be prevented, detected or corrected on a timely basis.

Recommendation

We recommend that management evaluate the situation. Management should consider the amount of additional expense the Plan would incur as a result of training or hiring individuals with the necessary skills or knowledge to produce the Plan's financial statements including footnote disclosures.

Management Response

We have discussed the options concerning the Plan obtaining the capabilities of preparing financial statements that would not require significant changes by the auditor. We have decided that it would not be cost beneficial to change from the present procedures. We believe it is in the best interest of the Plan to continue to retain the auditing firm to prepare the Plan's financial statements in conjunction with the year end audit.

Significant Deficiency

Forfeitures Account

During our audit procedures, we noted several participants whose accounts incurred forfeitures based on omissions in their employment data (date of hire) in the Plan recordkeeper's system. Such omissions result in the Plan's vesting schedule being incorrectly applied to participant accounts. These errors can lead to costly corrections, including allocating forfeitures as employer contributions if not detected on a timely basis. For those participants who received credit for lost earnings, it appears that the forfeiture account was used for the interest received. The Plan document only allows the forfeiture account to be used to pay Plan expenses or to reduce employer contributions. It appears that the forfeiture account balance at January 1, 2024 consisted of amounts forfeited in 2023 that were not used through December 2024. The Internal Revenue Code (IRC) requires that these forfeited accounts be used in accordance with the terms of the Plan document in the Plan year they are incurred.

Recommendation

We understand that the Plan Administrator directed the custodian recordkeeper to correct the errors by having the recordkeeper restore the forfeitures to the affected participant accounts. Plan management should also consider consultation with ERISA counsel and the third-party recordkeeper to determine if an official correction is necessary to ensure the Plan remains in compliance with ERISA and IRC regulations. Finally, we recommend that the Plan Administrator continue to review all transactions for accuracy and periodically spot-check reports received from the recordkeeper for any errors.
