***Independent Auditor's Report***

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

**NOTE 1: DESCRIPTION OF PLAN**

The following description of the Gift of Life Donor Program 403(b) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering eligible employees of the Greater Delaware Valley Society of Transplant Surgeons d/b/a Gift of Life Donor Program (Organization), a qualified 501(c)(3) organization along with Transplant House and Transplant Foundation. The Plan was established and originally effective January 1, 1980, to provide eligible employees the opportunity to accumulate savings that provide benefits in the event of retirement, disability, or death. The Plan is structured to comply with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Organization retains Lincoln Financial Group Trust Company, Inc. and Lincoln National Life Insurance Company (Lincoln) as the institutional custodians. Lincoln Financial Group is retained as the third-party administrator to maintain the assets of the Plan and to perform recordkeeping services.

**Eligibility** - All employees, except for those under a collective-bargaining agreement, nonresident aliens with no U.S. source income, per diem employees, interns, and individuals who are not on the U.S. payroll of the employer or a related employer, are eligible to make salary deferrals. Employees are eligible to receive employer discretionary matching and profit-sharing contributions after completing one year of service. Employees may enter the Plan during the first payroll period coinciding with or the next payroll period following the attainment of the eligibility requirements.

**Contributions** - Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also designate all or a portion of their elective deferral as after-tax Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans as defined in the plan document (rollover). The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Participants direct the investment of their contributions into various investment options offered by the Plan. For eligible employees, the Organization may contribute an employer-matching and discretionary contribution. For the years ended December 31, 2024 and 2023, the Organization made a matching contribution of 100% of each participant's contribution up to 5% of eligible compensation.

***Contributions - Continued***

The Organization may make a discretionary contribution to an allocation group based on the participant's date of hire as follows: Group 1 - all eligible participants who are credited with one hour of service on or prior to December 31, 1999, will receive a contribution equal to 8% of compensation or any other amount determined by the Organization, and Group 2 - all eligible participants who were credited with one hour of service on or after January 1, 2000, will receive a contribution equal to 6% of compensation or any other amount determined by the Organization. The Organization made discretionary contributions of \$1,736,605 and \$1,529,991, for the 2024 and 2023 plan years, respectively.

***Participant Accounts*** - Each participant's account is credited with the participant's contributions and the Organization's discretionary match and profit-sharing contributions as well as allocations of investment gains/losses. Participants are also charged with the allocation of administrative expenses that are not covered by the Organization. Certain administrative expenses are netted against the earnings of the investment alternatives held by the participants. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting*** - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based on years of credited service. A participant becomes 25% vested after two years of service. An additional 25% is attained each year thereafter until the participant is 100% vested after five years of credited service. A participant also becomes fully vested upon death or disability.

***Notes Receivable from Participants*** - Participants may borrow from their elective deferral and rollover accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 (reduced by the excess, if any, of the participant's highest outstanding loan balance during the one-year period) or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at prime plus 1%. Participant loans must be repaid within five years unless the loan is for a primary residence, in which case the loan may be repaid within 15 years.

***Payment of Benefits*** - Upon retirement, disability, or termination, a participant may elect to receive a lump-sum payment, partial lump-sum, installment distributions, or delay withdrawal until a future date. Benefit payments will commence the later of April 1 following the calendar year in which the participant becomes 73 or termination of employment. For participants who reach age 73 in 2024, the participant must take their first RMD by April 1, 2025 and the second RMD by December 31, 2025. Participants may rollover a distribution from the Plan directly to an eligible retirement plan specified by the participant. If the payment is to a beneficiary that is not the spouse, a direct rollover is only payable to an individual retirement account or individual retirement annuity that has been established on behalf of the beneficiary as an inherited IRA. A participant may withdraw certain vested account balances upon

*Payment of Benefits - Continued* - attainment of age 59½, occurrence of a hardship, or upon attainment of normal retirement age (age 65), as defined in the plan document. If a terminated participant does not elect to have a mandatory distribution not exceeding \$1,000 paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, the plan administrator will direct the trustee to immediately distribute such benefit in a lump sum without the participant's consent. For any distribution exceeding \$1,000, but not in excess of \$5,000, the participant shall be given the option to elect to have such distribution paid directly to an eligible retirement plan specified by him or her in a direct rollover or to receive the distribution directly. If neither option is selected, the plan administrator shall make such distribution in a direct rollover to an individual retirement plan designated by the plan administrator and shall provide written notice to the participant informing the participant that he or she has the option to transfer such amount into another individual retirement plan of his or her own choice.

*Forfeited Accounts* - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$25,577 and \$24,679, respectively. These accounts can be used to pay administrative expenses and to reduce future employer contributions. During 2024 and 2023, the employer offset \$97,313 and \$48,185, respectively of employer contributions from the forfeiture account.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting* - The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

*Use of Estimates* - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* - Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received for the sale of an asset or paid for the transfer of a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

*Investment Valuation and Income Recognition - Continued*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivables from Participants* - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant is issued a 1099-R. Delinquent participant loans are reclassified as distributions based upon terms of the plan document.

*Excess Contributions Payable* - Amounts payable for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding corrective distribution entry.

*Payment of Benefits* - Benefits are recorded when paid.

*Administrative Expenses* - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses paid by the Organization are excluded from these financial statements. Costs associated with participant-initiated transactions are paid by the respective participants' accounts. Administrative expenses of the Plan are partially paid by the Plan and partially absorbed by the plan sponsor. Administrative expenses paid from plan assets consisted of \$184,471 in administration expenses to Lincoln, \$6,935 in loan and participant fees to Lincoln, \$25 fees for MFGVA, and \$108,277 in advisory fees to Cornerstone Institutional Investors.

*Subsequent Events* - The Organization's policy is to evaluate events and transactions subsequent to its year end for potential recognition in the financial statements or disclosure in the notes to the financial statements. The plan administrator has evaluated events and transactions through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

**NOTE 3: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) Topic 820, *Fair Value Measurements*, are described as follows on the next page:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

**Registered Investment Companies (Mutual Funds)** - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective Trusts** - Public investment vehicles valued using the NAV provided by the custodians. The NAV is based on the value of the underlying assets owned by the trust minus its liabilities, divided by the number of shares outstanding. The NAV is not a quoted price in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4: FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

The Plan holds a traditional guaranteed annuity contract. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed annuity contract. The contract issuer is required to repay the principal and interest at a specified rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and is 1% based on the contract.

Participant-initiated withdrawals to a competing fund, as defined in the contract, are not permitted. In addition, withdrawals will not be permitted for 90 days after a transfer from any other investment option in the Plan to a competing fund. If a withdrawal from the contract is allowed for a participant, transfers thereafter from any other investment option in the Plan to a competing fund will not be permitted for 90 days. The Plan may request termination of the contract under the five-yearbook value installment option. If this option is specified, the plan account will be paid in six annual payments to a trustee of the Plan or to a financial institution designated by the employee.

The Plan may request termination of the contract under the market value payment option. If this option is specified, the plan account is reduced by a market value factor that will be paid in a lump sum at the termination date.

**NOTE 5: INFORMATION CERTIFIED BY THE CUSTODIANS**

The Plan's investments as of December 31, 2024 and 2023, were held by Lincoln Financial Group Trust Company, Inc. and Lincoln National Life Insurance Company (Lincoln). The plan administrator elected the method of annual reporting compliance permitted by Department of Labor (DOL) Reg. Section 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 6: RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Organization does not consider normal plan operations such as participant and employer contributions or benefits paid to participants as party-in-interest transactions that require separate disclosure. Certain plan investments are shares of registered investment companies, units of a collective trust, and a guaranteed annuity contract managed by Lincoln. Some fees incurred by the Plan are paid with revenue sharing dollars accumulated in an expense account. Participant loan origination and distribution fees are paid out of the relevant participants' accounts. The plan sponsor partially absorbs plan expenses. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

**NOTE 7: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their account balances, and any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Organization may determine.

**NOTE 8: TAX STATUS**

The underlying Principal prototype non-standardized 403(b) plan document has obtained an advisory letter on March 31, 2017, in which the Internal Revenue Service (IRS) states that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or DOL. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan's federal Form 5500 is subject to examination by the IRS and the DOL, generally for three years after it is filed.

**NOTE 9: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**NOTE 10: COMMITMENTS AND CONTINGENCIES**

In the normal course of business, there may be various commitments and contingencies outstanding, which are not reflected in these financial statements.
