1. Plan Description

The following description of the Employees' Savings Plan of Madico, Inc. (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Plan includes employees of Madico, Inc. and affiliates Vacuum Depositing, Inc. LLC and Lintec of America (collectively, the "Company" or "Plan Sponsor").

- a) *General* – The Plan is a defined contribution 401(k) plan covering eligible employees of the Company. The Plan was established by the Company on January 1, 1984. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Reliance Trust Company serves as the trustee. An employee of the Company serves as the Plan Administrator. Effective January 1, 2025, ADP Retirement Trust Services, LLC became the directed trustee of the Plan.
- b) *Eligibility* – All employees who have reached the age of 18 and completed three months of service are eligible to participate in the Plan. Employees that covered by a collective bargaining agreement and leased employees are excluded from eligibility.
- c) *Contributions* – Participant contributions are limited to the lesser of 90% of eligible compensation, as defined, or the annual deferral limit defined by the Internal Revenue Code (IRC).

Participants are automatically enrolled in the Plan and will defer 6% of their annual eligible compensation, as defined, as a pre-tax contribution unless they inform the Plan Sponsor to contribute a different percentage or elect not to participate in the Plan. Automatic contributions are automatically increase deferrals 1% per year up to a maximum 15%. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

Participants direct the investment of their contributions into various investments offered by the Plan. The Plan currently offers a variety of mutual funds issued by registered investment companies as investment options for participants.

The Company makes safe harbor matching contributions equal to 100% of participant salary deferrals that do not exceed 3% of compensation, plus 50%

of participant salary deferrals in excess of 3% and up to 5% of compensation. The safe harbor matching contribution is fully vested. During the years ended December 31, 2024 and 2023, the Company made matching contributions of \$713,194 and \$566,381, respectively.

The Plan offers a discretionary profit sharing employer contribution. Under the discretionary profit sharing employer contribution, the Plan Sponsor may make a contribution on behalf of each participant equal to the percentage declared of eligible compensation, as defined. The Company was the Plan sponsor of this qualified plan. The transfer represented excess pension plan funds to be allocated as either discretionary profit sharing or matching employer contributions. The Company did not make a discretionary profit sharing employer contribution during 2024.

- d) *Participants Accounts* – Each participant's account is credited with the participant's contribution and allocations of: (a) the Plan Sponsor's discretionary matching employer contribution, (b) the Plan Sponsor's discretionary profit sharing employer contribution, and (c) Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- e) *Vesting* – Participants are immediately vested in their contributions as well as employer safe harbor matching contributions and discretionary profit sharing employer contributions, plus actual earnings thereon.
- f) *Investment elections* – Each participant shall direct the investment of their account among a selection of mutual funds issued by registered investment companies. Contributions may be diversified among one or more of the funds in increments of 1%.
- g) *Notes Receivable from Participants* – The Plan permits its participants to borrow from his or her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 (less the highest outstanding loan balance in the previous 12 months) or 50% of the participant's account balance. Loans range up to 5 years or longer term for the purchase of a primary residence as established by the Plan Administrator at the time of the loan. The loans are collateralized by the balance in the participant's account and bear interest at a the prime rate of interest plus one percent. These rates range from 4.25% to

9.50% on outstanding loans as of December 31, 2024, and mature through 2051. Principal and interest are paid ratably through weekly payroll deductions. A participant is not allowed to have more than one loan outstanding at a time.

- h) *Payment of Benefits* – Withdrawals may be made from a participant's account at retirement, death, disability, hardship or termination of employment. A participant with a rollover account balance is permitted to withdraw all or a portion from the amount of rollover contributed to the Plan, as defined. A participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Notes receivable from participants

Notes from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced and a benefit payment is recorded based on the terms of the Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions

Contributions from Plan participants and the matching contribution from the Plan Sponsor are recorded in the year in which the participant contributions are withheld from amounts paid. Profit-sharing contributions are recognized upon authorization and in the year the underlying compensation is recognized under the Plan. All participant and employer contributions are participant-directed. Participant contributions in excess of amounts allowed by the Internal Revenue Service (IRS) regulation are recorded as a liability with a corresponding reduction in contributions.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes from participants that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation of fair value of investments.

3. Subsequent Events

The Plan has evaluated subsequent events and transactions occurring subsequent to December 31, 2024 through October 9, 2025, the date the financial statements were available to be issued.

4. Information Prepared and Certified by the Trustee

The following information included in the accompanying financial statements and supplemental material was obtained from data that has been prepared and certified to as complete and accurate by the Plan's trustee, Reliance Trust Company, as of December 31, 2024 and 2023.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities. The fair value measurement accounting literature

establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, level 2 inputs consist of quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets in inactive markets; and level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

6. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

7. Related Party Transactions and Party in Interest transactions

ADP Retirement Services is the Plan's recordkeeper and Reliance Trust Company is the trustee of the Plan. Recordkeeping and transaction fees of \$10,776 were paid to ADP in 2024.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain fully vested in their accounts.

9. Tax Status

The Plan is a pre-approved defined contribution plan ("Pre-approved Plan") sponsored by ADP Retirement Services ("ADP"). ADP obtained its latest opinion letter dated October 6, 2020 that the Pre-approved Plan, as then designed, was in compliance with the applicable requirements of IRC. is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan management believes that the Plan is currently designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, as the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
