### A. Plan Description:

The following description of the Integrated Research, Inc. 401(K) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

#### General:

The Plan is a participant-directed defined contribution plan sponsored by Integrated Research, Inc. (the Company) covering all non-bargaining, full-time employees who are age 21 or older. Employees are eligible to enter the Plan beginning on the first day of the month after attaining the age of 21 and completion of one month of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. Reliance Trust Company serves as the custodian and trustee. ADP, Inc. serves as the recordkeeper and third-party administrator. Global Retirement Partners serves as the investment advisor.

#### Contributions:

Each year, participants may make traditional or Roth contributions up to 90 percent of their eligible compensation, as defined in the Plan, not to exceed the maximum allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company contributes a nonelective Safe Harbor contribution equal to 3 percent of eligible compensation regardless of whether the participant contributed or not. The Company can also elect to make discretionary matching contributions and discretionary profit sharing contributions. For the years ended December 31, 2024 and 2023, the Company did not elect to make any discretionary contributions.

#### Investment Options:

Participants direct the investment of their contributions into the various mutual funds or the common collective trust option offered by the Plan. Participants may change their investment allocations at any time.

#### Participant Accounts:

Each participant's account is credited with the participant's contribution, allocations of the Company's contributions and plan earnings and any fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**A. Plan Description (Continued):**

Vesting:

Participants are immediately vested in all contributions plus actual earnings thereon.

Notes Receivable from Participants:

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a rate being charged by lending institutions in the same geographical locale as the Company. Interest rates are fixed for the term of the note. The maximum loan term is five years unless the loan is for the purchase of a primary residence, which may be approved for an extended period. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits:

Upon termination of service due to death, disability, retirement, or separation of employment, a participant is eligible for a distribution of his or her vested account balance. Participants who reach age 59.5 are also eligible for a distribution of his or her vested account balance. The Plan also allows for hardship withdrawals with certain limitations. Terminated participants with a vested account balance of \$5,000 or less will receive a lump-sum distribution upon termination.

Forfeited Accounts:

Excess employer contributions forfeited are used at the discretion of the plan administrator and can be utilized to pay plan expenses, reduce employer contributions, or allocated as additional employer contributions. No forfeitures were used during the years ended December 31, 2024 or 2023. The Plan held \$1,054 and \$1,025 of forfeited nonvested accounts at December 31, 2024 and 2023, respectively.

### B. Summary of Accounting Policies and Investments:

#### Basis of Accounting:

The accompanying financial statements are prepared on the accrual basis of accounting.

#### Use of Estimates:

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

#### Investment Valuation and Income Recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment custodian. See *Note D* for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits:

Benefits are recorded when paid.

Administrative Expenses:

Administrative expenses may be paid by the Company or the Plan at the Company's discretion. Fees related to the administration of benefit payments and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment advisory and management fees are allocated proportionately to participants based on their respective account balances. Certain investment related expenses are included in net appreciation in fair value of investments.

**C. Information Certified by the Plan's Trustee:**

The Company has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution and the trustee of the Plan, has certified the following information included in the accompanying financial statements and supplemental schedule is complete and accurate, to the best of their knowledge and belief:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investments and notes receivable from participants as shown in the accompanying supplemental information as of December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

### D. Fair Value Measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for identical or similar assets or liabilities in active or inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability or that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at quoted market prices, which represent the NAV of shares held by the Plan. Mutual funds held by the Plan are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**D. Fair Value Measurements (Continued):**

*Common Collective Trust:* The Reliance MetLife Stable Value Series 25157 fund (Stable Asset Fund), is a common collective trust that invests primarily in investment contracts. The Plan reports its investment in the Stable Asset Fund at the net asset value of the units held by the fund at year-end as a practical expedient. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The Stable Asset Fund is not subject to any withdrawal restrictions and distributions may be taken at any time. The Plan has no unfunded commitments relating to the Stable Asset Fund at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### E. Related Party and Party-in-Interest Transactions:

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

The Plan incurred administrative fees of \$16,400 and \$16,570 to the recordkeeper and \$16,244 and \$14,608 to the investment advisor during the years ended December 31, 2024 and 2023, respectively. The Company also provides certain administrative services at no cost to the Plan. Certain investments of the Plan are sponsored by the trustee.

### F. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

### H. Plan Tax Status:

The Plan has adopted a non-standardized pre-approved plan document provided by ADP, LLC. This pre-approved plan has been filed with the appropriate agency and has obtained a favorable opinion letter dated October 6, 2020 from the Internal Revenue Service stating that the pre-approved plan constitutes a qualified plan under section 401 of the Internal Revenue Code and that the trust was tax-exempt. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management performs an annual analysis of the Plan's various tax positions, assessing the likelihood of those positions being upheld upon examination by relevant taxing authorities. Management believes the Plan has conducted its operations in accordance with applicable income tax reporting requirements, and has properly maintained its tax-exempt status, and has taken no material uncertain tax positions that qualify for recognition or disclosure in the financial statements.

### I. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### J. Subsequent Events:

The Plan did not have any subsequent events through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued, for events requiring recording or disclosure in the financial statements for the year ended December 31, 2024.
