Basis for Opinion

We are required to be independent of FreedomPay, Inc. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about FreedomPay, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they could be reasonably expected to influence the economic decisions of users made on the basis of these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about FreedomPay, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



(1) Description of Plan

The following brief description of FreedomPay, Inc. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for complete information.

General

The Plan is a defined contribution plan covering substantially all employees of FreedomPay, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and qualifies under Section 401(a) of the Internal Revenue Code (IRC). The trustee of the Plan is Reliance Trust Company (the Trustee). The recordkeeper is Automatic Data Processing, Inc. (the Recordkeeper); the investment advisor is Johnson Kendall Johnson; and the Plan is administered internally by certain employees of the Company. The Plan was restated effective February 1, 2019. Effective January 1, 2025, ADP Retirement Trust Services, LLC became the trustee of the Plan.

Eligibility

Except as noted below, all employees are eligible to participate in the Plan once they attain twenty-one years of age and complete three months of employment (and work at least 250 hours). Employees may then enroll beginning the first day of the month coinciding with or next following the date the eligibility requirements are met. Leased employees are not eligible to participate.

Contributions

Eligible employees have the option to contribute pre-tax and Roth 401(k) contributions. A participant may authorize the Company to withhold up to 90% of his or her eligible compensation, not to exceed the annual limit established by the IRC. Participants' pre-tax and Roth 401(k) contributions are separately accounted for, as are the gains and losses attributable to each. The Plan allows participants who have attained age 50 before the end of the Plan year to make catch-up contributions, which are also eligible for employer match contributions. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Each pay period, the Company may make a discretionary employer match contribution in an amount to be determined by the Company. The Company made employer match contributions totaling \$787,876 for the year ended December 31, 2024. The Company may also make a discretionary employer profit-sharing contribution which is shared on a pro-rata basis among all eligible employees based on each participant's eligible compensation compared to total eligible compensation; however, a profit-sharing contribution was not made for 2024.

Participants direct the investment of contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions and an allocation of plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant transactions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 1) \$50,000 reduced by the excess, if any, of i) the highest outstanding note receivable balance during the prior twelve month period, over ii) the outstanding note receivable balance on the date the new note receivable is made, or 2) 50% of their vested account balance preceding the new note receivable, whichever is less. Participant notes receivable are secured by the vested balance in the participant's account and bear interest at the prime rate as published in the Wall Street Journal plus 1%. Participants may only have one note receivable outstanding at a time. Principal and interest are paid through payroll deductions over a period generally not to exceed five years.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution plus actual earnings thereon is based on years of credited service, defined as a twelve-month period commencing with a participant's first day of employment. A participant is 100% vested upon death, disability, retirement or after three years of credited service, which is earned 33% in both years one and two, and 34% in year three.

Payment of Benefits

Upon death, disability, retirement, termination of employment, a participant may elect to receive partial or installment payments or a lump sum equal to the participant's vested account balance. In-service distributions may be made to a participant who has not separated from service provided the participant has attained age 59½.

Hardship distributions are also permitted from the participant's account. The plan administrator may distribute terminated participants' account balances that are less than \$5,000 in a lump sum without the participants' consent. The plan administrator may also transfer terminated participants' account balances that are at least \$1,000 but less than \$5,000 into an individual retirement accounts without the participants' consent.

Forfeitures

Forfeitures of unvested participant account balances may be used to pay plan expenses or to reduce company contributions. Forfeitures of \$37,656 were used to reduce 2024 Company contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,027 and \$1,743, respectively.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are reported on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and Trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the plan year.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Benefits Paid to Participants

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from the financial statements. Fees related to the distribution, and the administration of notes receivable from participants and certain professional fees are charged directly to the participants' account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

(3) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codifications* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;

- inputs other than quoted prices that are observable for the assets or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common collective trust fund: Valued at the NAV of units of a common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(4) Information Certified by the Trustee

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

(5) Related Party Transactions and Party-In-Interest Transactions

Fees incurred by the Plan for related investment management services are included in net appreciation in fair value of investments. The Plan pays both direct and indirect fees to Reliance Trust and the recordkeeper for services provided to the Plan. Transactions such as these qualify as party-in-interest transactions, which are exempt under the prohibited transaction rules. The Company pays directly certain other fees related to the Plan's operations.

(5) Related Party Transactions and Party-In-Interest Transactions, Continued

The Plan is party to a plan expense agreement that provides for a revenue credit program. Under the agreement, any eligible revenue earned by the recordkeeper and/or its affiliates on the investments in the Plan is deposited into the revenue credit program account. The amounts in the revenue credit program account may be used to pay administrative expenses of the Plan or allocated to participant accounts. In 2024, \$44,407 of other income was earned by the Plan related to this agreement. The balance in the revenue credit program account at December 31, 2024 and 2023 is \$64 and \$54, respectively.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their account balances.

(7) Tax Status

The Company has not applied for a determination letter from the Internal Revenue Service (IRS) to determine if the Plan is designed in accordance with applicable sections of the IRC. The plan document is based upon a prototype plan instrument from ADP, LLC, which received an IRS opinion letter dated July 16, 2014. The prototype plan instrument has been updated for legislative and regulatory changes. Although the Plan has been amended since the date of the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the accompanying financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.
