Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTE A – DESCRIPTION OF PLAN

The following description of the ESP Associates, Inc. (“Company”) 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan covering all employees of the Company, except union employees, who have completed two months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator oversees governance of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions. Each year, participants may contribute up to 75% of their eligible compensation, as defined in the Plan, subject to certain limitations. A separate deferral election is allowed for bonus compensation of up to 90%. Participants are automatically enrolled at 5% of their eligible compensation on the first day of the next month following attainment of the eligibility requirements. The plan administrator must receive signed written documentation from the participant before this date to do otherwise. Participants are also allowed to make Roth contributions to the Plan. Participants direct the investment of their contributions into various mutual funds offered by the Plan. For the year ended December 31, 2023, the Company elected a match 100% up to the first 3% and then 50% up to the next 2% for a maximum matching contribution of 4% of the participant’s eligible compensation, which totaled \$1,626,022. Effective January 1, 2024, the Plan adopted a safe harbor matching contribution formula. All safe harbor matching contributions are fully vested when made. For the year ended December 31, 2024, the Company made a safe harbor contribution of 100% up to the first 3% and then 50% up to the next 2% for a maximum contribution of 4% of the participant’s eligible compensation, which totaled \$1,902,904. These contributions were allocated to participants’ accounts with each biweekly payroll period, with a final true-up contribution made after year-end to ensure that all eligible participants received the maximum match based on their total annual deferrals and compensation. A true-up matching contribution may be necessary if a participant’s elective deferral rate varies during the year. Employer contributions receivable at December 31, 2024 include \$25,945 of true-up matching contributions, which were paid in August 2025. The Company may, at its sole discretion, make a profit-sharing contribution. For the years ended December 31, 2024 and 2023, the Company did not elect to make a profit-sharing contribution. A participant must be employed on the last day of the Plan year in order to be eligible to receive the profit-sharing contribution.

Participant Accounts. Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting. Participants are immediately vested in their contributions and the Company’s safe harbor matching contributions plus actual earnings thereon. The Company’s profit-sharing portion of their accounts plus actual earnings thereon is based on years of continuous service and a participant is 100% vested after three years of credited service.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The notes are secured by the balance of the participant’s account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined monthly by the plan administrator. The Plan limits each participant to three loans outstanding. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits. On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts.

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$64,896 and \$55,779, respectively. These accounts will be used to reduce future employer contributions. Also, in 2024, forfeitures of \$114,382 were used to reduce employer contributions.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition. Investments held by a defined contribution plan are required to be reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income from participant notes are recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits. Benefits are recorded when paid.

Expenses. Non-investment costs and certain administrative expenses of the Plan are paid by the Company, which is a party-in-interest. These expenses, which are not reflected in the accompanying financial statements, constitute exempt party-in-interest transactions under ERISA. Certain distribution processing fees, loan establishment and maintenance and short-term trading fees are paid by the Plan's participants and all other investment expenses are offset against the related investment income.

NOTE C – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

At December 31, 2024 and 2023, the Plan's investments were held by the Trustee, Reliance Trust Company. The following information included in the accompanying financial statements was obtained from data that has been prepared and certified to as complete and accurate in accordance with Section 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 by the trustee. For the years ended 2024 and 2023, the certification was prepared on the cash basis.

NOTE D – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820 Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in the active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts (CCT): CCTs are valued at the NAV of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported net asset value. Participant transactions may occur daily.

Changes in Fair Value Levels: The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The plan administrator evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year December 31, 2024, there were no significant transfers in or out of levels 1, 2, or 3.

During 2024, the Plan paid Morgan Stanley Smith Barney \$77,135 for investment/financial advisory services and ADP, Inc. \$12,186 for recordkeeping services of the Plan. Therefore, these entities qualify as parties-in-interest.

NOTE F – CONCENTRATION OF RISK

For the year ended December 31, 2024, the Plan currently offers thirty-three mutual funds and two common/collective trusts as investment options for participants. However, the following two mutual funds make up 25% of total net assets available for benefits: Vanguard Balanced Index Adm Fund and Fidelity 500 Index Fund. Individually, each of these funds make up approximately 14% and 11% of the total net assets available for benefits, respectively. Therefore, these two funds represent material concentrated amounts.

NOTE G – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE H – TAX STATUS

The Plan has not obtained a determination letter from the Internal Revenue Service (the “IRS”) stating that the Plan was in compliance with the applicable requirements of the Internal Revenue Code (the “IRC”). The Plan is relying on the IRS approval of the non-standardized prototype plan that it is utilizing. The IRS determined and informed ADP, Inc. by a letter dated October 06, 2020, that the prototype plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator believes the Plan has under taken no uncertain positions as of December 31, 2024. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE I – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
