Other Matters

Supplemental Information Required by ERISA

The supplemental information listed in the index as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplemental information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental information that is agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Their report dated April 3, 2025 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

Notes to the Financial Statements December 31, 2024 and 2023

Note 1 – Plan Description

The following description of the D6 Inc. 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of D6 Inc. (the “Company” or “Employer”). The Plan, which commenced effective January 1, 2014, was amended and restated effective May 1, 2024, to comply with the latest rules and regulations, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

Plan Custodians and Trustees

Effective May 1, 2024, the Plan was amended and restated, and ADP Retirement Trust Services (“ADP”) was appointed as the new custodian and trustee of the Plan. ADP, Inc. was appointed as the new recordkeeper. Prior to May 1, 2024, Mid Atlantic Trust Company (“Mid Atlantic”) served as the Plan’s custodian and trustee and Paychex Retirement Services (“Paychex”) served as the recordkeeper. Collectively, ADP and Mid Atlantic are referred to herein as the “Custodians” or “Trustees.”

The Custodians maintain custody of all investments held by the Plan. Among other duties, the Custodians receive contributions, hold and invest the fund assets in accordance with the directions of participants, and make distributions to participants. The recordkeepers maintain the Plan’s participant account balances and provide recordkeeping services to the Plan.

As a result of the change in Custodians noted above, the Plan’s assets were transferred from Mid Atlantic to ADP, and the Plan experienced a blackout period from May 1, 2024 to June 15, 2024. During this blackout period, participants could not direct or diversify their investments, nor obtain a distribution or loan from the Plan.

Eligibility and Plan Entrance Date

All employees of the Company, except union employees whose employment is governed by a collective bargaining agreement, and non-resident aliens, are eligible to participate in the Plan after the employee has attained 21 years of age and completed 3 months of service. Effective May 1, 2024, residents of Puerto Rico are not eligible to participate in the Plan. Eligible employees are permitted to enter the Plan on the first day of the following month after which the employee has satisfied the eligibility requirements.

Participant Contributions

Effective May 1, 2024, participants may elect to contribute, on a pre-tax and Roth basis, up to 90% of their eligible compensation as defined by the Plan, subject to the annual deferral maximum permitted by the IRC, which was \$23,000 for 2024. Prior to May 1, 2024, participants could elect to contribute up to 92% of their eligible compensation. Participants who have attained 50 years of age before the end of the Plan year are eligible to make catch-up contributions of up to the maximum amount allowed annually under the IRC, which was \$7,500 for 2024.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral set at 3% of eligible compensation, with the contribution rate increasing by 1% each year until it reaches a maximum of 6% of eligible compensation, unless they elect otherwise.

Note 1 – Plan Description (continued)

Rollover Contributions

Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

Employer Contributions

The Plan provides for Safe Harbor Employer matching contributions. The Company made Safe Harbor Employer matching contributions to the Plan, on behalf of participants, in an amount equal to 100% of the first 1% of each participant's eligible compensation, plus 50% of the participant's contributions between 2% and 6% of eligible compensation that the participant contributed to the Plan.

The Company may elect to make discretionary profit-sharing contributions to the Plan. Profit-sharing contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation who had at least 500 hours of service during the Plan year and were employed on the last day of the Plan year. There were no profit-sharing contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's Safe Harbor Employer matching contributions, plus allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, Safe Harbor Employer matching contributions, discretionary profit-sharing contributions, rollover contributions, and any earnings thereon.

Participant-Directed Investments

All assets of the Plan are participant-directed investments. Participants have the option of directing their account balances to one or more investment options offered by the Plan. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. The options vary in types of investments, rates of return, and investment risk.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants are secured by the balance in the participant's account. The loan interest rate is set at 1% above Prime, as defined. Principal and interest are paid ratably through payroll deductions and are due in equal installments not less frequently than quarterly.

Payment of Benefits

Upon separation of service due to death, disability, normal retirement, or termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of their vested account, annual installments, nonrecurring partial payments, or an annuity contract. Distributions to a terminated employee with a vested account balance equal to or less than \$5,000 are made as a lump sum distribution, as soon as administratively possible following the participant's termination of employment. The participant may elect whether to receive the distribution directly or to rollover the distribution into another retirement plan. A participant may withdraw all or a portion of their account upon attainment of age of 59½. Hardship withdrawals are not permitted.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in the fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as those held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions based on the terms of the Plan agreement.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Certain expenses specifically incurred by, or attributable to, a participant will be paid from that participant's account and are included in administrative expenses. Investment-related expenses are included in the net appreciation of fair value of investments.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within level 1 of the fair value hierarchy.
- **Common Collective Trust Fund** – Valued using the NAV of units held by the Plan at year end as provided by the fund administrator. Units of each fund are valued each day on which the New York Stock Exchange (“NYSE”) is open for trading in accordance with the valuation procedures established by Invesco Trust Company. The NAV per unit is calculated as of the close of trading on the NYSE and computed by dividing the total fair value of the assets of a fund, less its liabilities, by the total number of units outstanding at the time of such computation. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee, and is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily, and there are no significant restrictions on participant redemptions or any unfunded commitments.

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Effective May 1, 2024, the Plan changed its qualified institution from Mid Atlantic Trust Company to ADP Retirement Trust Services. Accordingly, Mid Atlantic Trust Company and ADP Retirement Trust Services have certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate:

Note 5 – Related Party and Party-in-Interest Transactions

Plan investments are shares of mutual funds and common collective trusts managed by the Custodians; therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

The Plan has notes receivable from participants as of December 31, 2024 and 2023. These receivables and all related transactions qualify as party-in-interest transactions and are exempt from being prohibited by ERISA.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

Note 7 – Tax Status

The Plan operates under an adoption agreement in connection with a non-standardized profit-sharing plan (the “Prototype Plan”) sponsored by ADP, LLC. This Prototype Plan document has been filed with the appropriate agency and obtained an opinion letter from the IRS, dated October 6, 2020, stating that the prototype plan and related trust, as then designed, constitutes a qualified plan under Section 401 of the IRC, and therefore is not subject to tax. The Plan has not filed individually with the IRS for a letter regarding the Plan’s qualified tax status. However, the Plan Administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been made in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 – Prohibited Transactions

The Company failed to remit to the Plan's Custodians certain participant contributions in the aggregate amount of \$82,478 within the period prescribed by DOL Rules and Regulations. The DOL considers late deposits to be nonexempt prohibited transactions. Delays in remitting contributions to the Custodians were due to unintentional administrative errors. During 2024, the Company corrected \$67,961 of these contributions and remitted potential lost earnings due to the delays.

Note 11 – Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.
