Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Centers for Dialysis Care, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Plan

The following is a summary of certain provisions of the Centers for Dialysis Care, Inc. Retirement Savings Plan (the "Plan"). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Participation – The Plan is a defined contribution plan, established as of October 1, 1984, covering eligible employees of Centers for Dialysis Care, Inc. (the "Company"). Eligible employees may participate in the Plan on the first day of the month following the attainment of three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Administration – The Plan is administered by the Company which is responsible for controlling and managing the operations and administration of the Plan.

Contributions – Participants may elect to make contributions from 1% to 100% of their eligible earnings on a "pre-tax" or Roth basis subject to certain limitations of the Plan and the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified plans (rollover). Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. The Plan uses a negative election format in which employees are automatically enrolled when they become eligible. The Plan includes a Safe Harbor Qualified Automatic Contribution Arrangement ("QACA"), whereby employees who have not made an affirmative deferral election will be automatically enrolled in the Plan at a 3% rate. These rates will be automatically increased by one percentage point per year up to a maximum rate of 6% of compensation. The Company's matching contribution is 100% of the participant's elective deferrals that do not exceed 1% of the participant's compensation, plus 50% of the participant's eligible elective deferrals that exceed 1% of the participant's eligible compensation but do not exceed 6% of the participant's compensation subject to limitations of the IRC.

The Plan also provides for a Company discretionary profit sharing contribution to be allocated based on relative compensation of the participants. No such contribution was made for 2024.

Participant Accounts – The Plan maintains an individual account for each participant. These accounts are credited with participants' contributions, Company contributions and related earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. Participants elect to maintain their aggregate contributions in the investment funds offered by the Plan. Separate accounting for each of the funds is made pursuant to the participant's designated election. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable From Participants, net – The Plan allows loans to participants subject to certain regulatory restrictions. The amount of the loans cannot exceed \$50,000 or 50% of the participant's vested balance. Interest is charged based on the prevailing rate at the time of the loan. Repayments of principal and interest are credited to the participant's separate account within the funds as elected by the participant, paid through payroll deductions. Until such repayments are received, the loan receivable is accounted for in the participant loan fund.

Note 1. Description of Plan (Continued)

Vesting – Participants are at all times vested in their elective and voluntary contributions and earnings thereon. For Company contributions other than QACA matching contributions, participants become 100% vested after six years of service. For QACA matching contributions, a participant becomes 100% after two years of service. Additionally, participants become 100% vested upon death, disability or attaining age 65.

Payment of Benefits – A participant, upon retirement, termination, disability or the attainment of age 59½, or a participant's beneficiary upon the participant's death, may elect to either rollover the funds, receive a lump-sum amount equal to the value of his or her account or receive payments in substantially equal installments. In the case of a severe financial hardship, the plan administrator, in its sole discretion, may direct distribution of all or a portion of the participant's elective and/or voluntary contributions, subject to certain restrictions.

Forfeitures – At December 31, 2024 and 2023, there was \$46 and \$26,533, respectively, of forfeited nonvested accounts. These accounts are used to offset Company contributions or administrative expenses. Forfeitures of \$45,271 were used in 2024 to offset employer match contributions.

Termination Provisions – The Company anticipates and believes that the Plan will continue indefinitely. However, the Company reserves the right to terminate the Plan at any time by an action of its Board of Directors. In the event of termination of the Plan, participants would become 100% vested in their accounts and the assets then remaining in the funds will be allocated and distributed to participants in accordance with the terms and provisions of the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP"). Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 2. Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition – Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee and insurance company. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when earned. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants, net – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments, the plan administrator deems the participant loan to be in default. Allowances of \$-0- and \$957 have been recorded for these defaulted loan balances at December 31, 2024 and 2023, respectively.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – All administrative fees of the Plan are paid by the Company or the Plan at the option of the Company. In addition, any participants who elect to receive a loan, distribution or withdrawal are charged an administrative fee.

Subsequent Events – The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Note 3. Unaudited Information

The Plan's management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, management received certifications from Principal Trust Company, the Trustee of the Plan from January 1, 2024 through March 31, 2024, and ADP Retirement Trust Services, the Trustee of the Plan from April 1, 2024 to December 31, 2024, acknowledging the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule of assets (held at end of year) as of December 31, 2024, the related investment and loan interest activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024 and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

Note 4. Party-in-Interest Transactions

The Plan invests in a group annuity contract and a pooled separate account managed by an affiliate of the Trustees or their affiliates. The Plan also paid administrative fees to the Trustees. These qualify as party-in-interest transactions.

Note 5. Income Tax Status

The Internal Revenue Service has previously ruled by a letter dated October 6, 2020, that the prototype standardized model on which this Plan is based qualifies under Section 401(a) of the IRC and is, therefore, not subject to tax under present income tax laws. The plan administrator believes the adopted Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

Note 6. Fair Value Measurements

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

- Level 1 – Quoted market prices in active markets for identical assets and liabilities
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodologies used for Plan assets measured at fair value:

- The fair values of registered investment companies are determined based on their quoted closing market prices in active markets for identical investments and are classified as Level 1.
- The fair value of investments held in the pooled separate account is based on their reported net asset value ("NAV"). The NAV is based primarily on observable inputs, the market value of the underlying investments and is classified as Level 2.
- The fair value of investments held in the common/collective trust is based on their reported NAV. The NAV is based primarily on observable inputs and the market value of the underlying investments and is classified as Level 2.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7. Group Annuity Contract

Investments in the Principal Life Insurance Company Guaranteed Option meet the fully benefit-responsive investment contract criteria and are, therefore, reported at contract value as certified by Principal Trust Company. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. All transactions within this contract are executed at contract value including full liquidation of the fund.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on several factors, including current economic and market conditions, the general interest rate environment and both the expected and actual experience of a reference portfolio within the issuer's general account. These rates are established without the use of a specific formula, cannot be less than zero and are reset periodically as determined by Principal Life Insurance Company, but no more frequently than semi-annually.

The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.
