Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of General Tool 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements (the "financial statements").

Notes to Financial Statements December 31, 2024 and 2023

(1) Plan Description

The following brief description of the General Tool 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that was established effective November 1, 1998 and is administered by General Tool Inc. (“Plan Administrator” or “Company”) and has been amended and restated effective August 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is intended to satisfy all of the requirements for a qualified retirement plan under appropriate provisions of the Internal Revenue Code (“IRC”) and similar state tax laws. Reliance Trust Company is the asset custodian and trustee of the Plan’s investment assets and ADP, Inc., the third-party administrator, serves as the recordkeeper of the Plan.

Eligibility

The Plan covers all the employees of the Company who have completed at least three months of service, which includes eligibility for the Company’s discretionary profit-sharing contribution.

Contributions

Participants may contribute up to 90 percent of eligible compensation up to the statutory limit (\$23,000 for 2024). All employees who were eligible to make pretax deferrals under the Plan and had attained age 50 before the close of the Plan year were eligible to make catch-up contributions in accordance with, and subject to, the limitations set by the Internal Revenue Service (“IRS”) (\$7,500 per participant for 2024). Participants may make rollover contributions from other qualified retirement plans.

The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation.

The Company may make discretionary employer matching contributions equal to 100% of salary deferrals up to the first 2% of a participant’s eligible compensation. Discretionary matching contributions were \$180,152 for the year ended December 31, 2024.

Contributions (continued)

Each year, the Company may make a discretionary profit-sharing contribution to the Plan. Eligible employees' share of the contribution for the Plan year is calculated as follows:

$$\text{Profit Sharing Contribution} \quad X \quad \frac{\text{Employee Compensation}}{\text{Total Compensation of All Participants Eligible to Share}}$$

For the Plan year ended December 31, 2024, the Company did not make any profit sharing contributions.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's pretax contributions and allocations of (a) Company matching contributions, when applicable, (b) investment earnings or losses, and (c) charged with withdrawals and an allocation of Plan transaction fees. Allocations are based on participant investment selections. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Eligible participants are immediately 100% vested with respect to their voluntary and Company discretionary matching contributions, plus actual earnings thereon.

Eligible participants' vested percentage attributable to discretionary profit-sharing contributions is determined under the following schedule:

Participant Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. As of December 31, 2024, the Plan offered various mutual funds as investment options for participants.

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Such loans bear interest at prevailing interest rates and are repaid to the participant's account over no more than five years, except in the case of loans used to acquire a primary residence. Participant loans are secured by the balance in the participant's account. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan Agreement.

Payment of Benefits

Upon normal retirement, retirement due to permanent disability, termination, or hardship, a participant may elect to receive either a single lump sum payment in cash equal to the value of the vested interest in his or her account, or a series of substantially equal annual or more frequent installments over a period not to exceed the participant's life expectancy. Benefits are recorded when paid. Account withdrawals are permitted by participants who suffer certain financial hardships and meet criteria established by the IRS.

Administrative Expenses

Administration, audit, and recordkeeping fees are paid by the Company. Investment management fees are paid from the Plan's assets.

Forfeited Accounts

Forfeited, non-vested amounts are to be applied to reduce employer contributions. As of December 31, 2024 and 2023, there were no forfeited, non-vested amounts.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions set forth by ERISA. In the event of Plan termination, participants would be entitled to receive the accumulated balance in their individual account.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared under the accrual method of accounting and in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates

In preparing financial statements in conformity with U.S. GAAP, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income

The Plan’s investments are stated at fair value. The Plan’s investments are governed by a trust agreement with Reliance Trust Company. Investments in mutual funds are valued daily at quoted market prices. Investment income consists of interest and dividends earned and realized and unrealized gains or losses in the fair value of investments, less investment expenses. Investment income is allocated to participants’ accounts based on their respective interest in the Plan’s assets on the date it is earned. Purchases and sales of securities are reflected on the settlement date. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan Agreement.

Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

The Plan’s management evaluated subsequent events through October 14, 2025, the date the financial statements were ready to be issued.

(3) Investments

In accordance with U.S. GAAP, the Plan uses a hierarchy for measuring the fair value of all financial assets and liabilities that are being measured and reported at fair value on a recurring and non-recurring basis. Fair value is measured in levels, which are described in more detail below, and are determined based on the observability and reliability of the assumptions used to determine fair value.

Level 1: Valuation for assets and liabilities traded in active exchange markets. Valuations are obtained from readily available pricing sources for market transactions involving identical assets or liabilities.

Level 2: Valuations for assets and liabilities traded in less active dealer or broker markets. Valuations are obtained from third party pricing services for identical or comparable assets or liabilities.

Level 3: Valuations for assets and liabilities that are derived from other valuation methodologies, including option pricing models, discounted cash flow models, and similar techniques, and not based on market exchange, dealer or broker traded transactions. These valuations incorporate certain assumptions and projections in determining the fair value assigned to such assets or liabilities.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission (“SEC”). These funds are required to publish their daily net asset value (“NAV”) and to transact at that price.

Management may also be required, from time to time, to measure certain other financial assets at fair value on a non-recurring basis. During the year ended December 31, 2024, no other financial assets were measured at fair value on a non-recurring basis.

(4) Investments and Information Certified by Reliance Trust Company

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to investment information certified as complete and accurate by Reliance Trust Company, except for comparing such information certified by the trustee to the information included in the Plan's financial statements and supplemental schedule.

(5) Risks and Uncertainties

The Plan is exposed to market and credit risk due to the various investment securities that may be selected by the participant in any combination. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

(6) Tax Status

Effective August 1, 2020, the Plan adopted a non-standardized form of a prototype plan sponsored by Automatic Data Processing. The prototype plan has received an opinion letter from the Internal Revenue Service, dated October 6, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan has since been amended; however, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code ("IRC").

U.S. GAAP requires management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions.

(7) Party-in-Interest

The Plan Administrator performs administrative functions at no cost. These are considered permitted party-in-interest transactions. Notes receivables from participants held by the Plan also reflect permitted party-in-interest transactions.

(8) Prohibited Transactions and Contingencies

Late Remittances

For the 2024 Plan year, the Company transferred employee contributions of \$74,010 into the Plan after what was considered a reasonable period of time. The estimated lost earnings were \$1,022 for the year ended December 31, 2024. Management intends to fully self-correct these prohibited transactions as they relate to the 2024 Plan year in 2025. These delinquent contributions are considered non-exempt prohibited transactions under the regulations of the Department of Labor and therefore the Plan and/or the Plan Administrator may be subject to fines, penalties and interest.
