### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit For the 2024 Financial Statements***

We have performed an audit of the financial statements of the River Garden 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements ("2024 financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1. Plan Description**

***General***

The following description of the River Garden 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan sponsored by River Garden Hebrew Home/Wolfson Health & Aging Center, (“River Garden”) for the benefit of its employees. Related employers who participate in the Plan include River Garden Hebrew Home for the Aged; River Garden Holding Company, Inc. d/b/a River Garden Senior Services; The Coves at River Garden, Inc; and River Garden Foundation, Inc.

The purpose of the Plan is to reward employees of River Garden for faithful service, to establish a bond between employer and employee, to provide an incentive for efficient and conscientious work, to provide a fund for retirement, disability, or death, and to retain high-caliber employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan’s management determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Trustee. The Capital Bank and Trust Company (the “Plan Custodian”) serves as the custodian of the Plan.

***Contributions***

Each year, participants may contribute compensation, as defined in the plan document, subject to certain Internal Revenue Code (“IRC”) limitations. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. The Plan provides for employer contributions in an amount equal to 3% of a participant’s total qualified annual compensation for the year ended December 31, 2024. A participant must complete one year of service (at least 1,000 hours), satisfy an entry date on January 1 or July 1, and then, coinciding with or following the entry date, be employed by River Garden on the first day and the last day (except for reasons of death, disability, or retirement) of the Plan year, to share in the allocation of River Garden’s contribution for such Plan year. River Garden may also make a discretionary contribution to the Plan each year. There were no discretionary contributions made during 2024.

***Participant Accounts***

Each participant’s account is credited with the participant’s contributions, River Garden’s contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Capital Bank and Trust Company (the “Plan Custodian”). Participants may change their investment options at any time, with certain exceptions.

***Vesting***

Participants are immediately vested in their rollover contributions and elective deferral contributions, plus earnings thereon. Upon the death or permanent disability of a participant, their entire account balance becomes fully vested.

Vesting in the River Garden’s contribution portion of their accounts plus earnings thereon is based on years of service, as follows:

2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50%, of the participant’s vested account balance or \$50,000 reduced by the greater of the highest outstanding loan balance during the past 12 months or any existing loan balances on the date a new loan is made. Participants may only have two loan outstanding at any given time. Loan terms range from 1-5 years. The loans are secured by the balance in the participant’s account and bears interest at a 5% fixed interest rate. Principal and interest are paid ratably through biweekly payroll deductions.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the vested interest in their account. Partial withdrawals or installments are only permitted for participants who must receive the required minimum distributions. There were no unpaid amounts allocated to participants who elected to withdraw from the Plan as of December 31, 2024 and 2023.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$19,000 and \$17,000, respectively. These accounts will be used to reduce future employer contributions. During the year ended December 31, 2024, there were approximately \$18,000 from forfeited nonvested accounts used to reduce employer contributions remitted to the Plan.

**Note 2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Employer Contributions Receivable**

Employer contributions receivable represents contributions due from River Garden, based on the annual contribution calculation made as of the last day of the Plan year.

***Contributions***

Contributions from Plan participants and the matching contributions from River Garden are recorded in the year in which the employee contributions are withheld from compensation.

***Investment Valuation and Income Recognition***

The Plan's investments in cash and cash equivalents, collective investment trust accounts, and mutual funds are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 and 2024 excess contributions to the applicable participants before March 15, 2024 and 2025, respectively.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or River Garden, as provided by the Plan document. Certain administrative functions are performed by employees of River Garden. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable and distributions) are charged directly to the participant's account.

***Reclassifications***

Certain reclassifications have been made to the 2023 financial statements to conform to the 2024 financial statement presentation. These reclassifications had no effect on changes in net assets available for benefits.

***Subsequent Events***

Subsequent events for recognition and disclosure have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company, a qualified institution, has certified

the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule(s) is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024, and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024, and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### **Note 4. Disclosures About Fair Value Measurement of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

##### ***Mutual Funds***

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

##### ***Common Collective Trust Funds***

These funds are valued at the net asset value ("NAV") of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

#### **Note 5. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### **Note 6. Income Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan operates under a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the IRC. Although, the Plan has been amended since adopting the pre-approved plan document, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, the Plan is qualified.

#### **Note 7. Exempt Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Capital Bank and Trust Company. Capital Bank and Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. River Garden directly pays any other fees related to the Plan's operations. Fees paid by the Plan for administrative services was approximately \$1,600 for the year ended December 31, 2024.

#### **Note 8. Plan Termination**

Although it has not expressed any intent to do so, River Garden has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
